

Guide to Creating a Tax Invoice

Your tax invoice to Regional Arts WA **must** include the following information:

- The words 'Tax Invoice'
- The date that you have created the invoice
- The name, address and ABN of the company who you are asking for payment from *(in this
 case it is Regional Arts WA):
 - o Regional Arts WA,PO Box 7012, Cloisters Square, 6850. ABN 81 165 913 876
- The name of the person or organisation that the invoice is from (i.e.yourself as an individual
 or sole trader, a company or an auspicing organisation) and yours or their contact details. If
 you have nominated an auspice organisation the invoice must be from them.
- An email address or phone number in case we need to follow up with you about your invoice.
- Australian Business Number (ABN) this must be the same ABN as the ABN that you put into the Acceptance of Conditions of Grant form (your contract).
- A description of what the payment is for: In this case please put your Grant Application Reference Number, the grant program, and project title. Please do not list all the expenses separately as this tax invoice is for the full amount of the grant only. (You will be able to provide receipts after your project or activity has finished when you write your report.)
- Your Bank Details: The name of the Bank, the BSB and Account Number so that we can make a payment to you.
- The Grant amount (plus GST if applicable).
 - If you are registered for GST, you are entitled to add GST to the grant amount.
 Please ensure you show the grant amount, the GST and then calculate the total amount payable.

If you are NOT registered for GST, please write **I am not registered for GST** and simply invoice for the grant amount only, with \$0 showing for GST.
