3. **Duration of Promotion:** The Promotion commences at 11am on 27 June 2014 and ends at 11.59pm on 31 July 2014 ("the Promotional Period").
4. **Eligibility for Entry:** Entry may only be made in accordance with these Terms and Conditions. The Promotion is open to any Australian resident aged 18 years and over unless, they are an employee, or have been employed in the last six months by the Promoter or Participating Venue, including the immediate families, including spouse, parents, siblings and children of any such current or past employee ("Eligible Entrant").
