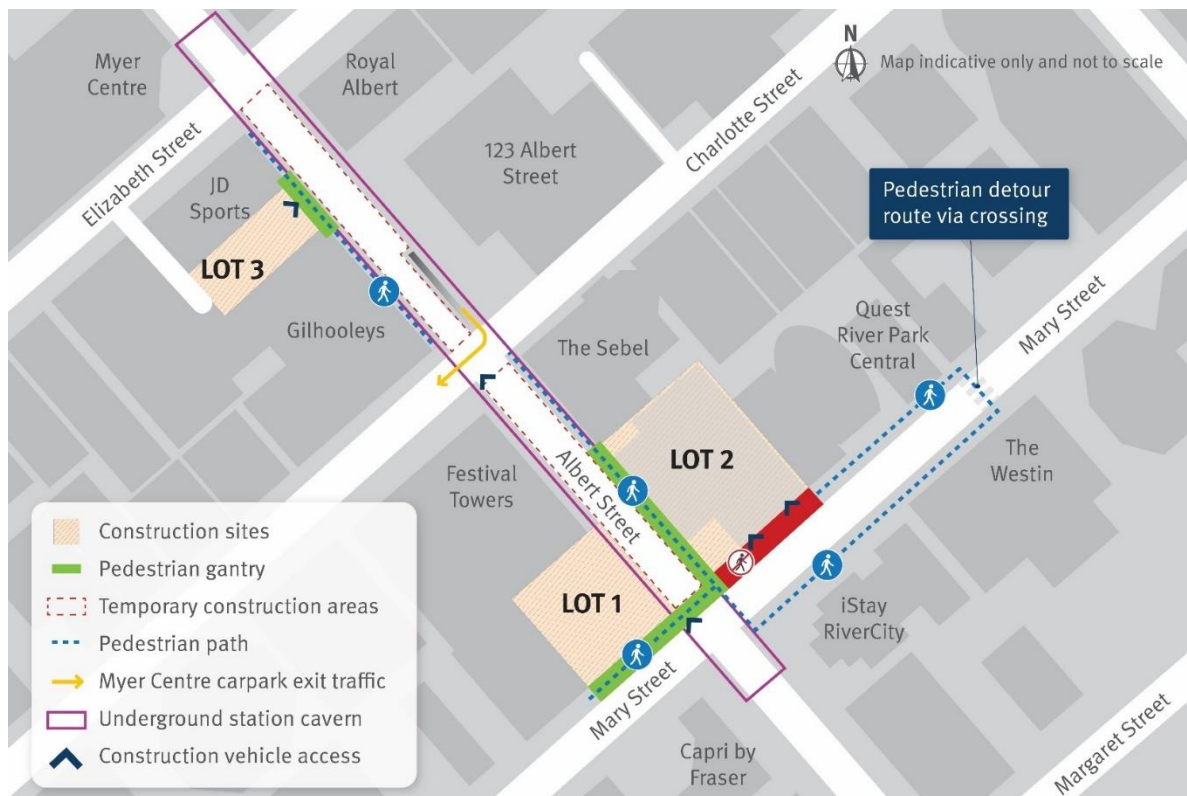


# Works Notice

March 2021

## Albert Street station construction update

Throughout March, works will continue at each of the three Albert Street station construction sites. This includes ongoing excavation for the future main station entrance (Lot 1), ongoing tunnelling activities within the acoustic shed to excavate the Albert Street underground station platform cavern (Lot 2) and ongoing bored piling and ground retention activities at the northern station entrance site (Lot 3).

### What to expect

- Construction activity in the area with potential for an increase in noise, dust, vibration, truck movements and workers.
- Construction impact mitigation activities such as street sweepers, water suppression and hoarding installation.
- Ongoing delivery and removal of material, equipment and machinery, including oversized plant.
- Temporary road, laneway and pedestrian traffic detours under the direction of traffic control which may cause delay in journey times and routes.
- Works are subject to site and weather conditions.

Cross River Rail propose to change working hours at the Albert Street construction site to include haulage and equipment delivery (excluding concrete deliveries) on Sunday between 9am and 6.30pm. ## LOT 1 – Main station entrance

Western corner of Albert and Mary streets intersection



### Excavation of the main station entrance

#### Ongoing

- Excavation and ground retention activities including rock hammering, saw cutting, drilling, rock anchoring and shotcreting
- Installation of structural steel propping systems, including use of mobile cranes
- Bulk spoil separation and removal

### Site support facilities

#### March 2021

- Line marking and lane adjustment activities on Mary Street in preparation for a material load out facility to be installed
- Adjustments to site facilities
- Delivery and removal of oversized plant equipment and material, including use of mobile cranes

## LOT 2 – Tunnelling site, within the acoustic shed

Northern corner of Albert and Mary streets intersection



### Underground excavation

#### Ongoing

- Excavation of the underground station platform cavern by roadheader and controlled blasting activities
- Ground stabilisation and retention works including shotcreting and rock bolting

### Tunnelling support activities

#### Ongoing

- Delivery and removal of plant, materials and equipment
- Extension, installation and adjustment activities to ventilation and tunnel services
- Bulk spoil removal activities

## LOT 3 – Northern station entrance

142 Albert Street, Brisbane



### Site support activities

#### March 2021

- Installation, adjustment and removal of barriers, fencing, hoarding and scaffolding, including signage
- Adjustments to site facilities
- Pedestrian gantry adjustment works
- Installation of material removal facilities including gentries and spoil bins
- Delivery and mobilisation of plant and equipment

### Earthworks and piling activities

#### March – April 2021

- Contaminated material inspections, monitoring and removal if required
- Site and geotechnical investigations
- Bored piling
- Earthwork activities including piling support activities, material separation and removal

## Local streets

Albert Street between Alice and Queen streets: Elizabeth, Charlotte and Mary streets



### Utility work and geotechnical investigations

#### Ongoing

- Locating, maintaining, installing and relocating services
- Geotechnical investigations and monitoring equipment installation
- Vegetation maintenance works

- Borehole investigations, drilling and reinstatement works
- Temporary partial lane closures and traffic changes where required



#### Standard construction hours

Standard construction hours are 6:30am to 6:30pm, Monday to Saturday.



#### Out of hours works

Some activities will be completed out of normal construction hours. Timing of these works are detailed in project updates - follow steps to register.



#### 24 hours

Tunnelling and tunnelling support activities are undertaken 24 hours a day.

### Albert Street controlled blasting update

As part of excavation of the tunnel access adits and underground station platform cavern, the Cross River Rail Tunnel & Stations contractor will recommence controlled blasting activities from mid-March 2021.

Blasting will be carried out between **7:30am and 4:30pm, Monday to Saturday**, excluding public holidays.
