5. A continuing Year 7 student is a student who was enrolled at the College for Year 6 and is continuing into Middle School. A new Year 7 student is a student that enrolls at the College for the first time in Year 7.

Other Family Fees

P&F Membership	\$20 per family
P&F Service Levy	\$250 per family*
College Journal	\$40 per family (payable in Term 4)
Building Fund	\$400 Recommended per family. All donations over \$2 are tax deductible.

*This amount is refundable at the end of the school year, provided the parent completes and reports 24 volunteer hours of P&F hours.

Notes:

- The College's policy is to provide all-inclusive Tuition Fees and levies as much as possible. This assists parents in establishing the total cost for the year, reduces cash handling and minimizes the number of requests for cash during the year.
- Levies include excursions, sport, swimming, textbook hire, graduation, student accident insurance, academic assessment tools, camps, curriculum bus transport, cultural activities and a general level of ICT access and support.
- The levies for Years 3, 5, 7 and 9 also include the charge from the government for each child's mandatory participation in the National Testing Program (NAPLAN).
- The levies for Years 7 to 12 also include an ICT levy for the provision of ICT support for the 1:1 program.

Discounts

The College Council has approved the following discounts to College families. The discount structure aims to support families most in need and reward families who diligently meet their fee payment obligations. These discounts apply to **Tuition Fees only**.

Payment Discounts

Early Bird Payment: Full payment of annual fees by 8 January 2017.

Annual Payment: Full payment of annual fees by 17 February 2017.

Direct Debit Payment: Discount per annum applicable to families who elect and honour direct debit system.

On-time payments: Discount per annum applicable to families who pay each term on-time or manage their own instalments.

Please note, these discounts are independent and not cumulative.
