Enrolment Fees

- Application Fee (payable when seeking admission to the School) \$100 inc GST
- Enrolment Fee (payable on acceptance of an Offer of Enrolment) \$80 ex GST
- Refundable Enrolment Deposit (payable on acceptance of an Offer of Enrolment and refundable when the student leaves the School) \$200 ex GST

TUITION FEES, LEVIES AND CHARGES

Early Learning Centre

- Kindy and Pre-preparatory \$81 / day
- Vacation Care \$81 / day
- Out of Hours School Care (OHSC) - After School Care \$15 / day
- Before School Care \$10 / day

Please note: Child Care Subsidy (CCS) is available on Kindy, Pre-preparatory, Vacation Care and OHSC Fees to all eligible parents who make application to Centrelink via MyGov. The Government pay the subsidy to the School and the School charges parents the balance. Further support for claiming Childcare Subsidy (CCS) is available from Centrelink.
