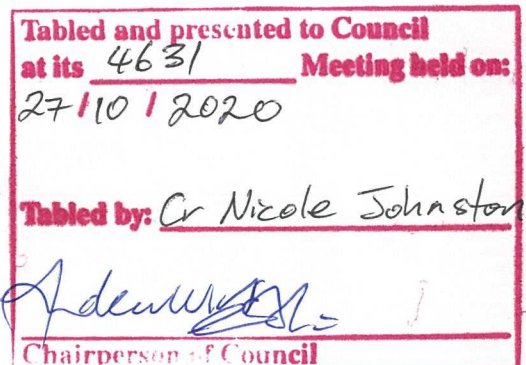

The idea postulated in the petition response that the petition is not by local residents is inappropriate and unnecessary. It also indicated to me that you really don't understand the importance of the safe crossing point at this location for the community.

Mildmay St is the link street between Fairfield and Annerley (via the station) and I know dozens of those signatures will be Annerley residents who live on the other side of the street and rail line and want a safe crossing point. They are clearly local and have an immediate interest in the petition outcome. Many are from nearby Yeronga as well.

Nor is there any mention of the major rail station upgrade currently underway.

This aspect of the petition response should be revised. This is a pro-forma response that does not even remotely address the issues or even acknowledge the interests of the signatories.

Deb you wanted to know what was wrong – this is a great example.
