The City of Adelaide (CoA) would like your feedback on an application for a City Works Permit from Yellow Berry Construct Pty Ltd and Cucci Investments Pty Ltd for:

The full road closure of John Street between Sturt Street and Heaslip Close From 7am Friday 28 July 2023 until 5pm Tuesday 17 December 2024 to allow for a loading bay to service the Kings Head Hotel Redevelopment.

Background

Under Section 223 of <u>The Local Government Act (SA)1999</u>. CoA has a legislative requirement to consult the public if it proposes to grant an authorisation or permit (following receipt of an application for a City Works Permit) for works 'that would result in any part of a road being fenced, enclosed or partitioned so as to impede the passage of traffic to a material degree'.
