Background

In September 2011 following community consultation the Open Space Strategy was adopted. As a number of the actions in the initial Strategy have been achieved the Strategy has been reviewed and updated.



The strategy lists open space maintained by Council and allocates each space to one of the following categories:

- Local Open space
- Neighbourhood Open Space
- District Open Space
- Regional Open Space
- State Open Space
- Network Open Space

The Strategy lists key design elements for each category of open space, actions that have been completed and actions for the future.

The intent of the Strategy is to provide the best possible services to the community while ensuring Council remains financially viable. In some circumstances this may result in reducing services or better managing open space. This is to ensure open space does not become a liability with additional assets needing to be maintained.

Why is Council consulting the community?

It is important to the community to have access to useable, safe and attractive open spaces. Open space contributes to the wellbeing and quality of life and the economic development and amenity of the district.
