Specific conditions relating to notices and disputes:

- I may ask my bank to reverse a direct debit up to 120 calendar days after the debit if:
 - I don't receive a written notice of the amount and date of each direct debit from the initiator, or
 - I receive a written notice, but the amount or date of debiting is different from the amount or due date specified on the invoice
- The initiator is required to give you a written notice of the amount and date of each direct debit no less than two (2) business days before the date of the debit
- If the bank dishonours a direct debit but the initiator sends the direct debit again within five (5) business days of the dishonour, the initiator is not required to give you a second notice of the amount and date of the direct debit.
