#### **Facts & circumstances of collection**

Your personal information is collected from:

- you when you provide us with your personal information;
- your authorised representatives;
- our dealerships, service centres or body shops when you buy, service or repair your vehicle;
- other service providers or entities affiliated with us that assist us in operating our business;
- publicly available sources; or
- as otherwise permitted or required by law.

## If the collection is required or authorised by law

We may be required to collect your personal information to register a vehicle you purchase under applicable State vehicle registration laws (e.g. Road Safety (Vehicles) Regulations 2021 (VIC)) or to sell your vehicle on consignment e.g. under the Motor Dealers and Repairer's Act 2013 (NSW).

#### **Purpose of collection**

The purpose for which we collect, hold, use, or disclose your personal information will depend on the specific collection. For example, if you purchase a vehicle from one of our dealerships, we collect personal information to manage your vehicle purchase and for matters that relate to your purchased vehicle including sending service reminders and safety recall notifications. In general, we may hold, use, or disclose your personal information for the purpose for which we collected it and related purposes which you would reasonably expect, or for purposes which you consent to and as otherwise authorised or required by law.

# The consequences if we do not collect your personal information

If we do not collection personal information we require, we may not be able to fulfill the purpose of collection and may not be able to do business with you or keep you up to date with information in relation to your purchased vehicle, parts, accessories, service, or special offers.

## Third parties we usually disclose personal information to and likely overseas disclosure

We may disclose your personal information to our dealerships or service centres, service providers who assist in the operation of our business and other third parties to fulfil the purpose for which we collected it, for example:

- if you subscribe to our marketing communications, our marketing agency;
- if you enter one of our competitions, prize providers;
- if you purchase a new vehicle, the vehicle manufacturer, regulatory authorities and third parties who assist with safety recalls;
- if you apply for finance, our finance providers; or
- if you are in an accident while test driving our vehicles, our insurers and where applicable third parties involved in traffic infringements.

Some of these may be located outside Australia including Singapore, Canada, Italy, Germany, Sweden, Japan, United States of America, United Kingdom, Ireland or New Zealand. Our privacy policy contains an up to date list.
