

**Suzuki 50% back**  
**Terms and Conditions of Entry**

**General**

1. Information on how to enter and prizes form part of the Terms and Conditions of Entry. Entry into this competition is deemed acceptance of these Terms and Conditions.
2. To the extent of any inconsistency between these Terms and Conditions and any other reference to this competition, these Terms and Conditions prevail.

**Who can enter**

3. Subject to the clauses below, entry is open to all residents of New South Wales and Queensland who have fulfilled the requirements set out below ('**Eligible Entrants**'). Entrants must be over the age of 18, as of the date of entry.

Entry is open to the range of new or demo Suzuki motor vehicles, excluding Jimny ('**Eligible Product Purchase**').
7.
