

Lake Victoria and Frenchman's Creek POSI

Northern Land Solutions (NLS) have been undertaking Rural Cadastral Survey work abutting Lake Victoria and Frenchman's Creek in remote NSW since 2019 for two clients, NSW DPIE and SA Water. Such works have involved Rural Subdivision, Conservation and Pipeline Easements and ultimately re-establishment of all of Lake Victoria, Frenchman's Creek and Rufus River boundaries; culminating into a Plan of Survey Information to be submitted to NSW LRS.

NLS were initially engaged by NSW DPIE to undertake subdivision and easement creation of historically significant Nulla and Noola Station, which was established in the 1890's as an 85,000-hectare Western Lands grazing property north of Lake Victoria. NLS were engaged to re-arrange title configurations such that the highly culturally significant frontage to Lake Victoria was divested from the overall farming activity, allowing the Department to sell such farming land back to graziers whilst retaining the Lake Victoria frontage under Department control. The total Lake Victoria frontage land excised from the station was 6050.2 ha, with the remaining 78,950 ha sold back to agriculture. Approximately 80km of pipeline, conservation and access easements were also created to allow NSW DPIE to protect and manage sites of cultural and conservational significance.

Following the registration of subdivision plans, NLS were then engaged by SA Water to re-establish and produce POSI plans along with GIS shapefiles for all 131km of their boundaries of Lake Victoria, Frenchman's Creek and Rufus River. Historically there had long been disputes about confirmed boundaries previously created between 1900 and 1910 via survey DP 191790. Furthermore, SA Water had a need to determine boundary positions to identify their responsibilities for extremely culturally significant sites throughout their land tenure. Most of the boundaries surveyed were extremely remote and inaccessible and could only be accessed by Quad-ATV. Many tree markings, original pegs, bottles and reference marks were found as part of this work. Boundaries were marked at corners and junctions along with 200m interval stakes.

Within all projects for NSW DPIE or SA Water, the extremely remote nature of boundary surveying was highly challenging. Literally hundreds of kilometres of boundary had to be surveyed and traversed across highly variable surfaces and landforms ranging from sand dunes, lakebeds, salt plains, erosion ruts, gypsum outcrops, river crevasses, creek depressions, lignum infestations and dense riverine vegetation. Excellent project planning was essential along with a rigorous Static Control Survey given the unforgiving access.

The majority of boundary sections were significantly cultural, with several hundred registered Aboriginal places including shell middens, artefact scatters, mounds, scarred trees and burials. NLS were required to carefully navigate these sites to ensure no harm, as required by SA Water's overarching AHIP. Knowing the locations of these sites relative to boundary was essential, hence NLS developed a customised GIS system to help locate sites in real time.

The team of NLS worked diligently and respectfully in undertaking their duties, and through excellent communication and expert explanation with clients and other stakeholders, valuable land titling and cadastral definition works were achieved.
