This course introduces participants to the issues associated with international trade transactions and the ways in which such issues impact on business and customs activities. Participants will examine commercial aspects and legal aspects of the international sale and carriage of goods, terms of trade, the financing of international transactions, and related matters.

Participants in this course will learn how to identify sources of information about international commercial transactions and apply their knowledge to their work as administrators, lawyers and traders. In particular they will learn how to increase their ability to deal with key issues of international trade contracts, terms of trade, and associated aspects.
