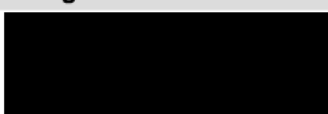
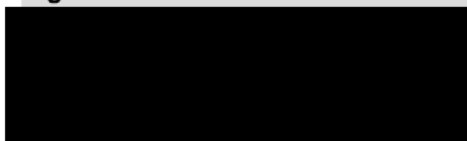

Electronic Record and Signature Disclosure

CONSUMER DISCLOSURE

From time to time, Rent Revolution (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. Getting paper copies

Withdrawing your consent
