

NETBALL SA STADIUM – CONDITIONS OF ENTRY

ALL PATRONS PURCHASING TICKETS OR ATTENDING EVENTS AT NETBALL SA STADIUM STRICTLY DO SO AT THEIR OWN RISK AND ARE THEREFORE REQUIRED TO ASSESS THEIR OWN RISK PRIOR TO ENTRY.

NETBALL SA HAS NO LIABILITY WHATSOEVER FOR ANY DAMAGED, LOST OR STOLEN PROPERTY NOR FOR ANY OTHER LOSS, DAMAGE OR INJURY SUFFERED BY ANY PATRON, WHETHER IN CONTRACT, TORT OR STATUTORY LIABILITY TO THE FULL EXTENT PERMITTED BY LAW.

NETBALL SA STADIUM IS COMMITTED TO PROVIDING A SAFE AND ENJOYABLE ENVIRONMENT FOR PATRONS, STAFF, ATHLETES AND PERFORMERS AND THE FOLLOWING CONDITIONS OF ENTRY WILL APPLY TO ALL NETBALL SA ATTENDEES.

PATRONS WHO REFUSE TO COMPLY WITH THESE CONDITIONS OF ENTRY WILL NOT BE PERMITTED ENTRY AND ANY ENTRY FEE/S WILL NOT BE REFUNDED.

TICKETS

- ALL PATRONS ENTERING NETBALL SA STADIUM MUST PAY THE APPROPRIATE ENTRY FEE OR PRESENT A VALID MEMBERSHIP CARD/TICKET.
- PASSES MUST BE RETAINED AT ALL TIMES.
- ANY TICKETS THAT ARE DAMAGED, DEFACED OR HAVE BEEN PURCHASED FROM AN UNAUTHORISED AGENT WILL NOT PERMIT THE HOLDER TO BE ADMITTED TO THE STADIUM.
- PATRONS MUST OCCUPY THE SEATS SPECIFIED ON THEIR TICKET.
- PATRONS WHO HAVE PURCHASED A CONCESSIONAL TICKET FOR AN EVENT MUST BE ABLE TO PROVIDE VALID PROOF OF CONCESSION (IE. PROOF OF AGE IDENTIFICATION OR CONCESSION CARD) UPON ENTRY IN TO THE STADIUM OR WHEN REQUESTED.

PASS OUTS

- PASS OUTS – WILL BE ISSUED ON MATCH DAY. PATRONS ARE ADVISED THAT WHEN RE-ENTERING THE STADIUM THEY MUST PRODUCE BOTH THEIR ENTRY TICKET AND PASS OUT.

SECURITY SCREENING

- BAG INSPECTIONS – NETBALL SA STADIUM MANAGEMENT RESERVES THE RIGHT TO INSPECT/SEARCH BAGS, REGARDLESS OF SIZE, OF ALL PERSONS WHO ENTER OR EXIT NETBALL SA STADIUM. THIS MAY INCLUDE THE TOUCHING OF THE OUTSIDE OF THE BAG AND/OR SEEKING ASSISTANCE OF THE BAG OWNER TO REMOVE ITEMS FROM THE BAG.
- NETBALL SA STADIUM WILL NOT BE HELD RESPONSIBLE FOR ITEMS CONFISCATED.
- SECURITY CAMERAS OPERATE AT THIS STADIUM AND PATRONS MAY BE FILMED/PHOTOGRAPHED.

PHOTOGRAPHY

- THE USE OF PHOTOGRAPHIC, VIDEO OR AUDIO EQUIPMENT FOR COMMERCIAL PURPOSES IS NOT PERMITTED WITHIN NETBALL SA STADIUM.
- PROFESSIONAL STANDARD STILL/VIDEO CAMERAS, RECORDING DEVICES AND ANY TRIPODS ARE NOT PERMITTED WITHIN NETBALL SA STADIUM.
- LENSES WITH A TOTAL-FOCAL STRENGTH OF GREATER THAN 200MM ARE NOT PERMITTED WITHIN NETBALL SA STADIUM.
- PATRONS GRANT NETBALL SA THE NON-EXCLUSIVE RIGHT TO USE THEIR IMAGE AND LIKENESS IN ANY FORM OR MEDIUM, AS PART OF ANY BROADCAST OR RECORDING OF THE MATCH AND FOR ANY OTHER COMMERCIAL PURPOSES (INCLUDING ADVERTISING AND PROMOTIONAL MATERIALS).
- TO ENSURE PATRON PRIVACY IS MAINTAINED, THE USE OF CAMERAS INCLUDING MOBILE TELEPHONES WITH CAMERAS MUST NOT BE USED IN AREAS SUCH AS TOILETS AND CHANGEROOMS.

PROHIBITED AND RESTRICTED ACTIVITIES AND ITEMS

- ALCOHOL – CANNOT BE TAKEN INTO OR FROM NETBALL SA STADIUM (see alcohol regulations below)
- ANIMALS – EXCEPT OFFICIAL GUIDE OR HEARING DOGS (passes must be shown)
- ANY ITEMS WHICH COULD REASONABLY BE DEEMED TO CAUSE PUBLIC NUISANCE OR OFFENCE TO ANY USER OF THE VENUE.
- BALLS, INCLUDING BUT NOT LIMITED TO TENNIS, CRICKET, FOOTBALLS
- BICYCLES, SCOOTERS, ROLLERBLADES/SKATES, SKATEBOARDS.
- BEVERAGE CONTAINERS (EXCLUDING AN INDIVIDUAL'S WATER BOTTLE) ARE NOT PERMITTED INTO THE STADIUM.
- FLAG POLES OVER 1 METRE IN LENGTH
- CONFETTI OR SHREDDED PAPER
- HARD ESKY OR ANY SIZE/TYPE (INCLUDING FOAM ESKY)
- FLARES, FIREWORKS, LASER POINTERS
- ILLICIT DRUGS
- INFLATABLE ITEMS INCLUDING BEACH VOLLEYBALLS, BALLOONS AND A RECEPTACLE DEVICE OR STRUCTURE.
- SHADE COVER STRUCTURES ARE PROHIBITED
- SIGNS, BANNERS, CLOTHING OR ANY OTHER ITEM INTENDED FOR THE ENGAGEMENT OF AMBUSH MARKETING
- THROWING OBJECTS – INCLUDING ONTO THE FIELD OF PLAY IS PROHIBITED AND MAY RESULT IN THE PATRON RESPONSIBLE BEING EVICTED (PENALTIES APPLY)
- ITEMS, WHICH IN THE OPINION OF MANAGEMENT, HAVE THE POTENTIAL TO CAUSE NUISANCE OR INCONVENIENCE TO ANY OTHER PERSON IN THE VENUE WILL BE REQUESTED TO BE REMOVED THE VENUE OR MAYBE CONFISCATED.
- LOUD HAILERS, MEGAPHONES AND MUSICAL INSTRUMENTS OR ANY NATURE (INCLUDING VUVEZELAS, HORNS, WHILSTLES AND DRUMS) ARE NOT PERMITTED INTO THE VENUE
- WEAPONS, GUNS AND KNIVES (OR ANY OTHER OBJECT THAT COULD BE USED AS A WEAPON).

SPECIFIC CONDITIONS MAY APPLY FOR SOME EVENTS REGARDING THE ENTRY OF MUSICAL INSTRUMENTS. PRIOR APPROVAL MAY BE PERMITTED AT THE DISCRETION OF VENUE MANAGEMENT.

ALCOHOL REGULATIONS

ALL PATRONS ENTERING NETBALL SA STADIUM ARE ADVISED THEY ARE ENTERING LICENSED PREMISES AND ARE THEREFORE REQUIRED TO COMPLY WITH THE FOLLOWING LIQUOR LICENSING LAWS;

- INTOXICATED PERSONS WILL NOT BE PERMITTED TO ENTER.
- PERSONS IN POSSESSION OF LIQUOR WILL NOT BE PERMITTED TO ENTER.
- INTOXICATED PERSONS WILL BE REMOVED FROM THE PREMISES.
- IT IS AN OFFENCE FOR MINORS TO PURCHASE AND/OR CONSUME LIQUOR.
- IT IS AN OFFENCE TO PURCHASE LIQUOR FOR (OR SUPPLY LIQUOR TO) MINORS.
- IT IS AN OFFENCE FOR PERSONS TO REMOVE ALCOHOL FROM THE PREMISES.
- PERSONS SUPPLYING LIQUOR TO MINORS WILL BE REPORTED TO THE POLICE. PENALTIES APPLY UNDER LEGISLATION.
- NO ALCOHOL CONFISCATED WILL BE RETURNED TO PATRONS.

SMOKING

- NETBALL SA STADIUM, INCLUDING THE OUTDOOR COURTS, IS A SMOKE FREE VENUE.

FIRST AID

- FIRST AID PERSONNEL ARE ON SITE TO PROVIDE THE GENERAL PUBLIC WITH FIRST AID SHOULD IT BE REQUIRED. PLEASE SEE STADIUM STAFF FOR ASSISTANCE.

DRESS STANDARDS

- AS A MINIMUM, PATRONS MUST BE APPROPRIATELY CLOTHED FOR A PUBLIC VENUE AND MUST WEAR SHOES.
- PATRONS WITH BARE FEET WILL NOT BE ADMITTED.
- SMART CASUAL ATTIRE IS THE MINIMUM STANDARD REQUIRED FOR CORPORATE HOSPITALITY.

GENERAL CONDITIONS

- TO ENSURE BOTH PATRON AND PLAYER SAFETY, UNAUTHORISED ENTRY TO THE COURT OF PLAY IS PROHIBITED (PENALTIES APPLY).
- PATRONS WHO CAUSE A DISTURBANCE, ARE OFFENSIVE, DISCRIMINATORY OR DISPLAY ANTI-SOCIAL BEHAVIOUR, OR REFUSE TO COMPLY WITH REQUESTS MADE BY NETBALL SA STADIUM STAFF MAY BE EVICTED.
- PATRONS WISHING TO BRING PERSONAL ITEMS INTO NETBALL SA STADIUM DO SO AT THEIR OWN RISK. NETBALL SA WILL NOT BE HELD RESPONSIBLE FOR ANY DAMAGE, LOSS OR THEFT OF A PATRON'S PERSONAL PROPERTY.
- UMBRELLAS MAY BE BROUGHT INTO NETBALL SA STADIUM BUT FOR THE SAFETY AND COMFORT OF OTHERS MUST BE USED RESPONSIBLY WHEN RAISED COURTSIDE WHILST ANY ACTIVITIES ARE TAKING PLACE ON THE PLAYING ARENA.
- PATRONS MUST REFRAIN FROM USING FOUL OR ABUSIVE LANGUAGE AND FROM MAKING RACIAL OR THREATENING REMARKS OR GESTURES.
- PATRONS ARE REQUIRED TO TAKE APPROPRIATE CARE FOR THEIR SUN PROTECTION AND HYDRATION
- SEATS RETRACT AUTOMATICALLY, PLEASE CHECK YOUR SEAT BEFORE YOU SIT DOWN

GENERAL CONDITIONS Cont.

- PATRONS MUST NOT INTERFERE WITH, OBSTRUCT OR HINDER NETBALL SA STADIUM OR ITS EMPLOYEES, AGENTS, CONTRACTORS OR AN AUTHORISED OFFICER.
- PATRONS ARE RESPONSIBLE FOR THEIR OWN CONDUCT WHILST IN THE VENUE AND MUST PAY FOR THE COST OF REPAIR OF ANY DAMAGE CAUSED TO THE VENUE AS A RESULT OF THEIR CONDUCT.
- PATRONS ARE NOT TO CONDUCT PUBLIC SURVEYS OR OPINION POLLS OR SOLICIT MONEY, DONATIONS OR SUBSCRIPTIONS FROM MEMBERS OF THE PUBLIC WITHOUT THE WRITTEN CONSENT OF NETBALL SA.

REFUSAL OF ENTRY / REMOVAL OF PATRONS

NETBALL SA STADIUM MANAGEMENT RESERVES THE RIGHT TO REFUSE ENTRY OR REMOVE ANY PERSON THAT BREACHES THESE CONDITIONS OF ENTRY.

- REFUSE ENTRY TO ANY PERSON DEEMED TO BE INTOXICATED AND/OR DISORDERLY;
- REFUSE ENTRY OR REMOVE ANY UNAUTHORISED PERSONS;
- REFUSE ENTRY OF ITEMS, WHICH HAVE THE POTENTIAL TO CAUSE INJURY OR PUBLIC NUISANCE.
- REFUSE ENTRY TO ANY PERSON REFUSING TO ALLOW INSPECTION OF CLOTHING, BAGGAGE OR CONTAINERS.
- REMOVE PATRONS THAT ARE DISRUPTIVE OR INTERFERE WITH THE ENJOYMENT, SAFETY OR COMFORT OF OTHERS.
- REMOVE PATRONS THAT HAVE A LOST, STOLEN COUNTERFEIT, DAMAGED OR UNREADABLE TICKET.

NETBALL SA STADIUM MANAGEMENT AT ITS DISCRETION, RESERVES THE RIGHT TO VARY THE ABOVE CONDITIONS OF ENTRY FROM TIME TO TIME.

PATRONS SHOULD ALSO REFER TO NETBALL AUSTRALIA'S MEMBER PROTECTION POLICY FOR ACCEPTABLE CODE OF CONDUCT AND CODES OF BEHAVIOURS EXPECTED AT NETBALL SA STADIUM.
