# Here is How the NSW Smart & Skilled Funding works...

**You are eligible for the NSW Smart & Skilled Funding if you are a:**

- ✓ **Australian Citizen** (Smart & Skilled Eligible; VET Student Loan Eligible)
- ✓ **Permanent Resident** (Smart & Skilled Eligible)
- ✓ **New Zealand Citizen** (Smart & Skilled Eligible; VET Student Loan – May be Eligible – contact to discuss conditions)
- ✓ **Humanitarian Visa** (Smart & Skilled Eligible; VET Student Loan Eligible)

## Your Student Fees

Student Fees can be paid by your work or by you as an individual.

### Payment Options for you to pay:

1. **Business pays in full** – either \$4430 or \$4700 – 100% tax deductible
2. **Payment Plans** are available to suit your budget (paid over 12 months on credit card).  
Either \$370 or \$392 per month
3. **VET Student Loan + small payment plan** – Only \$132 or \$154 mth x 12 months + INTEREST FREE Loan for \$2850 (paid back slowly with your personal tax when you personally earn over \$54,000 - for more details – [click here](#))

**Tax Deductibility (rebates)** – you will get back between **\$800 - \$2000** depending on your tax level and student fees, and if it relates to your work. Confirm with your Tax Advisor.
