### **TERMS & CONDITIONS**

- 1. The Finance Brokers Association of Australia Limited (FBAA) Awards of Supremacy are open to all members of the FBAA and/or their Industry BDM's
- 2. Each entry must be made in accordance with these terms and conditions. By entering the Finance Brokers Association of Australia Limited (FBAA) Awards of Supremacy, each nominee and each person submitting a nomination agrees to be bound by these terms and conditions.
- 3. Entries must be complete in every respect and must be received at the office of the FBAA by 5pm EST Friday, 2<sup>nd</sup> September 2022. No late entries will be accepted.
- 4. Entries may be submitted:
  - a. Via email to awards@fbaa.com.au
  - b. By post to PO Box 4792 Eight Mile Plains QLD 4113; or
     Delivered to the office of the FBAA at Level 1, 1 Miles Platting Road, Eight Mile Plains Qld 4113
- 5. If an entry is received in any manner other than as noted above, then its acceptance shall be at the absolute discretion of the judging panel.
- 6. An official entry form (photocopies accepted) must accompany each entry. The judging panel has the absolute discretion to reject any entry form that is incomplete or fails to provide all required information.
- 7. Criteria for selection may include (but are not limited to) disclosure of the gross amount of loans brokered by the nominee during the period from 1 July 2021 to 30 June 2022. Copies of supporting documentation from lenders/aggregators must be attached to the nomination to assist the judging panel to verify the stated amount. It is the responsibility of the nominee or person proposing the nomination to obtain all necessary consents and permissions to allow disclosure of such information to the judging panel. If such information is not provided, then the judging panel may at its absolute discretion reject the entry.
- 8. The judging panel shall comprise not less than two nor more than three persons, each of whom shall be appointed by the FBAA. The judging panel shall be disclosed to members by announcement either prior to or at the FBAA Awards of Supremacy.
- 9. The judging panel shall decide the award winner from entries received and considered acceptable by the judging panel. The criteria for judging entries shall:
  - a. Include the categories of information required as disclosed in the notes to the entry form;
  - b. Be consistent with the objects of the FBAA as set out in its constitution and its code of conduct;
  - c. Otherwise, be at the discretion of the judging panel, having regard to the interests and reputation of the FBAA and its members.
- 10. Decisions of the judging panel shall be final and binding; no correspondence will be entered into in relation to any decision of the judging panel.



## **NOTES FOR ENTERING EACH AWARD**

Set out the name of the category of award for which the nomination is made.
If the nominee is from a corporate member, then insert the name of the corporate member.
