4. ALLOCATION OF COMMONWEALTH GOVERNMENT DISASTER RECOVERY FUNDING

- B. Allocate \$250,000 for work to be undertaken in terms of stormwater drainage systems throughout the Shire in the 2019-2020 financial year with another \$250,000 to be forecast for work to be undertaken in terms of stormwater drainage systems throughout the Shire in the 2020-2021 financial year.
