Terms and Conditions

- 1. By completing and returning this form you are providing consent to Council to provide your Rate Notice(s) electronically pursuant to section 108 of the Local Government Regulation 2012. The provision of this information and/or documentation electronically complies with the *Electronic Transactions (Queensland) Act 2001*;
- 2. The information provided by you is solely for the purpose of delivery of your Rate and Water Notice by electronic mail:
- 3. You must be the registered owner of the property to receive your Rate and Water Notice by email;
- 4. Where a property has multiple owners, all owners must register for electronic rates and give consent to receive the Rate Notice to the one nominated email address provided;
- 5. All Notices will be sent as a PDF document attached to an email which includes the fees and charges brochure and any relevant information;
- 6. Any changes to your email address or requests to stop receiving Rate and Water Notice/s by email must be received in writing and is the responsibility of the property owner/authorised person;
- 7. If, for any reason, a Rate Notice could not be delivered to your email address, or if Council is unable to send a Rate Notice to your email address, the Rate Notice will be posted to you at your last advised postal address;
- 8. If, for any reason, a Rate Notice could not be delivered to your email address, or if Council is unable to send a Rate Notice to your email address, on two or more consecutive occasions, Council may cancel this electronic Rate Notice registration and recommence posting Rate Notices to you at your last advised postal address;
- 9. Council will only email a Notice to one email address;
