GENERAL MEETING MINUTES

Thursday 6th July 2023 at 9.00 am



- A. IN ATTENDANCE Mr RA Bosworth (Member), Cr WG Skinner (Member), Ms CA Coppo (Member), Ms LF Carr (Secretary) and Mr Brett Langtree (Trust Engineer).
- B. APOLOGIES Cr AJ Lancini (Member).
- **C. MINUTES** Confirmation of Minutes of the General Meeting held on 1 June 2023.

RESOLVED – That the Minutes be approved. (Ms CA Coppo and Cr WG Skinner - carried)

D. WORKS REPORT – The Trust Engineer, Mr Brett Langtree, provided an update of works for the month of June.

Langtree Consulting (BL) have undertaken the following tasks this month:

- 1. Attended the June HRIT Meeting on 1st June 2023.
- 2. Marine Cove Mooring, Dungeness: Rock Wall damage
 - Rhino Dive to undertake an underwater inspection of the site (including measurements and photos) and provide an inspection report for their findings on Friday 7th July 2023 at 10am.
 - Mr Keith Castorina is going to meet Mr Ryan Kelly from Rhino Dive on Friday morning and assist with the investigation.
- 3. Sink Holes Adjacent to Victoria Terrace, Halifax
 - Keita Services have not completed the works yet due to recent rains however, they are due to start next week.
- 4. 15 River Avenue, Halifax: Sink Hole Where Trees were buried
 - BL requested Keita Services to revise their quote to include the supply of the material only, based on the landowner installing the material themselves.
 - BL awaiting Keita Services revised quotation.

5. Frances/Cattle Creeks' Study

- Dr Mark Jempson's (Venant Solutions) draft report was issued to the HRIT on 14th June 2023.
- The report states that:
 - The evidence presented in the report all supports a view that the creek at the rail crossing is subject to periods of fluctuating bed levels over time scales of decades.
 - Sediment accumulations at the rail crossing have occurred in recent decades as the result of the interactions of natural process of sediment movement and human influences on sediment production.
 - It is likely that the period of pronounced sediment accumulation at the rail bridge is ending.
 That is not to say that sedimentation will cease to be a problem at this location, but it is unlikely that rates of sedimentation will increase in the near future.
 - The preferred option to investigate further is to extract sediment from Frances Creek upstream but near to the rail bridge. Extracted material would then by transported off the floodplain, possibly to the quarry area at the western end of Penna's Road.

6. Solari's Property

- The site inspection was undertaken on 30th March. There are in the order of seven (7) damaged sections along the Herbert riverbank.

- Scope of Works for the rehabilitation project is proposed to be:
 - All loose vegetation, rubbish, soil and sand to be removed back to cohesive soils at a batter slope that ties into the existing slope of the bank.
 - o Install a gabion wall at the top of the batter where the property boundary has started to become undermined.
 - Create a flat sand bed under the location of the proposed rock toe and install very large rock
 (i.e., rock in the vicinity of 1m diameter) at the toe.
 - Install rock in the order of 600mm diameter onto the batter slopes such that the batter rock interlocks and forms a stable batter all the way from the toe to the gabion wall at the top of the batter.
- It is estimated that the cost of these works is in the order of \$110K + GST for the Construction Works, Supervision and Contract Administration.

7. Timrith Bank Stabilisation Site

- Scope of Works for the rehabilitation project is proposed to be:
 - Undertake a geotechnical investigation and detailed survey of the existing site.
 - Undertake a detailed design and Bill of Quantities (BOQ).
 - Undertake a tender for a suitable contractor to complete the works and prepare contract documents upon the award of the works.
 - All loose vegetation, soil and sand to be removed back to cohesive soils at a batter slope and benches (say three benches if possible) that will allow the existing road/power poles to be retained.
 - Create a flat sand bed under the location of the proposed rock toe and install very large rock (i.e., rock in the vicinity of 3m diameter) at the toe.
 - o Install rock in the order of 600mm diameter onto the batter slopes such that the batter rock interlocks and forms a stable batter all the way from the toe to the top of the batter.
 - Hydro mulch the benches.
- It is estimated that the cost of these works is in the order of \$2.5M + GST broken down as follows:
 - Site Investigation works including the Geotechnical Investigation and Detailed Survey: \$150K.
 - Detailed Design: \$150K.
 - o Construction Works, Supervision and Contract Administration: \$2.2M.

8. Halifax Levee Project (to be undertaken by Keita Services)

• Keita Services have not completed the works yet due to recent rains however, they are due to start next week.

- 9. DRF Grant Applications decision made on 7th June 2023:
 - Reprofiling of Castorina Island approved to the value of \$510K (50-50 cost share, \$255K each);
 - Ripple Creek was not approved;
 - Denney Street Rock wall Emergent Works HSC was not approved; and
 - Herbert River Hydrological Study Dungeness HSC was not approved.
