1. About the Strategy

Northern Queensland Regional Organisation of Councils (**NQROC**) represents a collaboration of the following five Local Government Areas (LGA); Burdekin Shire Council, Charters Towers Regional Council, Hinchinbrook Shire Council, Palm Island Aboriginal Shire Council, and Townsville City Council. In a combined regional Council approach regarding policy and legislative changes, as well as emerging best practices, the joint decision was made to establish the **North Queensland Waste and Resource Recovery Strategy 2020-2030**.

The North Queensland Waste and Resource Recovery Strategy 2020-2030 identifies that a more rigorous view is required of the region's 'waste' streams and the opportunities they present to reduce, reuse, repair, recycle and otherwise recover. It supports the development of a circular economy that creates jobs, reduces pressure on landfill and the environment, and works towards the State and National 2050 waste targets.

A holistic strategic approach allows the opportunity to develop an overarching regional Strategy that is more efficient and sustainable than an individual Local Government Area (LGA) approach. Research indicates combined volumes of waste can attract higher levels of investment opportunities and more ambitious recovery infrastructure, leading to greater economic benefit and improved sustainability for the region.

The North Queensland Waste and Resource Recovery Strategy 2020-2030 takes into consideration a population of approximately 240,000 and covers a land area of 80,036 km².

2. Public consultation methodology

Public consultation regarding this strategy ran from **14 August 2020** to **18 September 2020**, which gathered valuable community feedback on the core concepts of the strategy. This consultation was based around the Have Your Say Townsville (HYST) online platform, whereby respondents could provide opinions and additional comment on the strategy.

Respondents were provided a set of key questions relating to the strategy and associated outcomes within their Local Government Area. This report identifies and captures all feedback associated with the project and serves as a public document to close the loop on the engagement process. The findings contained herein are presented in their entirety and draw no conclusions or recommendations on project outcomes going forward.

The identified Stakeholder Engagement objectives for this project include:

- Inform the community on current strategy concepts relating to waste and resource recovery throughout the region;
- Provide an opportunity for community feedback to be given; and
- Identify any opportunities or challenges pertaining to the strategy delivery or associated concepts.

These objectives were achieved through the delivery of timely and appropriate project collateral through multiple channels as outlined below.

3. Overview of key findings

Through the online Have Your Say platform, this consultation received **1044 unique site visitors** with **129 unique respondents** to the feedback form.

Key holistic findings received from this consultation include:

- 127 respondents (**98.4**%) believed it important for their respective Council to invest in improving waste management procedures;
- 68 respondents (52.7%) were satisfied with the information provided in the NQ Waste and Resource Recovery Strategy document;
- 94 respondents (**72.8%**) had *no concerns* or were *unsure* of the next steps outlined in the strategy document; and
- 95 respondents (**73.6%**) would be satisfied with NQROC implementing the next steps contained within the strategy document.




Figure 1 – Number of respondents by Local Government Area




Figure 2 - Number of respondents by residential status




Figure 3 - Number of respondents by land type




Figure 4 - Number of respondents by household size




Figure 7 – Respondent opinion on garden (green) waste services




Figure 10 - Respondent opinion on free dumping week waste services




Figure 11 – Respondent opinion on performance of local waste facility




Figure 12 - Respondent participation in composting methods including compost bin, chicken farm and/or worm farm




Figure 13 - Respondent usage of reusable shopping bags






Figure 14 - Respondent participation in rental of larger, hi-tech, or luxury items




Figure 15 - Respondent patronage of items that use less packaging / do not buy items with excessive packaging




Figure 18 - Respondent usage of larger recycling bin




Figure 23 - Respondent Priorities for Waste Management (1 = Highest Priority, 10 = Lowest Priority)

The clear priority with a highest rated average of **2.4** above was found to be '*Environmental Sustainability* (e.g. Reduce, Reuse, Recycle, Recover)', highlighting community focus on the need for improvements to waste management practices and services that will have the highest impact on improving sustainability.




Figure 24 – Respondent acceptance / tolerance of an increase to utilities charges on rates in order to provide additional waste services

The second highest priority across the combined Local Government Areas was found to be 'Accessibility to Services (e.g. frequency of collection, waste facility hours of operation)', which correlates directly to the finding of **75.2%** of respondents amenable to a utilities charge increase of between \$0 and \$100 to access these additional services (see *Figure 24* below).

In regards to public acceptance of an increase in utilities charges on their rates bill in order to access additional or auxiliary waste services, **75.2%** of respondents stated they **would** be amenable to an increase of between \$0 and \$100. Only **13.2%** of respondents stated that they **would not** pay for additional services.

3.2 Analysis of qualitative submissions

During the 35-day engagement period this public consultation received a total of **129 unique respondents**, from which **70 additional comments** were provided. An analysis of the additional text submissions found the following general themes:

- Support for increased communication and education on waste and recycling practices in the community;
- Support for increased green waste services;
- Interest in supporting and fostering innovation and alternative technologies in regards to waste recycling; and
- Concerns regarding mitigation and management of kerb-side and hard waste such as discarded tyres.




Figure 25 - Have Your Say Townsville Visitors Summary




Figure 26 - Have Your Say Townsville Channel Summary

5. Social media statistics

As part of this public consultation campaign, a number of integrated marketing channels were implemented to ensure a wider reach throughout the five Local Government Areas, and a more accurate representation of public opinion. Key figures related to the social media boosted post are as follows:

Where:

- "Impressions" is the number of people who had the article show on their device;
- "Reach" is the number of people who spent time reading the article; and "Results" is the number of people who clicked a link and interacted with the post.

Response	Do you have any concerns regarding the next steps contained within the Strategy?
1	Mandating a green/purple (organics) bin could be challenging. Uptake in Victoria is high but not required as some people have their own compost or worms or don't do their own gardening. All households should only have 80L or 120L red bin to reduce the use to these bins. Misses other streams such as soft plastic, printer cartridges, stationary and so many more that should be easily available but are very expensive for individuals to undertake (see TerraCycle.com/en-AU). Put them at landfills or incorporate collection days (eg with the free green waste??).
	Organics should include containers that are compostable in industrial facilities but not at home (like the ones most are using now at the TSV mandated plastic free events but they won't break down in the landfill!!)
2	A good waste option is desperately needed. Many councils have been doing it for years with great success, lowering land fill enormously
3	A number of additional services and processing technologies will add significant cost to the provision of waste services. How will this be covered?
4	At alligator creek we still do not have recycling bins despite discussing this at length with our local member.
5	Concerned about illegal dumping and feel there should be more actions outlined to mitigate the risk. I would like to see a managed strategy for easier and cheaper access to getting rid of bulky household waste and monitoring/cleanup of know dump sites and fines and prosecution for illegal dumping.
6	Cost and real practically. It is ultimately going to come down to escalating prices for rate payers and I am not happy about that. We pay excessive amounts for rates now.

Response	Do you have any concerns regarding the next steps contained within the Strategy?
7	Cost to rate payer.
8	Costs to each household. How much is government paying to foot this idea. Its called an investment at our cost.
9	Halving the amount of organic waste going to landfill is NOT sufficient- all organise waste should be composted. Manufacturers & retailers have an obligation to reduce waste & excessive packaging.
10	How you plan to get multiple councils with such physically and socially diverse groups to agree on a waste management plan is of concern.
11	I am concerned that a focus on improved education regarding recycling is not an appropriate strategy. Yes- education is important. But the way to change human behaviour is not just through education. One of the biggest barriers to recycling is the level of confusion about what can be recycled. Humans will usually choose the easiest option. Labelling of materials needs to be vastly improved to make it much easier to identify what can be recycled.
	Likewise- dumping options need to be improved and consideration needs to be given to how to make dumping affordable. Illegal dumping happens because transfer stations are not open at convenient times and costs can be prohibitive for some sectors of the community.
12	I am concerned that the main goals of the strategy appears to be further research and investigations rather than implementing changes that will reduce (preferably eliminate) landfill use in the next 10 years, increase/establish local material and energy recycling and establish commercial composting. The goals of the strategy should be updated to implementing these changes instead of 'investigating' their potential.
13	I don't want a smaller general waste bin!
14	I don't know what they are and that concerns me. I'm also wondering how much this strategy has cost.
15	I like what is written there, especially the circular economy, but I have little faith that it will actually happen. There's a lot of people in this town that don't understand or care enough to make a change.
16	I think that we can always go further. We can be more ambitious with our targets and commit to becoming (unnecessary) plastic free as soon as possible. I love the idea of organic bins and would like to see that implemented as soon as possible as well.
