

# Terms and Conditions

## 'MG3 Car Giveaway'

### Eligibility

1. Un-financial or Suspended members of Townsville RSL or Thuringowa RSL Club, Committee, Management, Employees of Townsville RSL Group & their immediate families are not eligible to enter the promotion. For the purposes of these Terms and Conditions, "immediate family" means any of the following: a spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, brother, sister, step-brother or step-sister living at the same residential address.

### Entry

2. Eligible members who play Townsville RSL or Thuringowa RSL gaming machines between 10:00am & 3:00am with their membership card inserted will receive 1 (one) automatic entry for every \$50 turnover.
3. Eligible members who use their membership card when paying through POS (Point of Sale) including food, beverage and Keno at Townsville RSL or Thuringowa RSL between 10:00am & 3:00am will receive 1 (one) automatic entry for every \$10 (ten dollars) spend.
4. Eligible members who swipe their membership card at a Foyer Kiosk at Townsville RSL or Thuringowa RSL will automatically receive 1 (one) entry per day.
5. Eligible members who play Townsville RSL or Thuringowa RSL gaming machines between 9:00pm – 3:00am daily with their membership card inserted will automatically receive double entries.
6. Promotional period is between 10:00am Friday 1<sup>st</sup> October 2021 – 8:00pm 26<sup>th</sup> December 2021.

### Identification

7. Members may be required to produce their membership card and one (1) form of valid photographic identification or their membership card and two (2) other forms of valid identification, acceptable to Townsville RSL Group, to claim their prize.

### Prize Giveaway

8. 3 (three) MG3 Cars valued at \$17,990 driveaway. Plus 20x \$250 cash draws each Saturday as listed below, totalling \$60,000.
9. Preliminary draws into major car draw and \$250 cash prizes are each Saturday night from 5:00pm. The dates are 9/10/21, 16/10/21, 23/10/21, 30/10/21, 6/11/21, 13/11/21, 20/11/21, 27/11/21, 4/12/21, 11/12/21, 18/12/21, 26/12/21.
10. The 3 (three) major car draws will take place on the following nights; Saturday 30<sup>th</sup> October, Saturday 27<sup>th</sup> November and Sunday 26<sup>th</sup> December.
11. Entries must be validated from 4pm by swiping your membership card in either the foyer swipe, completing a POS transaction or inserting into a gaming machine.
12. \$250 preliminary cash draws will be drawn at between 5:00pm and 8pm (20 x \$250 cash = \$5,000 Cash total).
13. At 8:00pm all entries from the previous 4 (four) preliminary draws will go into a barrel. The promotion host will randomly select an entry from the barrel as the winner of the car. There is a 1/80 chance of being selected.
14. To be eligible to win either the preliminary cash prize or major car prize, each selected Member must present himself/herself to a representative from Townsville RSL or Thuringowa RSL at the designated draw location within one (1) minute of his/her name being announced. If not, a redraw will take place until a winner is found.
15. Eligible members can be at either Townsville RSL or Thuringowa RSL to claim however the barrel will be located at Townsville RSL. If the 8:00pm major draw winner is located at Thuringowa RSL, the promotion host will communicate with the winner and details will be taken by a Manager.
