By entering the 2017 Townsville Turf Club 100 Club the representative of the business agrees to the following conditions

- 1. The entry fee of \$1,250.00 + GST will be paid no later than one week prior to the Gala Draw Evening in May 2017.
- 2. A draw shall be conducted by the Townsville Turf Club in May 2017 to allocate the sponsorship rights as detailed in the brochure circulated.
- 3. The business shall accept the ballot as FINAL. All businesses will be notified of the results by mail.
- 4. The sponsorship right shall only be used by the business listed in the application. Only ONE business name may be allocated for each sponsorship.
- 5. The sponsorship prize is non transferable, non exchangeable and non redeemable for cash.
- 6. The business will sponsor the horse race allocated to it by the ballot in the manner directed by the Townsville Turf Club.
- 7. The business will consult and comply with the directions of the Townsville Turf Club to ensure that the business advertising does not infringe the terms of any other sponsorship agreements held by the Townsville Turf Club.
- 8. The sponsorship rights shall be those specified in the brochure circulated by the Townsville Turf Club. Each entering business will receive two (2) tickets to the Gala Event where the draw will be conducted. In addition each business will receive an annual Membership to the Townsville Turf Club for the 2017/2018 financial Year.
- 9. In the event of a race meeting being abandoned, the business will lose the naming rights of the race allocated, but will be allocated another race sponsorship on a mutually agreed date.
- 10. Prizes for the draw will be drawn from 101st down to 2nd prize from a barrel containing the names of all 100 Club Sponsors. As the prizes are drawn, each 100 Club Sponsors name will then be placed into the major prize barrel. The major draw for 1^{st prize}, which is naming rights to the 2017 Ladies Race Day, will be the last draw of the evening and will contain the names of all of the 100 Club Sponsors.
- 11. One of the benefits of the 100 Club is an annual membership to the TTC for the season. Businesses are required to nominate one person not a current TTC member upon acceptance and payment of the 100 Club fee the TTC will forward a nomination form for membership.
