## Is NEIS for you?

To be eligible for New Business Assistance with NEIS you must:

- Be at least 18 years of age by the time you commence the program
- Be legally allowed to work in Australia
- Be available to participate in NEIS training (if relevant) and work full-time in your proposed NEIS business
- Have not received NEIS assistance in the previous year
- Not be an undischarged bankrupt

## About NEIS

New Business Assistance with NEIS is designed to give you the support you need to create and run a successful small business, achieve your goals and live life your way!

- Firstly, a NEIS mentor will review your business idea to check whether it's feasible. You'll then complete a BSB30315 Certificate III in Micro Business Operations (which takes about 8-13 weeks) to learn new skills in small business planning and operations. During the course you'll continue to develop your business idea and create a business plan.
- Once your business plan is approved, you'll commence one-on-one business mentoring, which will run throughout the first year of your business. You'll also receive financial support: the NEIS Allowance\* for 39 weeks plus NEIS Rental Assistance\* for up to 26 weeks.
