# BEFORE THE DISTRICT LICENSING COMMITTEE DECISION

- [1] An application was filed on 21<sup>st</sup> May 2025 by JOYCCS TRADING LIMITED for a temporary authority to operate an off-licence in respect of premises situated at 20 DUNMORE STREET, WĀNAKA, known as NEW WORLD WANAKA. The premises are currently operating pursuant to licence 68/OFF/2167/2024. The base licence was current until 13<sup>th</sup> December 2025.
- [2] The premises are to be operated in the same manner they have under the previous owner.
- [3] This will be the first issue of a temporary authority for these licences. A substantive licence application has yet to be made.
- [4] Seventeen certified managers are to be employed to properly operate the premises. The Applicant is reminded of their obligations pursuant to s.231 & 232 of the Act.
- [5] There were no matters in opposition from the Police and the report on the application from the Inspector was favourable.
- [6] The committee has considered the criteria in accordance with s.136 of the Act and grants the issue of temporary authority as sought.
- [7] This temporary authority is issued to take effect on the 7<sup>th</sup> July 2025 until 7<sup>th</sup> October 2025.

### 68/OFF/2167/2024

**Pursuant** to the Sale and Supply of Alcohol Act 2012 (the Act) **Greata Enterprises Limited** (the licensee) is authorised to sell and supply alcohol on the premises situated at **20 Dunmore Street, Wanaka, Queenstown Lakes District** and known as **"New World Wanaka"** to any person for consumption off the premises, and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

#### **CONDITIONS**

This licence is subject to the following conditions:

- a) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day or before 1.00pm on Anzac Day:
- b) No alcohol may be sold other than—
  - beer that complies with the appropriate New Zealand food standard for beer; or
  - ii) mead that complies with the appropriate New Zealand food standard for mead; or
  - iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
  - iv) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
  - v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- c) Alcohol may be sold only on the following days and during the following hours:

#### Monday to Sunday 7.00am to 10.00pm

- d) Alcohol may only be displayed and promoted in the single-area described in plans submitted to the District Incensing Committee on 6 October 2021.
- e) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed: Display of appropriate signs adjacent to every point of sale detailing the statutory restrictions of the supply of alcohol to minors, the prohibition on sales to intoxicated persons, and identification of minors.
- f) According to the Sale and Supply of Alcohol (Fees) Regulations 2013 the premises is assigned the fees category: **Medium Supermarket**.

#### **DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force –

- a) Until the close of the period for which it was last renewed; or
- b) If an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.
