

# Ōpōtiki District Licensing Committee

## OFF LICENCE

*Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012*

**PURSUANT** to the Sale and Supply of Alcohol Act 2012 (the Act), **JB HEAL LIMITED (the licensee)** is authorised to sell alcohol on the premises situated at **19 BRIDGE STREET, ŌPŌTIKI** and known as **ŌPŌTIKI NEW WORLD**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

### CONDITIONS

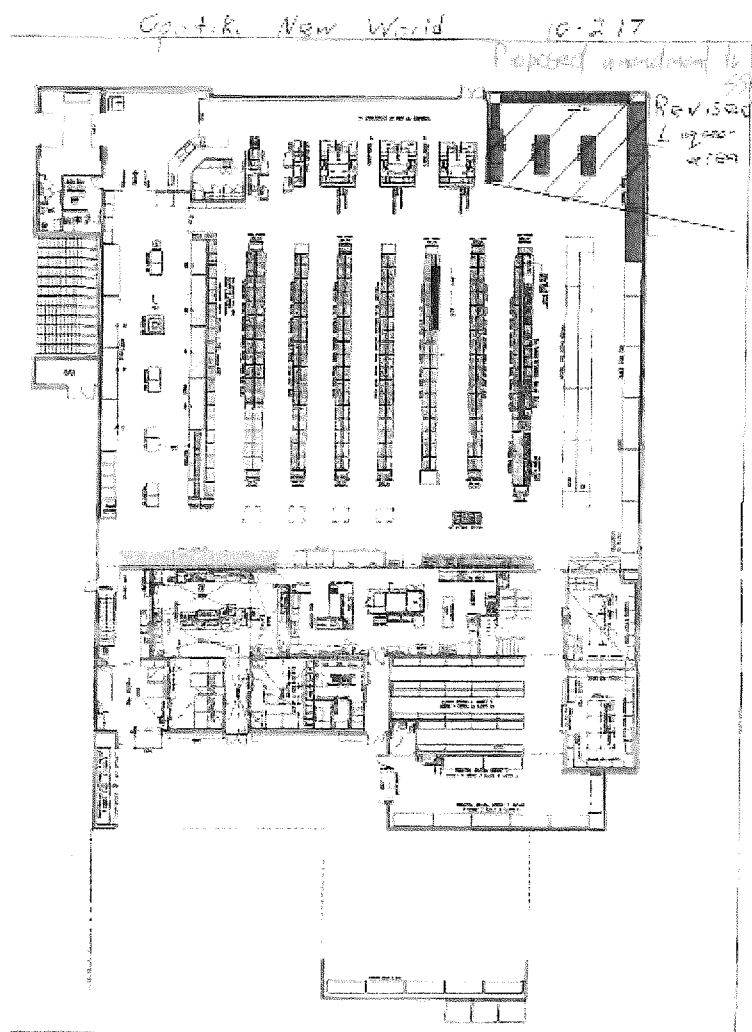
This licence is subject to the following conditions:

- (a) no alcohol is to be sold or delivered on Good Friday, Christmas Day, or before 1 pm on Anzac Day;
- (a) no alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made—
  - i. on the premises; or
  - i. from grapes or fruit harvested from land on which the premises are situated;
- (b) no alcohol may be sold other than—
  - i. beer that complies with the appropriate New Zealand food standard for beer; or
  - i. mead that complies with the appropriate New Zealand food standard for mead; or
  - ii. fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
  - iii. grape wine that complies with the appropriate New Zealand food standard for grape wine; or
  - iv. a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- (c) alcohol may be sold only on the following days and during the following hours:

**MONDAY TO SUNDAY, 7:00AM TO 10:00PM**
- (d) Water must be free and available during any tastings held at the premises and will be situated at the tasting area
- (e) the whole of the premises is designated as neither restricted or supervised, therefore is undesignated
- (f) Only the area delineated as “revised liquor area” on the attached plan marked Plan “B” is a permitted area for the display and promotion of alcohol (Single Alcohol Area). This condition will NOT apply until the 30th of May 2017.

- (g) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
- Staff must be trained in their responsibility to prevent sale of alcohol to minors or intoxicated people,
  - Signs must be clearly displayed at each point of sale indicating that alcohol will not be sold to minors or intoxicated people, and that ID is required for all persons who appear to be under the age of 25.
- (h) The following steps must be taken to promote the responsible consumption of alcohol:
- The premises Social Responsibility Policy must be on display and being implemented at all times when alcohol is available for purchase.

### PRINCIPAL ENTRANCE

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from **BRIDGE STREET, ŌPŌTIKI** is designated as the principal entrance.

**DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force –

- (a) Until **11 February 2020**; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed


NOTE: this licence shall expire on the same expiry date (or anniversary) as that of the licence it replaces or, if renewed, of the most recent renewal certificate.

**ADVICE TO APPLICANTS**

It is the licence holder's responsibility to note the expiry date for this licence and to ensure any renewal application is lodged prior to the expiry date.
