

**OFF-LICENCE****Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012**

PURSUANT to the Sale and Supply of Alcohol Act 2012 (the Act), **GR & S DYSON LIMITED** is authorised to sell alcohol on the premises situated at 247 Old Taupo Road, Rotorua, and known as "NEW WORLD WESTEND", to any person for consumption off the premises and to supply alcohol free, as a sample, for the consumption on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

**CONDITIONS**

This licence is subject to the following conditions:


- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on Anzac Day:
- (b) No alcohol is to be sold other than:
- (i) beer that complies with the appropriate New Zealand food standard for beer; or
  - (ii) mead that complies with the appropriate New Zealand food standard for mead; or
  - (iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
  - (iv) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
  - (v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- (c) Alcohol may be sold or delivered only on the following days and during the following hours:
- Monday to Sunday - 7.00 am to 11.00 pm**
- (d) The licensee must ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- (e) That no single sales of mainstream beer less than 500ml volume take place. This does not include craft beer and wine over 375ml.
- (f) That no single sales of high strength mainstream beer (8%+ alcohol by volume) in individual containers greater than 500ml volume takes place.
- (g) That the plan (dated 29 May 2018) of the single area be stored in the office of the premises and also includes the secondary area plan that is to be used annually from the 15<sup>th</sup> of December to the 10<sup>th</sup> of January inclusive.

**DURATION**

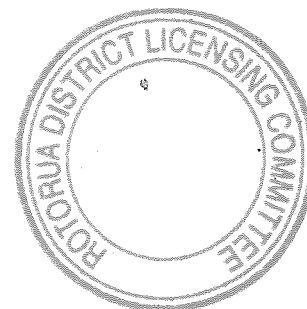
Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Either
- (i) until the close of the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) If an application for the renewal of the licence is duly made before the licence would otherwise expire, either -
- (i) until the close of the period of 3 years after the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.
