

OFF LICENCE

41/OFF/5121/2015

PURSUANT to Sections 17 to 20, and Section 64, of the Sale and Supply of Alcohol Act 2012, G and B Hasler Ltd (the licensee) is authorised to sell and supply alcohol on the premises situated at 8 Barraud Street Dannevirke 4930, and known as Dannevirke New World, to any person for consumption off the premises and to supply alcohol free, as a sample for consumption on the premises.

Conditions

This licence is subject to the following conditions:

1. No alcohol is to be sold or delivered on Good Friday, Christmas Day, or before 1pm on Anzac Day.
2. No alcohol is to be sold or delivered on Easter Sunday unless the alcohol is grape wine or fruit or vegetable wine made:
 - (i) on the premises; or
 - (ii) from grapes or fruit harvested from land on which the premises are situated.
3. In the case only where the premises are a supermarket or grocery store no alcohol may be sold other than:
 - (i) beer that complies with the appropriate New Zealand food standard for beer; or
 - (ii) mead that complies with the appropriate New Zealand food standard for mead; or
 - (iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
 - (iv) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
 - (v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
4. Alcohol may be sold only on the following days and during the following hours: **Monday to Sunday 7:00am to 10pm**
5. In the case only of a supermarket or grocery the only area delineated on the attached plan is a permitted area for the display and promotion of alcohol.
6. The licensee must ensure that the provisions of the Act relating to the consumption of minors and intoxicated persons are observed and signage is displayed.
7. The licensee must implement and maintain the steps proposed in the application for the licence aimed at promoting the responsible sale of alcohol.
8. **A copy of this licence must be displayed at the principal entrance/s** to the premises so as to be easily read by people entering each principal entrance
9. At each **principal entrance to the premises a sign must be displayed stating the hours of business** during which the premises are open for the consumption of alcohol
10. At each principal entrance to the premises a **sign must be displayed stating the Duty Manager**.

The Licensed Premises

The premises situated at 8 Barraud Street Dannevirke 4930 are more precisely identified as outlined in a plan date stamped by the Tararua District Licensing Committee on 20/06/2018. **The entrance from Barraud Street is designated as the principal entrance.**

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, this licence continues in force:

- (a) Either:
 - (i) until the close of the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) If an application for the renewal of the licence is duly made before the licence would otherwise expire, either:
 - (i) until the close of the period of 3 years after the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.
