

**OFF-LICENCE**

Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012

**PURSUANT** to the Sale and Supply of Alcohol Act 2012 (the **Act**), **Wentworth Supermarket Limited** is authorised to sell alcohol on the premises situated at 128 Onerahi Road, Onerahi, Whangarei and known as "**New World Onerahi**", to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

**CONDITIONS**

This licence is subject to the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
- (b) Alcohol may be sold only on the following days and during the following hours:  
**Monday to Sunday 8.00 am to 10.00 pm**
- (c) No alcohol may be sold other than-
  - beer that complies with the appropriate New Zealand food standard for beer; or
  - mead that complies with the appropriate New Zealand food standard for mead; or
  - fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
  - grape wine that complies with the appropriate New Zealand food standard for grape wine; or
  - a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- (d) Only the area delineated on a plan received by the District Licensing Committee and date stamped 19 March 2018, is a permitted area for the display and promotion of alcohol.
- (e) Drinking water is to be freely available to customers while alcohol is being supplied free, as a sample, for consumption on the premises and this must be located within the Single Alcohol Area.
- (f) The following steps must be taken to ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed:
  - Ensure that no intoxicated persons are allowed to enter or to remain on the premises;
  - Ensure that appropriate signs are prominently displayed at each entry and adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition of sales to intoxicated persons.
- (g) The licensee must ensure that the alcohol area is managed at all times to comply with section 114 of the Act.

**THE LICENSED PREMISES**

The sale, supply or consumption of alcohol is authorised in the premises situated at 128 Onerahi Road, Onerahi, Whangarei is more precisely identified as outlined in a plan date stamped as received by the Whangarei District Licensing Committee on 19 March 2018.

**DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S**

A copy of this licence must be attached to the inside of the premises concerned so as to be easily read by people entering principal entrance to the premises. The entrance off the carpark is designated as the principal entrance.

**DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) either—
  - (i) until the close of the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
  - (i) until the close of the period of 3 years after the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.
