

OFF-LICENCE

Sections 17, 18 and 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 (the **Act**), **Roose Moose Limited** (the Licensee) is authorised to sell alcohol on the premises situated at **10-12 Hakiha Street, Taumarunui (State Highway 4)**, and known as "**Taumarunui New World**", to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. If this Licence is not endorsed under Section 40 of the Act, the Licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

CONDITIONS

This licence is subject to the following conditions:

- (a) Alcohol may be sold and supplied only on the following days and during the following hours:
Monday to Sunday 7.00 am to 8.00 pm.
- (b) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
- (c) No alcohol may be sold other than:
 - (i) Beer, Mead, Fruit, Vegetable and Grape wine that complies with the appropriate New Zealand food standard; or
 - (ii) A food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- (d) The area where alcohol is to be sold is described in the plan date stamped as received by the District Licensing Committee on 1 April 2025. The only area permitted within that plan, as an area for the display and promotion of alcohol pursuant to section 112 is at front right-hand side of the shop adjacent to the primary exit.
- (e) The entire premises is undesignated.
- (f) A properly appointed certificated, acting or temporary manager must be on duty at all times when the premises are open for the sale and supply of alcohol.
- (g) A manager's register (as required by s.232 of the Act) is to be maintained and available on site.
- (h) A Host Responsibility Policy must be maintained and displayed at all points of sale and the Licensee must ensure all staff receives training in their responsibilities and obligations under the Sale and Supply of Alcohol Act 2012.
- (i) There must be no sale or supply of alcohol to minors or intoxicated persons and there must be displayed at every point of sale appropriate signs detailing these restrictions.
- (j) Drinking water must be freely available and displayed whenever alcohol is being supplied by way of complimentary tastings.
- (k) The Licensee must ensure the following are displayed:
 - (i) A sign to be seen from outside the principle entrance at 10-12 Hakiha Street, Taumarunui (State Highway 4) stating the ordinary hours of business during which the premises will be open for the sale of alcohol.
 - (ii) A copy of the original licence with all the conditions, just inside the principle entrance at 10-12 Hakiha Street, Taumarunui (State Highway 4) so persons entering can read it.
 - (iii) A sign in a prominent place identifying the duty manager.
