



**Pursuant** to the Sale and Supply of Alcohol Act 2012 (the Act), ACLB Limited (the licensee) is authorised to sell alcohol on the premises situated at 27 Russell Street, Waipukurau and known as New World Waipukurau, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

### Conditions

This licence is subject to the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Christmas Day, or before 1 pm on Anzac Day.
- (b) Alcohol may be sold only on the following days and during the following hours:  
**Monday to Sunday 7.00am to 11.00pm**
- (c) No alcohol may be sold other than—
  - (i) beer that complies with the appropriate New Zealand food standard for beer; or
  - (ii) mead that complies with the appropriate New Zealand food standard for mead; or
  - (iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
  - (iv) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
  - (v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- (d) Drinking water is to be freely available to customers immediately adjacent to any alcohol that is being supplied free as a sample on the premises
- (e) No intoxicated persons may be allowed to enter or to remain on the premises.
- (f) The licensee must ensure that the provisions of the Act relating to the Sale and Supply of Alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and complete the prohibition of sales to intoxicated persons.
- (g) Only the area outlined on the plan received by council is a permitted area for the display and promotion of alcohol. A copy of the plan must be either displayed alongside this licence, or available for viewing at the premises upon request.
- (h) The Social Host Responsibility policy that was submitted with the application must be complied with.
- (i) The whole of the premises is undesignated.

### Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) Either—
  - (i) until the close of the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued.
