## How is the information collected?

We collect personal information from people who respond to the Covid-19 Survey

## Is the collection required under a law or Court order?

No

## What are the purposes of collection?

The primary purpose of the collection is to:

- endeavour to establish the impact of the Covid-19 pandemic on sporting clubs across Australia, both now and into the future, including by trying to quantify the costs incurred by and the additional funding required by such sporting clubs as a result of the pandemic;
- to help us better represent the needs of grassroots sporting clubs in our discussions with potential funders (both philanthropic and Government); and
- to use the information collected to help raise more funds that we can then channel to sporting clubs to help them to deal with the extra costs and reduced income resulting from the impact of the Covid-19 pandemic.

The secondary purpose is to bring to your attention other opportunities, offers and events to assist with the funding of your sporting club. We will store your details in our database, including your name, email address, phone number, name of sporting club, location of sporting club and type of sport.

## What happens if we don't collect this information?

Without this information we are unable to accurately establish the impact of the Covid-19 pandemic on sporting clubs across Australia, to advocate on your behalf to secure additional funding for such sporting clubs or to notify you of other opportunities to assist with the funding and the future viability of your sporting club.

## Can you be anonymous?

No, we need to collect details of your name in order for us to ensure the integrity of the survey.

## To whom do we share this information ?

We share this information with other affiliated organisations and service providers, such as information technology or other service providers.

In advocating for additional funding for sporting clubs across Australia, we will share, on a de-identified basis, the general results of the Covid-19 Survey with Government departments and private and corporate philanthropists, as well as other stakeholders – such as national and state sporting organisations – that can assist in obtaining additional funds.

## Do we share the information overseas?

Yes, we store some personal information on cloud servers which are hosted overseas, together with software backups.
