If your Application is accepted by the Lessor, you are required to pay an amount equivalent to two (2) weeks rent and/or the full Bond amount and sign the General Tenancy Agreement within 24 hours of notification of acceptance.

Rent payment method options

Our Agency uses the services of Westpac Banking Corporation "PayWay and the cost to the Tenant if this service is accepted will be \$1.00 per direct debit transaction and 1.5% or higher for Credit or Debit Cards.
