## WHICH RATE APPLIES TO ME?

### Anytime – Single Rate tariffs:

These tariffs consist of a Daily Supply Charge and per kWh energy rate which is the same at all times of the day.

### Controlled/Dedicated Load rates:

Rates for time switch controlled hot water services, space heaters and other dedicated loads, generally controlled between 11pm and 7am.

### Time of Use and Flexible tariffs:

These tariffs consist of a Daily Supply Charge, and different per kWh energy rate for Peak times, Off Peak times and for Flexible tariffs, "Shoulder" times.
