Ross Creek rose 3 ft. higher than previously recorded. Keppel Sands (Sandhills), bathing boxes were damaged or blown off blocks. Flooding serious and Broadmount suffers effect of flood and tide, *Morning Bulletin*, 5 February, pp. 6-9.

Anon, (1929), Rain records broken, Rockhampton has 3133 points. Two men missing, one drowned, *Morning Bulletin*, 25 February, p. 7.

Anon, (1929), Casuarina Island (Fitzroy River) cyclonic rain, 40 in. in two days, *Morning Bulletin*, 25 February, p. 7.

Anon, (1929), Cyclone centred at coast, *Evening News*, 23 February, p. 5.

Anon, (1929), Rockhampton has nineteen hours of incessant rain. Vast area flooded, one man drowned, five others rescued from floodwaters. Cyclone of similar intensity to 1918 and

1928. River rose 14 ft. overnight, *Evening News*, 21 February, p. 1; 22 February, p. 9.

The fresh and flood in the Fitzroy River covers all wharves except the high-level railway wharf and deep-water wharves. No telegraph communication with Sea Hill. Arrival or departure of vessels is unknown. *Morning Bulletin*, 2 February, p. 5.

Anon, (1890), Storms and flood at Emu Park, where lightning killed a man at a Tanby Point work camp. *Morning Bulletin*, 27 March, p. 5.

Anon, (1890), Cyclonic rains flooded Emu Park. Hillsides became torrents. Cape Capricorn, North Reef and other light stations reported seas during early February the heaviest registered since formation of the stations. *Morning Bulletin*, 6 February, p. 5.

Anon, (1890), Lightning killed a man on Schooner *Martha Reid*. Vessel dismasted and captain severely injured. *Rockhampton Bulletin*, 24, 27 March.

Anon, (1890), The mast and sails of a boat, with blue and white flag attached, found washed ashore at Barwell's Creek, four miles north of Yeppoon, *Morning Bulletin*, 10 January, p. 3.

Gogango Divisional Board, (1890), Lengthsman's wives and families at camp on Rockhampton-Emu Park road near the saltpans were brought to Emu Park on rail trollies after torrential rainfall. Fifteen inches fell in 36 hours at Rockhampton, mostly during an eight-hour period. *Morning Bulletin*, 27 March, p. 5

Harbour Master, Rockhampton, (1890), condemns dangerous condition of the deepwater wharf: 'a mooring pole pulled away to leave a moored barque hanging to only one pole.' Wharf decking was also useless; the barque unloaded 50 tons of galvanised iron and the wharf deck sank almost 12 ins. *Morning Bulletin*, 23 April, p. 5.
