# **Privacy Policy**

This Privacy Policy applies to all personal information collected by Soferio Pty Limited via the web application you are using (or related sites).

## Collection and Purpose

We may collect personal information from you in the course of your website if you input any personal information into the website. In addition, we also collect cookies from your computer, which enables us to tell when you use the website and also to help customise your website experience.

We may use 'cookies' for maintaining contact with a user through a website session. A cookie is a small file supplied by our web server and stored by the web browser software on your computer when you access this site. An explanation of cookies can be found at the site of the Office of the Australian Information Commissioner. Cookies allow us to recognise you as an individual as you move from one of our web pages to another. This information is only used to help you use our website systems more efficiently, not to track your movements through the internet, or to record private information about you.

The purpose for which we collect personal information is to provide you with the best service experience possible on the website. Some provision of personal information is optional. However, if you do not provide us with certain types of personal information, you may be unable to enjoy the full functionality of the website.

#### Disclosure

We customarily disclose personal information only to our technology service providers who assist us in operating the website. We will only disclose personal information to an unrelated third party with your consent.

#### Access and correction

# Security

We have processes in place to fortify the security of your personal information, including encryption of data when it is transferred to our service providers and limitations on access to personal information within our organisation.

### Storage locations

The Site and related data (including your data) are hosted on secured servers maintained by Amazon Inc (the operator of the Amazon AWS service) and Salesforce.com Inc (the operator of the Heroku service).

All PDF documents are all stored in encrypted format on Amazon-hosted secure servers located **only in Australia**. Website text and imagery, website form fields, and tokens are transferred in encrypted form, to and from secure servers in the United States hosted by Heroku.com.

# Acceptable Use Policy
