



ACKNOWLEDGEMENT, RELEASE, WAIVER

Cycling Without Age Singapore ("**Cycling Without Age SG**"), a licensee of Cycling Without Age, conducts programs designed to create extraordinary intergenerational experiences by providing trishaw rides for elders driven by trained volunteers.

In consideration for being permitted by Cycling Without Age SG to be a pilot or a passenger in a cycle trishaw:-

- I acknowledge that before becoming a cycle trishaw pilot or passenger in connection with Cycling Without Age SG, I have been briefed on and am familiar with the policies, rules, regulations, procedures and requirements of Cycling Without Age SG.
- I will adhere to the policies, rules, regulations, procedures and requirements of Cycling Without Age SG, as well as all applicable governmental laws, rules, regulations, and ordinances. If I am a pilot, I also acknowledge that I am or will be trained to drive a cycle trishaw, and will only do so when approved for such by Cycling Without Age SG.
- **I FULLY UNDERSTAND AND AM AWARE THAT THERE ARE RISKS ASSOCIATED WITH BEING A PILOT OR A PASSENGER IN A CYCLE TRISHAW INCLUDING POSSIBLE INJURY, DISABILITY OR DEATH. I AM VOLUNTARILY PARTICIPATING AS A CYCLE TRISHAW PILOT OR PASSENGER WITH FULL KNOWLEDGE OF THESE RISKS AND FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONSIBILITY FOR BODILY INJURY, DISABILITY, DEATH, LOSSES, COSTS OR DAMAGES, WHETHER THOSE RISKS ARE KNOWN OR UNKNOWN, AS A RESULT OF MY PARTICIPATION.**
- To the fullest extent allowed under law, I hereby release, discharge and covenant not to sue, and agree to indemnify, save and hold harmless Cycling Without Age SG and its directors, officers, employees, volunteers, agents, contractors, licensees, and representatives (together, "**Releasees**") from any and all liability, actions, claims, losses or demands that I, together with my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives (together, "**co-Releaseors**") now have, or may have in the future, for injury, death, or property damage, related to (i) my participation in these activities, (ii) the negligence or other acts, whether directly connected to these activities or not, and however caused, by any Releasee, or (iii) the condition of the premises where these activities occur, whether or not I am then participating in the activities. I also agree that I and the co-Releaseors will not make a claim against, sue, or attach the property of any Releasee in connection with any of the matters covered by the foregoing release, and will indemnify, save and hold harmless each of the Releasees from any litigation expense, attorney fees, loss, liability, damage, or costs which any and all of them may incur.

PERSONAL DATA

As part of the program, your personal information (including but not limited to any visual images, photographs and/or videos captured during the program, social media presence and posts) ("**Personal Data**") may be collected, used and disclosed for the following purposes ("**Purposes**"):-

- Marketing and promoting the activities of Cycling Without Age SG through various channels including brochures, social media accounts as well as social media posts and reposts.
- To perform surveys and questionnaires for research and marketing purposes and for purposes related to the grant key performance indicators.
- To send information, updates and corporate information by post, email, text messages or social media about our events or those of third parties that we think may interest you.
- Communication purposes, such as sending out e-bulletins, newsletters, emails, brochures, leaflets, letters and flyers.
- Administer your participation in programs and events.
- Maintenance and upkeep of event participants' records and data.
- Respond to your questions related to the event or what we do.
- Process your payment transactions.
- To send out invitations for present and future Cycling Without Age SG events which may be of interest to you.
- Registration and maintenance of participants' database.

Your Personal Data may be disclosed for any of the Purposes and in accordance with the Personal Data Protection Act to any company related to Cycling Without Age SG (including Cycling Without Age); any agents or service providers providing services to us in relation to the Purposes; any third parties funding any of the Purposes; any third party who is jointly organising an event, activity or program with us; and any third party who is under a duty of confidentiality to keep your Personal Data confidential and who must comply with the PDPA. As the programs necessarily involve interactions between and among various participants (as pilots, passengers, facilitators, volunteers or otherwise), Cycling Without Age SG has no control over and cannot be responsible for the collection, use and disclosure of Personal Data by participants in their personal capacity. Similarly, you shall be respectful of the Personal Data of other participants.

BY TICKING THE CHECKBOXES BELOW AND SIGNING THIS AGREEMENT, YOU:-

- agree to disclose Personal Data about yourself to Cycling Without Age SG and complete any questionnaire in relation to the program;
- acknowledge that you have been informed that Cycling Without Age SG may collect, use, and disclose your Personal Data;
- acknowledge that your Personal Data may be collected, used and disclosed by other participants, which is out of the control of Cycling Without Age SG, and that you will be respectful of the Personal Data of others;
- confirm that you have read our Personal Data Protection Policy and foregoing information; and
- consent to Cycling Without Age SG's collection, use and disclosure of your Personal Data for the Purposes stated in this agreement.**

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS AND HAVE SIGNED IT ON MY OWN FREE WILL WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE. I AM AWARE THAT THIS IS A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE NOTWITHSTANDING SHALL CONTINUE IN FULL FORCE AND EFFECT.

If signed by Parent or Guardian (required for Participants under 18 years of age): I am the parent or guardian of the Participant listed below, and acknowledge and agree that the Participant is participating in this activity with my consent and permission, and that the dangers of the activities and the significance of this Release and Waiver have been explained to the Participant and that the Participant understood them. I hereby release, discharge and covenant not to sue, and agree to indemnify, save and hold harmless the Releasees from any and all liability, actions, claims, losses or demands on my and the Participant's account for injury, death, or property damage, related to (i) my participation in these activities, (ii) the negligence or other acts, whether directly connected to these activities or not, and however caused, by any Releasee, or (iii) the condition of the premises where these activities occur, whether or not I am then participating in the activities. I also agree that will not make a claim against, sue, or attach the property of any Releasee in connection with any of the matters covered by the foregoing release, and will indemnify, save and hold harmless each of the Releasees from any litigation expense, attorney fees, loss, liability, damage, or costs which any and all of them may incur.

For Pilots:-

In consideration for the resources that Cycling Without Age SG will expend in training me to be a cycle trishaw pilot, I agree that I will participate in at least **1 shift per month** as a pilot AND volunteer with Cycling Without Age SG for at least **1 year** from my successful completion of the cycle trishaw pilot training.
