

SUNCORP NETSETGO CENTRE OF THE TERM COMPETITION CONDITIONS

PARTICIPATION

1. This competition ("**Competition**") is conducted by Suncorp Corporate Services Pty Ltd, ABN 66 010 831 722, ("the **Promoter**"), of Level 28 Brisbane Square, 266 George Street, Brisbane, Queensland 4000.
2. All entry instructions and prize information published by the Promoter form part of these conditions. By entering, entrants accept these conditions.
3. The Competition is only open to individuals who: (i) are Australian residents aged 18 years or older at time of entry; and (ii) are not directors, management or employees, or their immediate family members, of the Promoter or its related companies or agencies associated with the Competition; and (iii) is a representative of a Suncorp NetSetGO Centre registered with Netball Australia for the 2018 season ("**Eligible Entrant**").
4. Competition entry commences at 9am on Monday 29th January 2018 and closes at 5pm on Friday 30th November 2018 ("**Entry Period**"). Except as otherwise stated, all times are AEST. Entries for each Centre of the Term close as follows:
 - a) Term 1 – 5th February – 6th April (closes 5pm AEST on the 6th). Winner announced 23rd April
 - a) Term 2 – 23rd April – 6th July (closes 5pm AEST on the 6th). Winner announced 23rd July.
 - b) Term 3 – 23rd July – 21st September (closes 5pm AEST on the 21st). Winner announced 8th October.
 - c) Term 4 – 8th October - 30th November (closes 5pm AEST on the 30th)
Winner announced 14th December.

ENTRY

5. To enter the Competition, an Eligible Entrant must, during the Entry Period: visit <https://netsetgo.asn.au/centre-of-the-term>, complete the online entry form and answer in 150 words or less how your club demonstrates the values of the Suncorp NetSetGO program. Any supporting materials, including photos, videos or other documents, must be uploaded and submitted at the time of entry. Any such materials are submitted with the permission (or parental/guardian permission) of those featured in the videos or photos or mentioned in the documents. Any personal information provided when submitting an Entry will be collected in accordance with our NSG Centre of the Term Privacy Statement and [Suncorp Group Privacy Policy](#). 6. Limit of one entry per Eligible Entrant, per school term. Any subsequent entry from the same Eligible Entrant after the first valid entry is received will be deemed invalid.
7. Entries must be received by the Promoter during the Entry Period. Entries will be deemed received at the time that the Promoter is satisfied that all necessary requirements under condition 5 have been met and not at the time of submission by the Eligible Entrant. The Promoter takes no responsibility for late, lost, incomplete, incorrectly submitted, illegible or misdirected entries or delays or failures in any equipment or telecommunications service used to administer this Competition.
8. Cost of entry via the internet is free, but internet connection and usage rates may apply. Eligible Entrants should obtain details of such costs from their service

providers.

9. Eligible Entrants must submit their internet entry manually. The Promoter may reject internet entries if it reasonably forms the opinion that they have been entered using automated entry means or by use of a competition entry service.
10. Eligible Entrants must create their own entry and only submit an entry in their own name. Entries that are found to have been derived from third party work will be considered invalid and, if awarded a prize, the prize must be returned to the Promoter. Each Eligible Entrant indemnifies the Promoter and its associated companies and agents for any claims, costs, expenses, penalties or damages they incur from reproducing, publishing or otherwise using any works subsequently found to have been derived in any way from any third party works.
11. Each Eligible Entrant warrants and agrees that:
 - a. they have created the entry themselves;
 - b. they are entitled to reproduce and exploit all underlying works in the entry;
 - c. the entry does not, and use or exploitation of the entry by the Promoter (and each of its assignees and licensees) as contemplated by these conditions will not, violate the rights (including copyright and privacy) of any third person;
 - d. the entry has not been previously published in any other medium or forum worldwide;
 - e. they will not submit material that is unlawful, obscene, defamatory, derogatory, abusive, harmful to any person or entity, or otherwise inappropriate or offensive;
 - f. all supporting material submitted by them, such as photographs and video have only been submitted with the permission and consent (or parent/guardian permission and consent) of the person(s) featured in those photos and videos; and
 - g. they have not granted rights to their entry to any other person which is inconsistent with the rights granted to the Promoter under these conditions.
12. Each Eligible Entrant acknowledges and agrees that the Promoter (and each of its assignees and licensees) has the right, in its absolute discretion, to edit, amend, copy, reproduce, use, publish, broadcast and communicate to the public, the entry (including any supporting material submitted by the entrant) in any media including television and the internet, without any further consultation, reference, payment or other compensation. Each Eligible Entrant also agrees that they will not make any claim against the Promoter (or its assignees and licensees) arising from the exercise of these rights, including claims in relation to any moral rights that they may otherwise have.
13. The Promoter may, in its absolute discretion, declare an entry invalid or disqualify any entrant that tampers with the entry process or benefits from such tampering, submits an entry that is incomplete or not in accordance with these conditions, or otherwise acts in a manner that is disruptive, dishonest or calculated to jeopardise the fair and proper conduct of this Competition.
14. The Promoter reserves the right to require an entrant to verify the validity of their entry within the requested time, including but not limited to an entrant's identity, eligibility, age and address and to disqualify any entrant who does not satisfy any entry criteria in these conditions. Errors and omissions may be accepted at the Promoter's discretion. Proof considered suitable for verification is at the Promoter's discretion.

JUDGING AND PRIZE(S)

15. This Competition is a game of skill and chance plays no part in determining the winner(s).
16. The best Entry submitted during each school term of the Competition Period will be selected as the relevant Prize Winner for that term based on the criteria described in clause 5 above. There are four Prizes to be won in total over the Competition Period.
17. Competition judging for each Prize will take place within 14 days of the end of the relevant term set out in condition 4. All valid entries received during the Entry Period will be judged by the Promoter's judging panel based on originality, creativity and ability to convey worthiness for the Entrant to win.
18. The winner of the relevant term set out in condition 4 will receive a visit and netball clinic for 30 participants facilitated by a former Australian Diamonds netball player such as Clare McMenemy and at least one Suncorp Super Netball player valued at \$3,000 AUD including GST depending on number of clinic participants (up to 30 per clinic) and travel costs for ambassadors to attend each clinic. Date and time of clinic is to be a mutually convenient time for the Winner and the Promoter.
19. The total prize pool is valued at up to \$12,000 AUD including GST depending on number of clinic participants (up to 30 per clinic) and travel costs for ambassadors to attend each clinic. A prize value is the recommended retail value as provided by the relevant supplier(s). The Promoter takes no responsibility for any variation in a prize's value due to exchange rate changes or otherwise.
20. Any additional costs not expressly stated, but which may be incurred in acceptance and use of a prize, are the responsibility of the winner. This includes but is not limited to additional equipment requirements for NetSetGO participants to take part in the clinics, resources required to supervise children, travel costs for participants and their guardians.
21. No compensation will be payable if a winner is unable to take any element of a prize as stated, or does not satisfy any conditions of use for any element of the prize (including conditions imposed by event organisers or staff, or other prize providers, such as health, behavior, age and safety requirements), for whatever reason. Any part of a prize that is not taken for any reason is forfeited and no compensation will be provided.
22. If a prize (or part of a prize) is unavailable for any reason, the Promoter may, in its absolute discretion, substitute alternative goods or services of equal or higher value. The Promoter accepts no other liability or responsibility for any loss incurred by a winner or any other party if a prize (or part of prize) is unavailable for any reason.
23. Other than as expressly stated in these conditions, a prize is non-transferable, non-refundable, non-exchangeable, non-replaceable, and non-redeemable for another prize including cash, except at the Promoter's discretion.

PRIZE WINNER(S)

24. The winner(s) will be notified by a phone call and email using the details provided in their entry within 2 business days of judging of the winner. The name of the winner(s) will also be published at www.teamgirls.com.au
25. The prize notification will include instructions as to how the winner is to claim their prize.

26. The prize(s) will only be awarded following any winner validation and verification that the Promoter requires in its sole discretion.
27. If: (i) a prize is not claimed by a winner or the Promoter has been unable (despite reasonable efforts) to successfully contact the winner; or (ii) a winner is determined by the Promoter to be ineligible to win a prize in accordance with these conditions, the relevant prize will be forfeited and instead awarded to the Eligible Entrant judged to have the next best entry in accordance with the criteria set out in condition 15. Any resulting winner(s) will be notified by a phone call and email using the details provided in their entry within 2 business days of judging of the winner. That process will be repeated if required.

GENERAL

28. If for any reason this Competition is not capable of running as planned, or is interfered with or disrupted in any way (including by vandalism, power failures, natural disasters, acts of God, weather event, civil unrest, strikes, computer bugs or viruses, tampering or technical failures), the Promoter reserves the right to cancel, terminate, modify or suspend the Competition, or invalidate any affected entries.
29. The Promoter assumes no responsibility for: (i) any error, omission, interruption, or delay in the operation or transmission of any communication sent to (or by) the Promoter or any entrant whether caused by problems with communication networks or lines, computer systems, software or internet service providers, congestion on any carrier network or otherwise; (ii) any theft, destruction or unauthorised access to, or alteration of such communications; (iii) any problem with, or technical malfunction of, any computer system or other equipment used for the conduct of the Competition; (iv) any incorrect or incomplete information which may be communicated in the course of the administering this Competition (whether as a result of one of the foregoing causes or otherwise); or (v) any delay in delivery (when not directly caused by the Promoter or its supplier), or failure of safe delivery of a prize.
30. All of the Promoter's decisions in relation to all aspects of this Competition are final and no correspondence will be entered into. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
31. A winner accepts a prize at their own risk. Any tax liability arising as a result of accepting a prize is the responsibility of the winner. Independent financial advice should be sought.
32. To the full extent permitted by law, the Promoter, its associated companies and agencies and any of their personnel (the "**Relevant Parties**") exclude all liability for any loss (including any damage, claim, injury, cost or expense) which is suffered or incurred by any Eligible Entrant in connection with the Competition or a prize, including without limitation: (i) any indirect, special, economic or consequential loss; (ii) any loss arising from the negligence of a Relevant Party; and (iii) any liability for personal injury or death. To the extent that such liability cannot be excluded by law, it is limited to the minimum allowable by law. The Promoter may request that a winner signs and returns a deed of release to this effect as a condition of a prize being awarded. If a winner fails to sign and return such release, they may forfeit the prize.
33. The winner(s) must, at the Promoter's request, participate in all promotional activity (such as publicity and photography) surrounding winning a prize, free of charge, and consent to the Promoter using their name, likeness, image and/or voice (including any photograph, film and/or recording of them) in promotional material in any media

at any time without notification or compensation, financial or otherwise.

PRIVACY STATEMENT AND MARKETING CONSENT

34. Entrants' personal information is collected from entrants by or on behalf of the Promoter to enable the Promoter and its agents to manage, administer and promote the Competition and, where applicable, publicise the winner(s). The personal information may also be provided to persons assisting the Promoter, including prize suppliers and deliverers, marketing agencies and IT providers, media outlets and related companies. The winner's name will also be published at www.teamgirls.com.au. By participating in the Competition, Eligible Entrants consent to these uses and disclosures of their personal information.
35. If an Eligible Entrant does not provide the personal information the Promoter requests, the Promoter may not be able to enter them into the Competition. All personal information is handled in accordance with these conditions and the Promoter's Privacy Policy.
