

## Terms and Conditions

1. The promoter is Netball Australia (ABN 66 003 142 818) of 191 Johnston Street, Fitzroy, Victoria, 3065 (Promoter).
2. Entry into the Suncorp NetSetGO at Home competition is deemed acceptance of these Terms and Conditions (Terms).
3. Entry is open to parents of all Suncorp NetSetGO participants (Entrant) except:
  - a. Employees of the Promoter and their immediate family members;
  - b. Persons who have breached the Terms of any promotion run by or on behalf of the Promoter (Entrants).
4. The Promotion commences on 26 October 2018 at 12:00 pm (AEDT) and concludes on 16 November 2018 at 11:59 pm (AEDT) (Promotion Period).
5. Winner will be notified through direct message or private message by the weekend ending Friday 23<sup>rd</sup> of November 2018.

## How to Enter

17. All entries become the property of the Promoter. By entering the Promotion, Entrants grant the Promoter a royalty free, perpetual, non-exclusive, irrevocable licence to keep, store, reproduce, publish all or part of their entry.
18. Entrants acknowledge and agree that:

22. To the full extent permitted by law, the Promoter is not liable for any injury, damages, expenses or loss whatsoever (including but not limited to indirect or consequential loss) to persons or property arising in any way out of the Promotion.
23. Each Entrant indemnifies and keeps indemnified the Promoter against all claims, losses or damages and expenses suffered by the Promoter or any third parties arising out of the breach of these Terms, the conduct of the Entrant in relation to the Promotion, or use of the Prize.
