

CALHN TRAVEL ALERT for OPD/Pre-admissions*

Working draft V16
7/7/2020

Ask the patient each of the 7 questions

Have / are you:

1. Travelled overseas in the last 14 days
2. Been a passenger or crew on a cruise ship in the last 14 days
3. Travelled interstate where South Australia has "restricted borders" in the last 14 days
4. Currently in home isolation for suspected / probable / confirmed coronavirus
5. Been exposed to or advised you are a close or casual contact with a confirmed, probable or suspected case
6. People from (lived in or travelled through) a geographically localised area with elevated risk of community transmission (as defined by public health authorities / [SA Health public health alert](#))
7. Healthcare worker / aged or residential care worker with epidemiological COVID-19 risk eg looked after COVID-19 patients

NO to all questions

If patient is asymptomatic, manage patient as per usual processes.

If admitting follow **CALHN Inpatient COVID-19 flow chart** which provides additional criteria for isolation.

Staff PPE as per [SA Health PPE Matrix](#)

If patient is symptomatic arrange for Dr to assess patient for signs / symptoms compatible with COVID-19. If compatible illness then ask patient to put on a surgical mask AND follow flowchart to arrange testing.

YES to any question
Ask patient to put on a surgical mask AND
Immediately advise clinical staff (nurse or doctor)

Clinical staff to identify signs/symptoms:

- Fever / history of fever **OR**
 - Acute respiratory infection (shortness of breath, cough, sore throat) **OR**
 - Acute unexplained loss of smell or altered sense of taste **OR**
 - Persons with new onset of clinical symptoms* compatible with COVID-19
- *Other clinical symptoms: Fatigue, headache, runny nose, muscle pain, joint pain, diarrhoea, nausea/vomiting, loss of appetite.

YES

1. Call:

- If the hospital site has a COVID-19 clinic activated then mildly unwell patients may be escorted to the clinic. Advise clinic staff : RAH COVID-19 clinic ph 7074 2997. 0900 hrs – 2000 hrs, 7 days per wk.
- Otherwise, contact Emergency Department (ED) RAH: 43177 / QEH: 27101 and advise that you are escorting patient to ED for assessment.
- Infection Prevention Control Unit (SD 81327 or 0421899376) with patient name and UR number (if after hours leave a message)
- If OPD department is not onsite at RAH or QEH, consider sending the patient to the nearest [COVID-19 clinic](#) or phone SA Health CDCB 1300 232 272

2. Patient to continue to wear a surgical mask

- 3. **Staff to don PPE:** Surgical mask and protective eyewear/face shield, long sleeved gowns and gloves.

- 4. **Transport patient to the COVID-19 clinic / ED.** If there is a delay: isolate patient in a single room with door closed. If not available seat patient at least two metres away

- Discuss with OPD / clinic medical officer so a risk assessment can be undertaken re appointment / procedure. Non-urgent appointments should be rescheduled.

- Patient to continue to wear surgical mask

For patients requiring [self-isolation / quarantine](#), ask them to arrange private transport home. If private transport is not available then follow [Australian Government advice](#).

If delay: isolate patient in a single room or if not available seat patient at least two metres away from others.

If requires admission unrelated to coronavirus, follow ED / inpatient COVID-19 flow chart which provides additional criteria for isolation
