Consideration of Relocation of Te Kura Kaupapa Māori o Te Whānau Tahi (1618) or Te Kura Kaupapa Māori o Waitaha (4212):

Feedback from Consultation

Executive Summary

- 1. This paper seeks your decision on the proposed relocation of Te Kura Kaupapa Māori o Te Whānau Tahi or Te Kura Kaupapa Māori o Waitaha to the north or north-west of the greater Christchurch area.
- 2. On 13 September 2012, you announced a number of proposals for changes to schooling in greater Christchurch including the proposal to merge Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha.
- 3. The proposal was based on the low roll at each kura, surplus capacity and the relatively high cost of remediation of buildings for weather tightness. Te Kura Kaupapa Māori o Te Whānau Tahi had a 1 July 2012 roll of 72 and a 1 March 2013 provisional roll of 83, and Te Kura Kaupapa Māori o Waitaha had a 1 July 2012 roll of 81 and a 1 March 2013 provisional roll of 76.
- 4. In January 2013, the Ministry of Education reported to you on the results of the consultation undertaken by the Boards of each kura with its community about both proposals to merge the two schools. Two reports (Metis 742257 and Metis 745275) were provided and both are attached for your information (Appendix One).
- 5. After consideration of the Boards' responses together with information on the location of Māori children in greater Christchurch, you decided to withdraw the proposal to merge the kura.
- 6. Demographic analysis shows that there are a large number of Māori children in Christchurch who do not have access to kura. After considering this information you decided this gap could best be filled in the short to medium term by relocating one of the existing kura. Accordingly you asked both Boards to consider which of them would be relocated to a different part of the city and receive a purpose-built new school.
- 7. This interim decision was made on the basis that the intention was always to strengthen Māori medium provision and in the knowledge that the Ministry was working with the Waitaha Advisory Board, the Māori Medium Cluster and providers of all forms of Māori medium education, to develop a strategy, plan and models for provision across the whole of the greater Christchurch area.
- 8. This was announced on 18 February 2013 and you gave the Boards until 28 March to respond to the proposal.
- 9. The Boards used a facilitator to discuss the proposal with the kura whānau and each Board then submitted its own response. These were forwarded to you on 3 April.

- 10. Neither kura supports the proposal. Both Boards consider that the proposal does not acknowledge the cultural link of the kura to its whānau and its site stating there is historical and cultural significance for the current sites.
- 11. The Board of Te Kura Kaupapa Māori o Te Whānau Tahi considers that should the kura relocate it would impact on student achievement. It also considered that the relocation would negatively impact on Te Reo Māori revitalisation.
- 12. As well as raising these concerns, the submission includes options that were raised by whānau to strengthen access to Māori medium provision across the city. These include establishing satellites or new kura, or having units in mainstream schools or independently situated but supported by kura. Support could be at the governance level and classroom teaching, as satellite students could engage with the 'tuakana' kura site.
- 13. In addition, the submission from the Board of Te Kura Kaupapa Māori o Te Whānau Tahi states that, as Te Kura Kaupapa Māori, it stands alongside Te Kura Kaupapa Māori o Waitaha rather than in competition to it. Both kura have considered that the process to determine which kura should be relocated has been divisive. It is noted that the Treaty of Waitangi recognises that the Government should not undermine relationships between Māori organisations. It is acknowledged that the intention of the proposal was to strengthen Māori medium provision, as outlined below.
- 14. The Board of Te Kura Kaupapa Māori o Waitaha held hui, submitted a petition (46 signatories) and undertook a survey of families in the Parklands, Aranui and Mairehau suburbs to gauge the number of young people in those communities that:
 - are interested in immersion / bilingual education
 - have a level of Te Reo that would support them to learn in an immersion
 Te Kura Kaupapa Māori environment.
- 15. The Board of Te Kura Kaupapa Māori o Waitaha rejects the proposal to relocate and considered that the proposal does not consider the cultural aspects of the kura and its relationships with the community, its kōhanga reo and its site.
- 16. After considering its survey feedback, the Board does not believe that there is an access problem for young people wanting immersion education (very few of those in the survey had high enough levels of te reo to be enrolled at the kura). It states that relocation is a costly option and would impact on the transition from kōhanga to kura.
- 17. The Board also states that the proposal continues to be in breach of a number of the Government's obligations including of the Treaty of Waitangi.
- 18. The Ministry's view is that given the strong argument from both Boards outlining the importance of the setting and context of each kura, and the acknowledgement that kura are established by whānau and grow within the community, that you agree that both kura be retained on their current sites.

- 19. The implication of this decision is that the design of the strategy and plan for provision of all forms of Māori medium education across greater Christchurch must ensure it factors in provision for the north and west of the Christchurch area. This work will also factor in other known interests such as Te Pā o Rākaihautū, which was supported by Minister Tolley when she asked the Ministry continue discussion with the applicant group, and Tai Wananga, which while expressing interest, has not generated a proposal as yet. It is also noted that should you proceed with the development of the proposed Aranui Campus, this will provide significant opportunity to include Māori medium, including immersion education.
- 20. The opportunity to improve access to Māori medium education for Māori children is only temporarily affected by not progressing with the relocation of one of the kura. The Ministry does not consider in the light of discussions occurring about the wider strategy that there will be any medium or long term loss from this decision. The work remains on track to strengthen Māori medium education and will be sped up to ensure it is driven in a timely manner.
- 21. The indicative property costs to repair the kura on their current sites are \$1.55 million for repairs at Te Kura Kaupapa Māori o Te Whānau Tahi, and \$0.32 million for repairs at Te Kura Kaupapa Māori o Waitaha.

Recommended Actions

We recommend that you:

- a. **note** the information provided about the responses to the consultation by the Boards and whānau with their communities about the proposed relocation of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha;
- b. **agree** that Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha will be retained on their current sites;

AGREE / DISAGREE

- c. **note** that while this decision means that a short term opportunity to provide greater access to Māori immersion education to children in the north and west of the greater Christchurch area will be lost, it will not affect the medium and long term planning and implementation;
- d. **note** that the strategy being developed for the greater Christchurch area on the current provision, demand and opportunity for long term investment in Māori medium provision is progressing well and will now be sped up;
- e. **sign** the attached letters to the Boards of Trustees and whānau of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha, Te Rūnanga o Ngāi Tahu, Te Rūnanga Nui o Ngā Kura Kaupapa Māori o Aotearoa and the local Members of Parliament, advising them of your decision; and
- f. agree that a copy of this report be released to the Boards of Trustees and whānau of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha.

Education Report:

Consideration of Relocation of Te Kura Kaupapa Māori o Te Whānau Tahi (1618) or Te Kura Kaupapa Māori o Waitaha (4212): Feedback from Consultation

Purpose

1. This report provides you with information about the responses to the consultation by the Boards of Trustees and whānau of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha on the proposal to relocate one of the kura to another site in the city.

Background

- 2. Te Kura Kaupapa Māori o Te Whānau Tahi is a decile 3, Year 1-13 composite school in the Wigram electorate. The July 2012 roll was 72 and the 1 March 2013 provisional roll was 83, 100% of whom were Māori.
- 3. Te Kura Kaupapa Māori o Waitaha is a decile 2, Year 1-13 composite school in the Port Hills electorate. The July 2012 roll was 81 and the 1 March 2013 provisional roll was 76, 100% of whom were Māori.
- 4. Both kura were established under section 155 of the Education Act 1989 (the Act). This means that they both operate under the philosophy of Te Aho Matua.
- 5. On 13 September 2012 you announced the proposed merger of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha as part of the Greater Christchurch Education Renewal Plan Programme Interim Business Case.
- 6. On 28 September 2012 you wrote to the Boards of Trustees and whānau of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha and initiated consultation on the possible merger of the two kura on a site yet to be determined. That consultation period ended on 7 December 2012.
- 7. On 18 February 2013 you announced that, after considering the feedback from the Boards and whānau of both kura, you had decided not to merge the kura. You did however ask the Boards to consider which of the kura should be relocated to another part of the city in order to improve access to immersion Māori medium education across Christchurch.
- 8. This consultation period ended on 28 March 2013. The Boards used a facilitator to discuss the proposal with kura whānau and each Board submitted a separate response. The Boards' submissions were forwarded to you on 3 April 2013.

Reasons for considering the Possible Relocation

- 9. The Ministry's intention has always been to strengthen all levels of Māori medium provision in the greater Christchurch area. There are over 8,000 Māori children in the area and the Māori immersion education options for them at this time are limited. While work is being done to identify the optimal range, type and volume of Māori medium provision, the Ministry sought, as part of the recommendations, to provide Māori immersion education in the north or west of Christchurch. The most efficient way to do this was to propose the relocation of one of the existing kura. This would result in one of the kura being able to operate from a purpose-built new school.
- 10. The Ministry's view was that relocation should be tested with the Boards and whānau of the two kura as it was believed that this was an attractive option to provide greater access to immersion education in a short timeframe while the overall strategy is being developed. The Ministry also considered that the option provided an opportunity for a purpose built new school for the relocated kura.

School-aged Māori young people in Christchurch

- 11. For the 80 addresses of young people enrolled at Te Kura Kaupapa Māori o Waitaha (from its 1 July 2012 roll return):
 - they lived an average of 6.2 kilometres from the school site
 - seven young people lived at addresses between 24 and just over 33 kilometres from the school site.

The majority of children and young people enrolled at the kura live in Linwood and Aranui, in the east of Christchurch.

- 12. For the 70 addresses of young people enrolled at Te Kura Kaupapa Māori o Te Whānau Tahi (from its 1 July 2012 roll return):
 - they lived an average of 3.8 kilometres from the school site
 - all young people lived less than 12.12 kilometres from the school site.

The majority of children and young people enrolled at the kura live in Cashmere and Hornby, in the south west of Christchurch.

- 13. The July 2012 data for Māori school-aged young people not attending Māori medium education (by Census Area Unit) shows that:
 - 512 live in Papanui, Roydvale and Burnside
 - 350 live in Parklands
 - 535 live in Aranui
 - 253 live in Mairehau

Note these are areas that neither kura are located within.

Māori medium provision at July 2012

- 14. From the 1 July 2012 roll data the Ministry has identified that 459 young people across Christchurch were involved in Māori Medium provision. Of these:
 - 226 were learning at Level 1 immersion (81-100% of time teaching / learning was in te reo Māori). This included the children / young people enrolled in both kura.
 - 233 were learning at Level 2 immersion (51-80% of teaching / learning was in te reo Māori).
- 15. As well as the two kura, there are three primary schools that offer Level 1 immersion. There are six primary schools, Unlimited Paenga Tawhiti and Halswell Residential School (a special school) that offer Level 2 immersion.¹

Consultation Feedback

16. Both kura discussed the merger proposal and responded separately to it.

Te Kura Kaupapa Māori o Waitaha

- 17. The Board does not support the proposal that its kura is relocated. It held a hui to discuss the proposal and provided feedback which includes:
 - The proposal does not take into consideration the cultural aspects of the kura (loss of tūrangawaewae and the various relationships the kura has developed over time).
 - No data to show there is an access problem that needs to be solved by the relocation of one of the kura. This kura provides transport as far afield as Rangiora to the north.
 - Costly option and will meet the needs of about 2-4% of Māori. Other options may be more cost efficient.
 - Proposal appears to be trying to address a gap in transition from intermediate level to secondary total immersion education.
 - Relocation would move wharekura from their k\u00f6hanga reo. It would have an impact on children transitioning to school from k\u00f6hanga.
 - Concern that the proposal indicates that a decision has already been made that one of the kura must move (i.e. the consultation process is flawed).
 - Proposal continues to be in breach of the Treaty of Waitangi, United Nations Declaration on the Rights of Indigenous Peoples and the intention of Te Aho Matua as it potentially undermines the relationship between the two kura.

¹ Unlimited Paenga Tawhiti also offered Level 2 immersion in 2012 (there were a small number of students with a high level of language provision). The school does not currently provide a Level 2 language programme.

- 18. The kura submission also included that:
 - Relocation fails to acknowledge that each kura is intrinsically linked to the land - kura whānau and whenua. Relocation is seen as closure of one kura and opening of another, as it would be quite different in another location.
 - After investigating distances between the six k\u00f6hanga reo in Christchurch and kura it considers that young people enrolled at them would, in general, need to travel further to the kura if one was relocated to Parklands or Aranui².
- 19. The Board of the kura also undertook a survey of 50 families in each of the eastern suburbs of Parklands, Aranui and Mairehau, asking their preference for bilingual or total immersion education and their current level of te reo.
- 20. This survey showed that few young people of the families surveyed would have the level of te reo to be enrolled at an immersion kura (4/80 school aged children within the survey sample in Aranui, and 5 /53 in Mairehau. There were none in Parklands). Details of the outcome of the survey are attached as Appendix Three.
- 21. The third part of the kura submission was a petition signed by 46 people stating that they do not support the relocation of either of the kura.

Te Kura Kaupapa Māori o Te Whānau Tahi

- 22. The Board similarly rejects the proposal that its kura is relocated. It held two Board / whānau hui to discuss the proposal and provided feedback on the reasons it considers the proposal should not be implemented which includes:
 - It would remove choice for whānau who have selected the kura because of educational preferences and ties, but who would not be able to attend if the kura was relocated elsewhere.
 - The historical and cultural significance of the current site.
 - The educationally beneficial relationships the kura has established with its local community would be lost if it was to be relocated.
 - Whānau have purchased and rented houses close to current site so that tamariki do not have far to travel.
 - If it did relocate, there would potentially be a negative impact on student achievement and Te Reo Māori revitalisation.

Other key messages that the kura provided are:

• Both kura in Christchurch are Te Kura Kaupapa Māori so both stand alongside each other and are not in competition with each other.

² This suggests that the Ministry would not consider the relocation of kōhanga reo as well as kura, which is not the case.

Access to Māori Medium (TKKM) could be improved by:

- having more applications to establish TKKM
- the establishment of a new TKKM or satellites of current kura
- having units attached to mainstream schools
- dedicated transport options for young people in areas so they can go to either of the kura from western Christchurch (Rolleston, Hornby and Halswell)
- the Ministry investing more in kōhanga reo so there is sustainability for Te Kura Kaupapa Māori in Christchurch.
- 23. Apart from the Board's submissions, you did not receive any other correspondence about the relocation proposal.

Ministry Comment

- 24. The Ministry acknowledges the responses from both kura and the support of Te Rūnanga Nui o Ngā Kura Kaupapa Māori o Aotearoa in the consultation process.
- 25. Feedback from the kura show they have both soundly rejected the proposed relocation. This is because, to be successful, kura that work under Te Aho Matua must be positive about the community they are located in and must engage the kura whānau in the effective running of the kura, to a greater extent than other kura and English medium schools.
- 26. In addition, while many schools serve the education needs of their local community, children enrolled in kura kaupapa Māori generally enrol at kura where they have a particular affiliation or association. In this respect, while the work on Māori medium provision has established that there are a large number of Māori children without access to Māori immersion education, within the current timeframe the Ministry has been unable to establish actual demand for the options within the full range of different levels of te reo provision.
- 27. The Board of Te Kura Kaupapa Māori o Waitaha raised a concern about travel distances should one of the kura relocate. The Ministry also undertook an analysis of the young people enrolled at the kura to consider the distance they travelled (Appendix Two). It shows that approximately 6% of students attending Te Kura Kaupapa Māori o Waitaha reside within 3 kilometres of the kura and therefore 94% of its tamariki already travel considerable distances to attend the kura (refer to Appendix Two).
- 28. Unlike English medium state schools it is acknowledged that enrolment at a kura is often based on the desire to support Māori language and culture within a particular kaupapa. Kura may grow within a community which has particular relationships with its land and community, and so the benefits of a relocation of a kura must be considered alongside the current and future community of that kura, and its relationship with the current and proposed sites. As described by one submission, in this situation the relocation of the kura would be the same as closing it and reopening another kura on the other site. Its development would begin again. The Ministry does not consider this an unsurmountable issue if one of the kura had been positive about the opportunities relocation offered. However the Ministry acknowledges this issue cannot be managed in circumstances where neither kura want to relocate.

- 29. Given this situation, it is recommended that the two kura are retained on their current sites and the current process underway to develop the strategy for Māori medium provision be completed as a priority.
- 30. Refer to Appendix Four for Ministry comment about the information provided by Te Kura Kaupapa Māori o Te Whānau Tahi about the ways its whānau consider that access to Māori medium provision could be improved. These suggestions and the Ministry's responses to them will be forwarded to the Waitaha Advisory Board.

Waitangi Tribunal

- 31. The Waitangi Tribunal and the Courts have found that active protection of the Māori language is a Government responsibility under the Treaty of Waitangi. This means that due care must be taken to when a Minister exercises network powers which impact upon the provision of education in te reo Māori (e.g. closure or merger of a kura).
- 32. The Ministry recognises the views of those consulted that the relocation of either kura could result in the kura having to rebuild its relationships with its whānau and community. This in turn could have a negative impact on the wellbeing of young people and inhibit efforts to revitalise and grow Māori language, culture and traditions at the kura.
- 33. Should the relocation eventuate the Ministry would work with the Board and community to mitigate this situation.
- 34. It is also noted that the proposal to relocate one of the kura was made in order to strengthen Māori medium provision across the city rather than undermine the relationship between the kura. The Waitangi Tribunal has stated that Government should not damage relationships between Māori organisations.

Property

35. An indicative cost to retain both kura on their current sites and repair their property is as follows:

- 36. For more details of these property costings refer to Appendix One (Metis 742257).
- 37. The Te Kōhanga Reo National Trust has requested that Oterepo Te Kōhanga Reo is permanently relocated to the Kura Kaupapa site at Hassalls Lane, Opawa. Prior to the announcement regarding a possible merger of the two Kura, a suitable piece of land with access and adequate space for parking was identified, and approval in principle for the issuing of a lease for land was given. In early 2012, Te Kōhanga Reo National Trust was awarded \$458,000 in Targeted Assistance for Participation funding to build a new facility for the Oterepo Te Kōhanga Reo on the Te Kura Kaupapa Māori O Waitaha site. This project has been put on hold until a decision is made regarding the proposal to merge / relocate the two Kura, and the funding will remain available for establishing a permanent building for Oterepo Te Kōhanga Reo.
- Providing Oterepo with a permanent lease of land meets the outcomes in the Early Learning Foundations section of the Shaping Education Renewal programme in greater Christchurch: ensuring that the identity, language, and cultures of young people continue to be valued and supported by working with Te Köhanga Reo National Trust to secure and strengthen the role of Köhanga Reo. This also supports the retention of 21 Te Köhanga Reo spaces plus the creation of a further 19 spaces to further increase participation for Māori tamariki.

Future Māori Medium Education Provision in Christchurch

- 39. The Ministry in conjunction with the Waitaha Advisory Board, the Māori medium cluster and Māori education providers are developing a strategy for Christchurch and this will include the current and is proposing location / access of kōhanga reo and immersion / bilingual schooling. This will be used to ensure that suitable pathways for young people learning in te reo are available at all year levels.
- 40. The Waitaha Advisory Board and The Māori Medium Community Cluster have committed to the development of the following principles:

The Waitaha Advisory Board

- the enhanced provision of quality teaching and te reo Māori at all levels,
 and oppose any decrease in current provision
- the right of access to, and choice of, local full immersion te reo Māori education
- the least number of transition points for young people moving from early childhood services to compulsory schooling or between schools, in order to mitigate the risk of student disengagement from learning
- the need for 21st century learning environments that include teaching and learning, and physical environments, that are responsive to Māori to ensure all young people are supported in the best possible way.

The Māori Medium Community Cluster

- the need for multiple access points into Māori medium education of various forms and of varying levels across the city
- that quality Māori Medium education is defined in line with a kaupapa Māori framework
- the strong focus on the protection of te reo Māori and revitalisation efforts in Christchurch
- the requirement for meaningful consultation with the Māori Medium community to inform decisions that impact on young people and may result in the reduction of provision
- the demand for high quality teaching and learning, and resources from both the Ministry and Ngāi Tahu, both for current provision and additional future options.

Te Pā o Rākaihautū

- 41. The Ministry has received an application for the establishment of a designated character school called Te Pā o Rākaihautū (Te Pā). It is proposed that this would be Year 1-13 English Medium schooling (and eventually link with early childhood education and tertiary provision). The school is proposed to be a learning village with people of all ages interacting in a Māori environment. Identity as Māori will be central to the curriculum.
- 42. Initial agreement that the proposal should be further developed was given by Hon Anne Tolley (former Minister of Education) in late 2011 and it was also agreed that the Ministry would continue to engage with the applicant group and that the proposal would be included in the future network planning for the greater Christchurch area.
- 43. Hon Pita Sharples (Associate Minister of Education) has now agreed to the required consultation being undertaken for the establishment of the school. Letters will be sent to Boards after the school holidays. No site has yet been identified for the school.

Tai Wānanga

- 44. The Board of Tai Wānanga (a designated character school with two campuses one in Hamilton and the other in Palmerston North), has also indicated interest in developing a campus of its school in Christchurch. If this was approved it would offer Year 9-13 schooling in English within a Māori context and using Māori philosophy. There is currently no firm proposal.
- 45. While neither of these new schools provide immersion / bilingual education they can be seen as part of the continuum of support for Māori identity, language and culture. The Ministry is unsure of the impact that Te Pā and Tai Wānanga could have on the rolls of the kura and other immersion / bilingual provision in Christchurch.


Conclusion and Next Steps

- 46. The Ministry's recommendation is that Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha should be retained on their current sites.
- 47. The Ministry's focus will continue to be on working with all parties, facilitating the development of Māori medium Strategy and Plan, and report back to you on its development in July 2013. The Waitaha Advisory Board together with the Māori Medium Cluster has been tasked with leading the development of the strategy and working with existing providers of all forms of Māori Medium provision together with all parts of the system, drawing in kōhanga and giving consideration of the work the secondary cluster principals are doing in this area. This work also draws on the planning being done currently each of the 39 geographical clusters. It is also likely that decisions being considered on the network, for example the Aranui Campus proposal, will provide the opportunity for the community to consider Māori immersion education as an integral part of the campus.
- 48. This recommendation takes into consideration that:
 - both kura have been established on their current sites, and consider their whānau, tamariki and whenua to be central to the culture of the kura
 - whānau enrol their children at kura because of the links they have to its culture. In this way kura, unlike English Medium schools which can successfully be relocated, are grown from the ground up and for the two in Christchurch they 'belong' on their current sites.
- 49. If after considering the information in this report you agree that the relocation should not proceed, the Ministry will develop letters to the Boards of Trustees, Te Rūnanga o Ngāi Tahu, Te Rūnanga Nui o Ngā Kura Kaupapa Māori o Aotearoa and the local Members of Parliament for your signature.
- 50. If you decide to retain the kura on their current sites the Ministry will meet with the Boards to provide any support that is needed. This will include working with them to ensure that the relevant property planning for the repairs to the kura are progressed as part of the capital works programme for greater Christchurch.
- Once your decision has been made, the Ministry recommends that a copy of this report be released to the Boards of Trustees and whānau of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha.

Education Report:

Proposed Merger of Te Kura Kaupapa Māori o Te Whānau Tahi (1618) and Te Kura Kaupapa Māori o Waitaha (4212)

Executive Summary

- 1. This report seeks your decision on the proposed merger of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha under section 156(A) of the Education Act 1989.
- 2. On 13 September 2012, you announced the proposed merger as part of a number of proposed changes for education provision in greater Christchurch. On 28 September 2012 you initiated formal consultation on the proposal to merge the two kura on a site that is still to be determined.
- 3. The proposal was based on the low rolls at each kura (Te Kura Kaupapa Māori o Te Whānau Tahi had a roll of 72 learners in July 2012 and Te Kura Kaupapa Māori o Waitaha had a July 2012 roll of 81), surplus capacity, and the relatively high cost of remediation of buildings for weather tightness.
- 4. The Boards of Trustees and whānau of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha have undertaken consultation with their communities about the proposal.
- 5. The Ministry received submissions from the Board of each kura and their respective whānau and communities, as well as from the Māori medium community cluster in Christchurch and Te Rūnanga Nui o Ngā Kura Kaupapa Māori o Aotearoa. The submissions argued that the proposal did not consider the cultural significance and importance of each kura as separate entities and if the proposal were implemented it would inhibit and likely reverse efforts to revitalise and grow Māori language, culture and traditions in Christchurch.
- 6. Submissions also stated that the implementation of the proposal would result in negative impacts on the wellbeing of learners and whānau of both kura communities, as well as Māori across Christchurch. The submission from Te Kura Kaupapa Māori o Waitaha states that implementation of the proposal would be in breach of the Treaty of Waitangi principles and the United Nations Declaration on the Rights of Indigenous Peoples to merge the kura.
- 7. While the initial proposal stated the advantage of merging would enable better use of land and resourcing generated through a higher roll, after weighing the submissions, on balance the Ministry considers that other factors outweighed this in favour of not merging.

- 8. The Ministry recommends you agree that the proposed merger of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha does not proceed. It acknowledges the Boards' feedback and recognises that any proposed change to the Māori medium schooling network should be made within the context of a plan for effective Māori medium provision that supports te reo. It is also acknowledged that this planning includes a range of learning pathways and educational options across the city. This would be undertaken during 2013 with a report back to the Ministry by January 2014.
- 9. This planning process recognises the Waitangi Tribunal and the Courts findings that the active protection of the Māori language is a Government responsibility under the Treaty of Waitangi. This means that due care must be taken when a Minister exercises network powers which impact upon the provision of education in te reo Māori (for example closure or merger of a kura).
- 10. The Ministry recommends that it is agreed it asks the Waitaha Advisory Board to work with the kura communities and other key stakeholder groups to develop a comprehensive plan for all levels of Māori medium education provision across the greater Christchurch area. This was the recommendation of the Māori Medium Community Cluster and supports aspects of a number of other submissions that were received.
- 11. Within the context of considering a range of Māori medium provision the plan should include the relocation of one kura to another part of the city so that there is equitable access to this form of immersion education for learners in the greater Christchurch area.
- 12. It is considered that this consultation and planning process will ensure that there is support for te reo and the wellbeing of learners during any transition, with minimal risk to kura, whānau or communities becoming disenchanted or disengaged as a result of changes to the network.

Recommended Actions

We recommend that you:

- a. **note** the information provided about the responses to the consultation by the Boards and whānau with their communities about the proposed merger of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha and that neither Board submission supports the proposal to merge;
- b. **agree** that Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha will be retained as separate kura and not merge;

c. agree that the Ministry of Education will ask the Waitaha Advisory Board to work with the kura communities and other key stakeholder groups to develop a comprehensive plan for all levels of Māori medium education provision across the greater Christchurch area, and that this include the relocation of one of the kura to a site in another part of the city;

Proposed Merger of Te Kura Kaupapa Māori o Te Whānau Tahi (1618) and Te Kura Kaupapa Māori o Waitaha (4212)

Purpose

- 1. This report provides you with information about the responses to the consultation by the Boards of Trustees and whānau of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha on the proposal to merge the two kura.
- 2. You are asked to indicate your decision on this proposal.

Background

- 3. Te Kura Kaupapa Māori o Te Whānau Tahi is a decile 3, Year 1-13 composite school in the Wigram electorate. The July 2012 roll was 72, 100% of whom were Māori.
- Te Kura Kaupapa Māori o Waitaha is a decile 2, Year 1-13 composite school in the Port Hills electorate. The July 2012 roll was 81 learners, 100% of whom were Māori.
- 5. Both kura were established as Te Aho Matua kura under section 155 of the Education Act 1989 (the Act).
- 6. A map showing the geographic area around the two kura is attached as Appendix One.
- 7. On 13 September 2012 you announced the proposed merger as part of a number of proposed changes to education provision in greater Christchurch. This announcement included the proposal to merge Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha.
- 8. On 28 September 2012 you wrote to the Boards of Trustees and whānau of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha and initiated consultation on the possible merger of the two kura on a yet to be determined site. That consultation period ended on 7 December 2012.

Reasons for Considering Merger

- 9. The aggregate roll for the two kura fell by over 50 learners between July 2010 and July 2012. Both kura have low property utilisation rates.
- The proposal to merge Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha reflects these relatively low rolls and low utilisation rates, as well as the high remediation costs for one of the sites. Merging the kura and relocating to one site would enable better use of land and the resourcing generated by the kura having a higher roll.

- 11. The indicative ten year property cost for Te Kura Kaupapa Māori o Te Whānau Tahi is \$1.5 million. For Te Kura Kaupapa Māori o Waitaha it is \$0.3 million. In both cases, these costs are predominantly related to weather tightness remediation works.
- 12. Because both kura are located in close proximity to each other in the south of Christchurch, access to full immersion te reo Māori provision is restricted geographically. It is proposed that as part of the planning for education renewal in greater Christchurch, the Ministry will ask the Waitaha Advisory Board to undertake consultation with kura whānau and other stakeholders to explore a wide range of options for enhancing Māori medium provision across the area. Options should include the relocation of one kura, the possibility of establishing additional kura, as well as reviewing current bilingual and immersion provision to ensure there is equitable access and a range of immersion and bilingual learning pathways for students in the greater Christchurch area.

Māori Medium Education Proposals

13. As at March 2012 Māori medium education in immersion and bilingual classes across the greater Christchurch region is as follows:

14. The Rationale for Change documents for Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha are attached as Appendix Two.

Consultation under Sections 156 and 157 of the Education Act 1989

15. Before making a decision about merging schools, the Minister must consult with the Board of the schools concerned and with the Boards of state schools whose rolls may be affected.

Consultation with the Boards of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha

- 16. On 13 September 2012 you called a meeting of all schools affected by the proposals for possible closure and merger. You also wrote to the Boards of the kura on 28 September 2012.
- 17. The Ministry had individual, combined and cluster meetings with the Board of Trustees and whānau of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha Boards of Trustees and whānau from 13 September to 12 October 2012 to discuss possible merger proposal.
- 18. The Ministry also held three information workshops on the consultation process for Board Chairs and the facilitator the schools engaged to undertake the consultation. It was made clear to the Board and whānau at these meetings that no decision about merger had been predetermined. Regular contact has been maintained with representative Board members and the Principals of both kura.
- 19. The Boards and whānau undertook to consult with their communities and other key stakeholder groups. The final date for submissions was 7 December 2012. On 14 December 2012 you were provided with the complete submissions from the Boards of both kura.
- 20. You also received an Official Information Act request in relation to the proposed merger of the two kura.
- 21. The feedback from the Boards and whānau of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha is summarised as follows:
 - Both kura oppose the proposal to merge and seek to continue as individual kura with distinct kaupapa.
 - Both kura consider that the kaupapa or ideology and cultural significance of its kura for its whānau was not considered in the rationale, as its focus was the provision of education within the context of changes to the land, buildings and people.
 - The submissions propose that a merger would inhibit and likely reverse efforts to revitalise and grow Māori language, culture and traditions in Christchurch. It would negatively impact on the well-being of learners and whānau of both kura communities, as well as Māori across Christchurch.
 - The Board of Te Kura Kaupapa Māori o Waitaha states that a merger would be in breach of the Treaty of Waitangi principles and the United Nations Declaration on the Rights of Indigenous Peoples.

- 22. Submissions from both kura propose to strengthen the use of Māori language and its revitalisation by promoting the benefits of kura kaupapa Māori in kōhanga reo and the wider Christchurch community. This includes investigating opportunities to provide support for learners and whānau moving into total immersion education, and strengthening the links with kōhanga reo by establishing kōhanga reo on the same site as kura.
- 23. Te Kura Kaupapa Māori o Te Whānau Tahi outlined its proposal to deliver culturally grounded, 21st century education. Its "five models of innovation" to support Māori learner achievement and success in education include student study support, a Ngāi Tahu cultural learning programme, a gifted and talented programme, e-learning and a transition class for new Māori medium learners.

Consultation with the Boards of schools whose rolls might be affected

- 24. On your behalf, the Ministry undertook consultation with the Boards of Somerfield School, Cashmere High School, Christchurch South Intermediate, Hillmorton High School, Manning Intermediate, Rowley Avenue School and Woolston School.
- 25. The only response received was from the Board of Somerfield School. It did not anticipate that there would be a significant impact on its school as a result of the proposed merger of the two kura. The Board believes that its school has the capacity to accommodate the learners from Te Kura Kaupapa Māori o Te Whānau Tahi residing within its zone if this became necessary.

Consultation with local iwi via the Waitaha Advisory Board

- 26. The feedback received from the Waitaha Advisory Board was as follows:
 - The Advisory Board strongly supports the enhanced provision of quality teaching in te reo Māori, at all levels, and opposes any decrease in current provision
 - It supports a situation where whānau have the right of access to, and choice of, local full immersion te reo Māori education
 - It supports a model of education provision where there is the least number
 of transition points for learners moving from early childhood services to
 compulsory schooling or between schools, in order to mitigate the risk of
 student disengagement from learning
 - It supports the need for 21st century learning environments that include teaching and learning, and physical site environments, that are responsive to Māori and the culture of the kura.

Additional Consultation

Consultation with the Māori Medium Community Cluster

- 27. Given that there are likely to be changes to Māori medium provision in Christchurch in the future, the Ministry offered the opportunity for the Māori Medium Community Cluster to make a specific submission about the future of this provision in Christchurch.
- 28. Feedback from meetings of the Māori Medium Community Cluster and a survey completed by 370 respondents showed five overarching themes:
 - the need for multiple access points into Māori medium education of various forms and of varying levels across the city
 - that quality Māori medium education is defined in line with a kaupapa Māori framework
 - the strong focus on the protection of te reo Māori and revitalisation efforts in Christchurch
 - the requirement for meaningful consultation with the Māori medium community to inform decisions that impact on learners and may result in the reduction in the amount of provision
 - the demand for high quality teaching and learning, and resources from both the Ministry and Ngāi Tahu, both for current provision and additional future options.
- 29. This submission also included a recommendation to develop a longer term plan for revitalisation of Māori medium education in Christchurch that acknowledges current bilingual and immersion schooling and new different types of Māori medium provision.

Consultation with Te Rünanga Nui o Ngā Kura Kaupapa Māori o Aotearoa

- 30. Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha were established under section 155 of the Education Act and provide immersion education within the philosophy of Te Aho Matua. Because of this the Ministry has a responsibility to consult and work with Te Rūnanga Nui o Ngā Kura Kaupapa Māori o Aotearoa (Te Rūnanga Nui) in relation to matters that may impact on the content of Te Aho Matua.
- 31. Representatives from Te Rūnanga Nui attended meetings with the kura communities in Christchurch. Te Rūnanga Nui also prepared its own submission to the Ministry regarding the proposal to merge the two kura. Te Rūnanga Nui noted that "controversy, anger, sadness and bewilderment dominated each whānau" following the announcement of the proposal to merge the two kura.
- In its submission, Te Rūnanga Nui recommends that the two kura should remain independent and that they should be allowed to continue to grow, and should receive support and advocacy. Consequently Te Rūnanga Nui has proposed that it work with the Ministry, the Te Kōhanga Reo National Trust and the Waitaha Education Advisory Board to grow and strengthen the provision of kaupapa Māori education in Christchurch. It considers that Te Rūnanga Nui and other key stakeholder groups should "collectively strategise to move forward".

- 33. The submission from Te Rūnanga Nui stated that the rationale for the merger was unclear and questioned the basis of the rationale which it stated was based on property issues and low utilisation. Te Rūnanga Nui is of the view that the rationale did not adequately consider or understand the kaupapa of the two kura, noting also that a merger of this nature had never been done before.
- 34. The submission reports that Te Rūnanga Nui considers the rationale did not make clear what the benefits and advantages of a merger would be. According to Te Rūnanga Nui, it would be a massive challenge and burden to create a new environment at a location that is not yet known, and in a manner not yet disclosed.
- 35. Te Rūnanga Nui outlines the following cultural considerations in response to the proposed merger:
 - the cultural framework on which the two kura were established and developed has an inherent spirituality based on a Māori world view, therefore the merger may result in "eliminating, trampling and abusing the spiritual essence of each whānau"
 - the success or demise of a kura is dependent on the strength of its whānau and community which in turn is determined by the quality of the bonds and relationships between the whānau
 - proceeding with a merger would mean multiple, complex relationships would have to be reconstituted in terms of mana, mana whakahaere, rangatiratanga, tikanga and kawa, risking the loss of two good kura in exchange for a new one that may have a higher degree of uncertainty.
- 36. Te Rūnanga Nui dismisses concerns about low utilisation of the kura property. It states that since the earthquakes, roll numbers at Te Kura Kaupapa Māori o Te Whānau Tahi have remained stable while Te Kura Kaupapa Māori o Waitaha has gradually increased its roll numbers to 75. Following discussions between Te Rūnanga Nui, Te Kōhanga Reo National Trust Board and local kōhanga reo, it estimates that over the next two years 50 kōhanga reo graduates will enrol at Te Kura Kaupapa Māori o Waitaha and a further 35 will enrol at Te Kura Kaupapa Māori o Te Whānau Tahi.
- 37. With respect to the property issues in the Rationale document, Te Rūnanga Nui states the significant faults with the buildings at both kura existed before the earthquakes as a result of poor design and construction, and therefore the remediation costs should be met by the architect and the builders rather than used as a reason for the proposed merger of the kura.
- 38. The submission makes the distinction between kaupapa Māori education and Māori medium education. It cites kōhanga reo, kura kaupapa Māori and wānanga as examples of kaupapa Māori education where the predominant use of te reo Māori, and the governance structures and environments, are key distinguishing features.

- 39. Te Rūnanga Nui considers that the inequity of provision of kaupapa Māori education in Christchurch prior to the earthquakes is a reason the two kura must not be merged. It proposes that a proportion of the overall education renewal budget be set aside to implement a strategic plan that will support the growth of Te Aho Matua kura kaupapa Māori in Christchurch through:
 - support in developing Te Aho Matua curriculum
 - strengthening of te reo Māori in each of the wharekura
 - nurturing current teachers and increasing the number of teachers
 - developing capacity for successful whānau governance.

Ministry Comment

- 40. The proposal to merge the two kura provides an opportunity to better utilise their land and resources as they would have a higher roll. After weighing up the arguments presented in the submissions the Ministry considers that other factors outweigh these gains and recommends the merger proposal is not progressed further.
- 41. It is recognised that any change to the Māori medium network would be most effectively undertaken within the context of a plan for Māori medium provision across the city since this would ensure that te reo, as well as learners, kura and whānau are supported throughout the transition.

Waitangi Tribunal

- 42. The Waitangi Tribunal and the Courts have found that active protection of the Māori language is a Government responsibility under the Treaty of Waitangi. This means that due care must be taken to when a Minister exercises network powers which impact upon the provision of education in te reo Māori (eg closure or merger of a kura).
- The Ministry recognises the views of those consulted that a merger could result in negative impacts on the wellbeing of learners and inhibit efforts to revitalise and grow Māori language, culture and traditions in Christchurch. It also acknowledges that the Rationale documents were focused on land, buildings and people and did not include information about the wider issues of active protection of the Māori language nor how access and provision of Māori medium education could be strengthened and improved across Christchurch.

Ministry View

Merging two English medium schools generally combines the majority of learners from both communities (most of whom still attend a local school). In the case of the kura, enrolment is often based on the desire to support Māori language and culture within a particular kaupapa, rather than being linked to a particular location.

- 45. In the current situation, where the depth and spread of Māori medium education provision in Christchurch is in need of review, there is a risk of disengagement by whānau and movement of learners to other schools, particularly if a merger of the schools is perceived negatively. There is also a risk that a merger would distract the community from engaging in work to enhance the quality of, and access points to, Māori medium education across the greater Christchurch area.
- 46. The Ministry is supportive of the proposal to develop the future of Māori medium provision in the greater Christchurch area by developing a comprehensive plan. This was presented in several submissions. It is considered that the Waitaha Advisory Board would be the best group to lead this work and that it could complete it during 2013 and report back to the Ministry with its plan in January 2014.
- 47. A decision to retain both kura provides the opportunity:
 - to include changes to the kura (relocation) within discussions and with a process that is focussed on planning for the future of the Māori medium provision within all interested parties in the community.
 - for them to build on current successful initiatives and nurture the unique kaupapa of the respective kura, and seek innovation that will result in improved achievement for Māori learners and whānau of each kura.
- 48. The Ministry's view is that if a merger was to proceed, in-depth work would be needed to inform and support dialogue between the kura communities, Te Rūnanga Nui and the Crown. Ideally this would be part of a comprehensive review of, and plan for, Māori medium education in the greater Christchurch area.
- 49. The Ministry recommends that work is undertaken to develop a comprehensive vision and plan to enhance the quality of, and access to, Māori medium education across the greater Christchurch area through community engagement and consultation. It is considered that the best group to lead this work is the Waitaha Advisory Board and that it include the relocation of one of the kura to provide better access to kaupapa Māori provision for learners living in different parts of the city.

Education Provision at the two Kura

50. The Education Review Office (ERO) last reviewed Te Kura Kaupapa Māori o Te Whānau Tahi in June 2009. In that report, ERO stated that:

The aspiration for students to nurture their individual talents is clearly reflected in the kura vision statement: Poipoia ō tātou nei pūmanawa. This is underpinned by the key values defined in the charter that engender respect, care and generosity.

Staff and whānau provide many opportunities for students to learn about who they are. Planned noho marae and haerenga coincide with kura-wide kaupapa. Previous kaupapa included Wai Māori, Tangata Rongonui, and other significant events such as Matariki, Waitangi Day and ANZAC Day. Student's awareness of tūrangawaewae, Te Whānau Tahitanga and Kai Tahutaka is increasing as whanaungatanga is enhanced.

Kaiako and kaimahi model personal characteristics that promote caring and respectful interactions with others. During the day, they actively participate in karakia alongside students, praise and affirm positive behaviour, and acknowledge students' achievements and successes. These successes are also shared with the wider kura whānau through their pānui, and their rewards systems Toa o te Wiki and Ngā Taumata o Te Rangitūhāhā.

Students' sense of identity is reinforced through learning their pepeha, relevant whakataukī and tauparapara. This is reflected in students' written and visual work displayed in classrooms and documented electronically. Over time, students, staff and whānau members have established their own tikanga, or ways of doing things, that reflect Te Whānau Tahitanga. An example of this is how karakia is conducted each morning. Daily karakia provides leadership opportunities for all students and affirms their confidence and self-esteem.

Student's confidence is fostered through the wide range of activities provided within and outside the kura. There are high levels of student participation and success in sports competitions and tournaments. Wharekura students also participate in physical activities including abseiling, rock climbing, kayaking, tramping and orienteering.

Whānau members participate in some of the kura activities and state children enjoy these activities. They have observed the positive outcomes in terms of their relationships with others. Whānau members also see students developing confidence and positive self-esteem during activities that require them to stand before their own peers and members of the wider community. These activities have included the Manu Kōrero ā-Kura, regional speech and kapa haka competitions and the Wearable Arts evening. Pō Whakanui Tamariki are held regularly throughout the year to showcase students' learning and achievements.

51. ERO last reviewed Te Kura Kaupapa Māori o Waitaha in May 2010 when it returned to conduct a supplementary review. ERO reported the following:

Whānau and kaiako have adopted a strategic approach to support them to address specific areas in Te Ira Tangata, Te Reo and Āhuatanga Ako. They have worked hard to develop and implement clear systems to improve school wide practices that have included:

- establishing guidelines and expectations to foster positive relationships among students and strengthening tuakana, teina roles and responsibilities with a particular focus in Wharekura
- identifying strategies to supporting individual kaiako with specific te reo Māori language developmental needs
- implementing a school wide literacy plan to increase kaiako understanding and clarity to integrate good practice in classroom programmes
- providing kaiako with guidelines and expectations to fulfil their professional responsibilities to improve the quality of teaching and learning school wide.

ERO has also identified next steps for whānau and kaiako that are focussed on improving the overall quality of te reo Māori and teaching and learning to improve learning outcomes for students.

ERO is likely to carry out the next review within three years.

Priority Learners

Ongoing Resourcing Scheme (ORS)

52. As at 1 July 2012, neither of the two kura had learners accessing Ongoing Resourcing Scheme (ORS) funding.

Financial Implications

- 53. If Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha merge it would generate Education Development Initiative (EDI) and Joint Schools Initiative Funding (JSIF) in line with the EDI policy.
- 54. These funds are used for projects that support student achievement, psychosocial needs, transition and change management within and across schools (EDI funding) and Learning Community Clusters (JSIF funding). This funding is only generated if the merger is implemented.
- 55. If your decision is that the kura should merge, or you decide to proceed with further options for consultation on the future of the schools, estimates of the savings to the Crown in operational funding will be prepared for your information.

Property Implications

Background Rationale

- The buildings on the Te Kura Kaupapa Māori o Te Whānau Tahi site have suffered some degree of earthquake damage. This covers a wide spectrum from minor cracking to ceiling and wall finishes, to the need to replace concrete slabs of pathways. At present no buildings have been identified as potentially requiring structural strengthening. Buildings on site have been flagged for weather tightness remediation.
- 57. Surrounding land is predominately CERA technical category 2 (TC2). While geotechnical considerations are unlikely to be a significant factor at this site, preliminary assessments suggest further investigation will be required if further development is undertaken on this site.
- 58. The indicative cost to repair Te Kura Kaupapa Māori o Te Whānau Tahi is \$1.5 million.
- 59. The buildings on the Te Kura Kaupapa Māori o Waitaha site have suffered some degree of earthquake damage. This covers a wide spectrum from minor cracking to ceiling and wall finishes, to a need for re-levelling building floors. At present no buildings have been identified as potentially requiring structural strengthening. No weather tightness issues were identified during the national survey and subsequent inspections.
- 60. Surrounding land is a combination of CERA technical category 2 (TC2) and technical category 3 (TC3). Preliminary assessments suggest geotechnical considerations are likely to be a factor when undertaking development at this site. Significant foundation engineering is likely to be required.

61. The indicative cost to repair Te Kura Kaupapa Māori o Waitaha is \$0.3 million.

Proposal Analysis

62. No queries about land and buildings were raised by the Board of either kura.

Property Entitlement

- 63. The Ministry uses a number of data sources to provide an estimated cost per learner for the original Minister's proposal and any alternative proposals put forward by the school.
- 64. These sources are:
 - the latest indicative property cost information
 - current roll information (October 2012)
 - network analysis of the estimated additional required teaching spaces required.

65. If you decide to proceed with the merger of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha, the risks are:

Māori medium provision

- The provision of Māori medium education in Christchurch could be compromised by the reduction in the total number of immersion education settings, and the possibility of whānau and wider communities of both kura becoming disaffected and disengaged.
- o If the merger proceeds the Ministry will work with the Boards and kura whānau to support them to continue providing quality educational provision and a positive environment as they work through the transition.

Waitangi Tribunal

- There is a risk that a claim to the Waitangi Tribunal could proceed, citing breaches to Articles One and Two of the Treaty of Waitangi.
- If this does proceed the Ministry will develop its response to the claim.

Planning of future Māori medium provision

- o If you agree that as well as merging the kura the Ministry asks the Waitaha Advisory Board to develop a plan for the future of Māori medium provision in the greater Christchurch area, there is a risk that the merger process could distract communities from engaging in this.
- In order to mitigate this, the Ministry would present the two processes as both strengthening the provision of te reo Māori, but in different ways. Both aim to provide new and exciting opportunities for learners.

Iwi engagement

- The Ministry was initially advised that Ngāi Tahu requested that this report on the kura proposal was developed within a philosophy that considers the perspectives and aspirations of both kura kaupapa Māori and Ngāi Tahu. There is a risk that the Ministry may be perceived as not having taken this request seriously, and therefore not honouring its obligations.
- As part of its consultation the Ministry formally approached Te Runanga Nui and the Waitaha Advisory Board for their response to the merger proposal. Where submissions were presented in Te Reo Māori these were translated into English, so that all details of the responses were fully captured. In developing this report input has been provided from a range of staff with backgrounds in Māori medium provision in Christchurch and across the country.
- The Ministry will ensure that Ngāi Tahu, Te Runanga Nui and the Waitaha Advisory Board are made aware of the decisions for the kura and the wider schooling proposals (it is proposed that this is through an email or at meetings on 18 February 2013 and later, face to face).

66. If you decide not to proceed with the merger, the risks include:

The context of kura and te reo

- The perception by other schools and communities in Christchurch that the kura are being treated differently from mainstream English medium schools because they are being retained and not merged.
- o The Ministry recognises that each proposal is unique because each school's situation is unique. Not all merger proposals in English medium schools are being progressed. The decision to retain the two kura as separate schools is within the context that the Waitaha Advisory Board leads the development of a plan for Māori medium provision for the greater Christchurch area. This should include the relocation of one of the kura to another part of the city. This relocation supports requests for greater equity of access to immersion provision for learners from across the city.

Further consultation

- The two kura communities may disengage from the subsequent, positive conversations about education renewal in Christchurch if they believe the kura are both exempt from merger or closure.
- The consultation about the future of Māori medium provision is an exciting and challenging opportunity to have a say in the future of education in the Christchurch area. This planning is likely to provide opportunities for a range of new provision as well as ideas for strengthening current provision. The Ministry will ask the Waitaha Advisory Board to ensure it engages a range of organisations, including Te Runanga Nui and Ngāi Tahu and the Boards and the whānau from both kura.

Conclusion and Next Steps

- The Ministry's recommendation is that Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha should remain as separate kura and not merge, but that one of the kura should be considered for relocation. The Ministry does not have a view on which one and recommends the Waitaha Advisory Board consider this in the context of the wider review of provision of Māori medium education.
- 68. This recommendation takes into consideration:
 - the submissions from the Boards of the kura which show that neither support the merger proposal
 - the need to ensure that any change to the Māori medium network is made within a planned context which ensures the support of te reo
 - the possibility that whānau could become disheartened and disengaged with supporting Māori medium education if the merger is progressed against the advice of the Boards' submissions
 - the need to have a wider discussion about the Māori medium/bilingual language provision across all providers in greater Christchurch with a view to developing a strategy that aims to further develop and strengthen this provision.

- 69. Once your final decision is known, letters will be developed for you to inform the Boards of both kura.
- 70. Note that when your decision is known letters will also be developed for Te Rünanga o Ngāi Tahu, Te Rūnanga Nui o Ngā Kura Kaupapa Māori o Aotearoa and the local Members of Parliament, advising them of your decision.
- 71. Once your decision has been made, the Ministry recommends that a copy of this report be released to the Boards of Trustees and whānau of Te Kura Kaupapa Māori o Te Whānau Tahi and Te Kura Kaupapa Māori o Waitaha.



Te Kura Kaupapa Māori o Te Whanau Tahi – Rationale for change

This document has been prepared to assist discussions with parents and communities about proposals for education renewal for greater Christchurch.

Why is change needed?

A strong education network is vital for the renewal of greater Christchurch.

The extent of damage and ongoing impact of people movement in the wake of the 2010 and 2011 earthquakes mean it cannot be restored to the way it was.

We need to accept in areas that have been depopulated we will have to do things differently, which will inevitably mean some change to services. The viability of existing individual schools and increased demand for new schools are a key consideration going forward.

The earthquakes, while devastating, have provided an opportunity beyond simply replacing what was there, to restore, consolidate and rejuvenate to provide new and improved facilities that will reshape education, improve the options and outcomes for learners, and support greater diversity and choice.

Education renewal for greater Christchurch is about meeting the needs and aspirations of children and young people. We want to ensure the approach addresses inequities and improves outcomes while prioritising action that will have a positive impact on learners in greatest need of assistance.

With the cost of renewal considerable, the ideal will be tempered by a sense of what is pragmatic and realistic. Key considerations are the practicalities of existing sites and buildings, the shifts in population distribution and concentration, the development of new communities and a changing urban infrastructure.

Innovative, cost effective, and sustainable options for organising and funding educational opportunities must be explored to provide for diversity and choice in an economically viable way.

Discussions with schools, communities and providers within learning community clusters have and will continue to be key to informing decisions around the overall future shape of each education community. Ways to enhance infrastructure and address existing property issues, improve education outcomes, and consider future governance will form part of these discussions which are running in parallel to consultation around formal proposals.

"We have a chance to set up something really good here so we need to do our best to get it right" – submission to Directions for Education Renewal across greater Christchurch.

Why is it proposed my kura merge?

People movement and land and or building damage as a result of the earthquakes are the catalysts for change across the network across greater Christchurch.

Many school buildings suffered significant damage, school sites have been compromised and there were 4,311 fewer student enrolments across greater Christchurch at July 2012 compared to July 2010¹.

Even before the earthquake there were around 5,000 spaces already under utilised in the network.

The aggregate roll for the two kura fell by over 50 learners between July 2010 and July 2012. Both kura have low utilisation rates.

The proposal to merge the two kura reflects these low rolls and low utilisation rates, as well as the high remediation costs for one of the sites. Merging the kura and relocating to one site will enable better use of land and funding.

Because both kura are located in close proximity to each other in the south of Christchurch, access to this provision is restricted. As part of the planning for renewal, the Ministry wants to work with the community to explore other options for enhancing Māori medium provision across greater Christchurch. This includes the possibility of establishing additional kura, as well as reviewing bilingual and immersion provision to ensure it is high-quality and easily accessible.

Land

Surrounding land is predominately CERA technical category 2 (TC2).

While geotechnical considerations are unlikely to be a significant factor at this site, preliminary assessments suggest further investigation will be required if further development is undertaken on this site.

Buildings

The buildings on the TKKM o Te Whanau Tahi site have suffered some degree of earthquake damage. This covers a wide spectrum from minor cracking to ceiling and wall finishes to replacing concrete slabs of pathways.

At present no buildings have been identified as potentially requiring structural strengthening.

Detailed Engineering Evaluations (DEE's) are yet to commence but are scheduled to be complete by mid 2013; these reports will confirm the exact scale of the structural strengthening, if required.

Buildings on site have also been flagged for weather tightness remediation.

People

While the roll for TKKM o Te Whanau Tahi has remained relatively stable, the roll for TKKM o Waitaha has fallen in July 2012 compared to July 2010.

The aggregated July 2012 rolls for both kura have decreased by over 50 learners since July 2010.

Manning Intermediate offers only Level 4 Māori Medium Education. This school is also proposed to close.

Tuahiwi School is located in the Waimakariri District, north of Kaiapoi.

Excluding the two kura and Halswell Residential College, three of the schools listed above are proposed to close and two are proposed to merge with another school.

The Ministry wants to work with the community to develop other options for enhancing Māori medium provision across greater Christchurch. This includes the possibility of establishing bilingual and immersion provision in other locations to ensure quality and ease of access.

Student Distribution patterns4

Students attending a local state school

In the July 2012 school roll returns, 8,620 students in greater Christchurch were identified as Māori or part Māori. Of these 88% (7,610) attend a state school, 10% (861) attend a state integrated school, and 2% (149) attend private schools.

Population change⁵

Number of March 2010 and March 2012 student address records⁶ in red zones⁷.

There are significant areas of CERA 'Red Zone' land within the catchment of the two kura (Christchurch City).

At March 2010 only one TKKM o Te Whanau Tahi student lived within an area now classified as "Red Zone" land by CERA. No address matched TKKM o Waitaha student data is available for 2010.

At March 2012, no TKKM o Te Whanau Tahi or TKKM o Waitaha students lived within these areas.

There are significant areas of greenfield residential development proposed in the North and West of the city.

Given the two kura draw few students from these areas of red zone and the future greenfield growth, the scale of household change in the schools catchment is expected to have little impact on future demand for schooling provision at the kura.

Factors such as parental choice and a recent increase in birth rate are more likely to impact roll change at these schools.

The Ministry will continue to work with agencies such as Christchurch City Council and CERA on projected population change.

Six percent of TKKM o Waitaha students reside within 3 kms to the TKKM o Te Whanau Tahi site.

Approximately 30% of students currently attending a kura reside within 3 km of the TKKM Te Whanau Tahi site.

While more students reside close to the TKKM o Waitaha site than the TKKM Te Whanau Tahi site, other factors such as land, site size, property, and facilities available will play a greater role in determining which site is preferable in the event of a merger.

Merging the two kura would provide opportunities to explore options for provision outside of the south of Christchurch and for funding to be invested into the network generally to provide modern learning environments for a larger number of students.

Safe and inspiring learning environments are key to meeting the New Zealand Property vision for greater Christchurch schools, which means:

- Ensuring any health and safety and infrastructural issues are addressed
- Taking into account whole of life cost considerations, to allow cost over the life of the asset, rather than initial capital cost to drive repair or replacement decisions
- Enabling all entitlement teaching spaces to be upgraded to meet the 'Sheerin' Core modern learning environment standard – which has a strong focus on heating lighting, acoustics, ventilation and ICT infrastructure upgrades.

This will include provision of appropriate shared facilities across schools within a cluster that can be used by both schools and the community and other agencies as appropriate.

An effective merger brings together the strengths of both schools. The particular programmes which are run in the merged school are decisions made by the board of the continuing school, however, it is likely the successful programmes, culture etc which have been developed within either school would be continued in the merged school.

The Ministry would expect a merged school would want to work with all learners in its community.

If a merger is to proceed the move would not be piecemeal.

The board of the continuing school would discuss an implementation plan for the merger with the Ministry. This would then be implemented.

If a final decision to merge is made by the Minister, and gazetted, the board of the continuing school or a new board as appropriate, would oversee the process. This will include decisions around school name, uniform, branding etc.

There must be at least one full term between the gazetting and when the merger is implemented. In some cases, the Minister agrees to appoint a board for the continuing school. The appointed board can co-opt members as required.

Elections for a new board of trustees must be held within three months of the date of merger. At this time, the newly elected board will be representative of all families at the merged school.

The Ministry will ensure appropriate provision for learners within this cluster to support any changes that may result from consultation.

The Ministry will provide information around enrolment options to families and provide required support.

Staff, including support staff, will be able to apply for positions in the merged school. Alternatively redundancy may apply in respect to reduced or full loss of hours.

The provisions of the respective employment agreements will apply for staff.

If a decision to merge is made the vacated school property site will go into a disposal process.

How would the proposed merger of my kura fit into the overall plan for my learning community cluster and the network as a whole?

Renewal focuses on the cluster of provision within an education community and the collective impact of people movement and land and building damage across the entire provision within the cluster.

The future of your learners should continue to feature in the wider discussion.

In the first instance this is because the cluster may have thoughts it wishes to contribute during consultation around alternative options that will meet the overarching needs of this cluster to not only revitalise infrastructure but also enhance educational outcomes across this education community.

The cluster will also need to consider how learners might be accommodated in the future should a decision be made to merge TKKM o Te Whanau Tahi and TKKM o Waitaha. The cluster would want to consider how enhanced provision that might be required to support moving student populations might look and how the merger could support the wider idea for enhanced provision across the network.



Te Kura Kaupapa o Waitaha – Rationale for change

This document has been prepared to assist discussions with parents and communities about proposals for education renewal for greater Christchurch.

Why is change needed?

A strong education network is vital for the renewal of greater Christchurch.

The extent of damage and ongoing impact of people movement in the wake of the 2010 and 2011 earthquakes mean it cannot be restored to the way it was.

We need to accept in areas that have been depopulated we will have to do things differently, which will inevitably mean some change to services. The viability of existing individual schools and increased demand for new schools are a key consideration going forward.

The earthquakes, while devastating, have provided an opportunity beyond simply replacing what was there, to restore, consolidate and rejuvenate to provide new and improved facilities that will reshape education, improve the options and outcomes for learners, and support greater diversity and choice.

Education renewal for greater Christchurch is about meeting the needs and aspirations of children and young people. We want to ensure the approach addresses inequities and improves outcomes while prioritising action that will have a positive impact on learners in greatest need of assistance.

With the cost of renewal considerable, the ideal will be tempered by a sense of what is pragmatic and realistic. Key considerations are the practicalities of existing sites and buildings, the shifts in population distribution and concentration, the development of new communities and a changing urban infrastructure.

Innovative, cost effective, and sustainable options for organising and funding educational opportunities must be explored to provide for diversity and choice in an economically viable way.

Discussions with schools, communities and providers within learning community clusters have and will continue to be key to informing decisions around the overall future shape of each education community. Ways to enhance infrastructure and address existing property issues, improve education outcomes, and consider future governance will form part of these discussions which are running in parallel to consultation around formal proposals.

"We have a chance to set up something really good here so we need to do our best to get it right" – submission to Directions for Education Renewal across greater Christchurch.

Why is it proposed my kura merge?

People movement and land and or building damage as a result of the earthquakes are the catalysts for change across the network across greater Christchurch.

Many school buildings suffered significant damage, school sites have been compromised and there were 4,311 fewer student enrolments across greater Christchurch at July 2012 compared to July 2010¹. (*This includes international fee paying students.*)

The aggregate roll for the two kura fell by over 50 learners between July 2010 and July 2012. Both kura have low utilisation rates.

The proposal to merge the two kura reflects these low rolls and low utilisation rates, as well as the high remediation costs for one of the sites. Merging the kura and relocating to one site will enable better use of land and funding.

Because both kura are located in close proximity to each other in the south of Christchurch, access to this provision is restricted. As part of the planning for renewal, the Ministry wants to work with the community to explore other options for enhancing Māori medium provision across greater Christchurch. This includes the possibility of establishing additional kura, as well as reviewing bilingual and immersion provision to ensure it is high-quality and easily accessible.

Land

Surrounding land is a combination of CERA technical category 2 (TC2) and technical category 3 (TC3).

Preliminary assessments suggest geotechnical considerations are likely to be a factor when undertaking development at this site. Significant foundation engineering is likely to be required.

Buildings

The buildings on the TKKM o Waitaha site have suffered some degree of earthquake damage. This covers a wide spectrum from minor cracking to ceiling and wall finishes to relevelling building floors.

At present no buildings have been identified as potentially requiring structural strengthening.

Detailed Engineering Evaluations (DEE's) are yet to commence but are scheduled to be complete by mid 2013; these reports will confirm the exact scale of any structural strengthening, if required.

No weather tightness issues were identified during the national survey and subsequent inspections.

All follow up site specific invasive investigations are being carried out by qualified engineers who interpret the findings and recommend further testing as appropriate.

For assessing weather tightness – cost estimates were developed as part of a national survey of school buildings. Further detailed assessments were carried out on buildings identified through this exercise.

People

While the roll for TKKM o Te Whanau Tahi has remained relatively stable, the roll for TKKM o Waitaha has fallen in July 2012 compared to July 2010.

The aggregated July 2012 rolls for both kura have decreased by over 50 learners since July 2010.

Tuahiwi School is located in the Waimakariri District, north of Kaiapoi.

Population change⁵

Number of March 2010 and March 2012 student address records⁶ in red zones⁷.

There are significant areas of CERA 'Red Zone' land within the catchment of the two Kura (Christchurch City).

At March 2010 only one TKKM o Te Whanau Tahi student lived within an area now classified as "Red Zone" land by CERA. No address matched TKKM o Waitaha student data is available for 2010.

At March 2012, no TKKM o Te Whanau Tahi or TKKM o Waitaha students lived within these areas.

There are significant areas of greenfield residential development proposed in the North and West of the city.

Six percent of TKKM o Waitaha students reside within 3 km of TKKM o Te Whanau Tahi

Approximately 30% of students currently attending a kura reside within 3 kms of TKKM Te Whanau Tahi site.



Education Report:

Organisation of schools in greater Christchurch if all proposals for merger or closure proceed – provision for Māori Medium education.

Purpose of Report

- 1. On Tuesday 22 January, in a discussion about the Ministry's recommendations for the proposed merger and closure of schools in the greater Christchurch area, you sought further information about the provision of Māori medium education in order to assist with your consideration of the recommendation about the two kura in Christchurch.
- 2. It was also noted that the proposals for some schools in greater Christchurch to close or merge will impact on current provision of Māori medium education provision in the region, as they have bilingual/immersion units.
- 3. The purpose of the report is to provide additional information, seek your agreement on a revised recommendation for the two kura and seek your endorsement for work underway so that continued and enhanced provision is available to all learners who want to receive their schooling in te reo Māori.

Background

- 4. Current provision for Māori medium education provision in greater Christchurch is provided by two kura and bilingual units at 10 schools. All but one of these are situated in the Christchurch area. There is no provision in the Selwyn district and one unit in the Waimakariri district (at Tuahiwi School).
- 5. Apart from Unlimited Paenga Tawhiti (a designated character school) and the two kura kaupapa, there is no provision for Māori medium education at any of the secondary schools in greater Christchurch. Secondary schools are required to meet the New Zealand curriculum requirements in relation to te reo Māori.
- 6. The attached map 'MME Providers in Greater Christchurch and Recommended Changes January 2013' (Map1) identifies the location of each current provider of Māori medium education. This map also indicates which of these providers have been proposed to merge or close and three areas that require closer attention (Focus areas 1, 2 and 3) in regards to accessibility for Māori learners.
- 7. Table 1 is the number of students enrolled at each of these providers at July 2012

- 8. Seven of the 12 providers are not affected by proposals for closure or merger, three are recommended to merge with another school that does not currently offer Māori medium provision, and two providers are proposed for closure.
- 9. The attached map 'Māori Student Distribution by Area Unit at July 2012' (Map2) indicates the home addresses for students enrolled in Māori medium education at that time, and the distribution of the Māori student population in greater Christchurch, by area unit.
- 10. If all current proposals for mergers proceed it is anticipated that the existing units will be retained by the Board of the continuing school, ensuring continued provision in that community. Once final decisions are made the Ministry will work with the Boards to facilitate this outcome.
- 11. Should the current proposal to close Branston Intermediate proceed, it could be anticipated that students enrolled in that unit will transfer their enrolment to the neighbouring Hornby High School which is proposed to change its class to become Year 7-13.
- 12. Should the proposal to close Shirley Intermediate proceed, the Ministry recommends that a unit be established at Shirley Primary to ensure continued provision in the area. This would depend upon the approval of the recapitation of Shirley Primary to include Year 7 and 8 students. If this eventuated the Ministry would discuss this further with the Shirley learning community cluster.
- 13. Map 2 indicates areas of greater Christchurch were there are relatively higher numbers of Māori students and no current provision for Maori medium education. These are identified on the Map as 'Focus 1', 'Focus 2' and 'Focus 3'.


- 14. Focus 1 area includes the communities of Papanui, Roydvale and Burnside where moderate numbers of Māori students reside. The Ministry intends to discuss provision with the learning community clusters in this area and monitor whether provision is required for future planning.
- 15. Focus 2 area includes parts of the Parklands and Mairehau communities where moderate to high number of Māori students reside. It also borders the greenfield development of housing at Prestons Road. The Ministry intends to work with these communities to discuss local provision for students.
- 16. Focus 3 area relates to Aranui where the highest numbers of Māori students reside but no current Māori medium education is available. The Ministry's proposal for this community is that the schools combine into one school, covering Years 1 to 13. The Ministry will work with this cluster to ensure provision is available in the new school or schools, no matter what shape that may be.
- 17. In relation to the two kura kaupapa, the Ministry's original proposal was that these kura merge. Following analysis of feedback from the kura, the Ministry has now recommended that one of these relocate. We have not specified which kura that may be or which area they should relocate to.
- 18. We recommend that the area for the relocation should be to the north east of Christchurch in or close to Focus 2 area, or to Aranui (Focus 3).
- 19. It is the intention of the Ministry to investigate, in collaboration with the Māori medium learning community cluster and the Waitaha Advisory Board, the feasibility of relocating a kura to Aranui or somewhere in the north east of Christchurch city.
- 20. As previously noted, the only secondary provision for Māori medium is at the two kura. The Ministry intends to work with the secondary schools cluster to discuss provision within current schools. The aim would be to ensure that students learning in Māori medium at primary school can continue with this in their secondary education.
- 21. There are two possibilities for establishment of Māori medium education at secondary schools. The first possibility is to work with the secondary school learning community cluster to establish units at some of the secondary schools. The second possibility is to discuss with the two kura the establishment of satellite classes at some secondary schools, managed and governed by the Board of Trustees at the kura.
- 22. The only Māori medium provision in the Waimakariri district is at Tuahiwi School and there is no provision in the Selwyn district. The Ministry intends to work with learning community clusters in these areas to discuss future provision for Māori medium education.
- 23. If all proposed changes for school reorganisations in Christchurch are progressed, Māori medium education in greater Christchurch would be enhanced and more accessible. The table below indicates where provision would be.



Current provision for Māori medium education provision in greater Christchurch is provided by two kura and bilingual units at 10 schools. All but one of these are situated in the Christchurch area. There is no provision in the Selwyn district and one unit in the Waimakariri district (at Tuahiwi School).

Apart from Unlimited Paenga Tawhiti (a designated character school) and the two kura kaupapa, there is no provision for Māori medium education at any of the secondary schools in greater Christchurch.

The attached map (Appendix 1) shows the distribution of the Māori student population in greater Christchurch, by census area unit.

The Minister's Interim Decisions at 18 Feb 2013 include an interim decision to close Branston Intermediate. Given that Hornby High School would take most of the Year 7&8 students that currently attend Branston Intermediate, it is logical that a MME class be established at Hornby High School. This may provide an opportunity for the school to build on this MME provision by offering secondary education through MME.

The interim decisions also included mergers for each of Unlimited Paenga Tawhiti, Freeville School, and Woolston School. These units would be expected to continue at the merged schools, providing an opportunity for more students at each merged school to access MME.


Large numbers (512) of Māori students reside in the communities of **Papanui**, **Roydvale and Burnside**. The Ministry intends to discuss provision with the learning community clusters in this area and monitor whether provision is required for future planning. Note these are areas that the **kura are not located within**.


Moderate numbers of Māori students reside in the **Parklands** (350 students) and **Mairehau** (253 students) communities. It also borders the greenfield development of housing at Prestons Road. The Ministry intends to work with these communities to discuss local provision for students. Note these areas that the **kura are not located within**.

A large number (535) of Māori students reside in Aranui, but no current Māori medium education (including kura) is available in this community. The Ministry's proposal for this community is that the schools combine into one school, covering Years 1 to 13. The Ministry will work with this cluster to ensure provision is available in the new school or schools, no matter what shape that may be.

There is currently **no MME (including kura) provision in Selwyn district**, despite a **large number** (367) of students residing in and around **Rolleston** identifying as Māori.

Appendix B shows the map as in Appendix A, but includes the CERA residential "Red" zones and the Council planned Greenfield residential growth areas. This shows the areas of expected population growth and areas affected. Note neither kura are well placed for the proposed growth patterns across greater Christchurch, TKKM Te Whanau Tahi will meet some of the growth proposed for Halswell.





Appendix B:

General Comments (Summary re Kura Provision)

- It is usually considered preferable for schools/kura to be located so as to allow good access for their target students.
- Due to the two Kura being the only providers of this type of education in the Greater Christchurch region, some students travel large distances to attend these schools.
- The two Kura are located close to each other, in the South of Christchurch.
- Part of the rationale for relocating one of the Kura was to provide greater ease of access to this type of education for students across Christchurch.
- Based on student addresses as at July 2012 roll return data:

TKKM o Te Whanau Tahi:

- Of the 70 address matched student records from the July 2012 roll return.
- Students lived an average of 3.8 kilometres from the school site.
 - All students lived less than 12.2 kilometres from the school site.

TKKM o Waitaha:

- Of the 80 address matched student records from the July 2012 roll return.
- Students lived an average of 6.2 kilometres from the school site.
- All students lived less than 33.1 kilometres from the school site.
- Seven students lived at addresses between 24 and 33.1 kilometres from the school site. These students live in the Waimakariri District.
- The majority of TKKM o Te Whanau Tahi students live in Cashmere and Hornby, in the South West of Christchurch.
- The majority of TKKM o Waitaha students live in Linwood and Aranui, in the East of Christchurch

Iwo key findings from the community consultation on Directions for Education Renewal in Greater Christchurch

- Focus on quality bilingual and immersion education
- Whānau can access quality bilingual or immersion education

Seneral stats:

- Total number of Maori students in greater Christchurch is 8331.
- Total number of Maori students in the north of greater Christchurch is 4384.
- Total number of students in Maori medium (level 1 and 2) is 459 as at July 2012.

Te Kura Kaupapa Māori o Waitaha - Survey

The Board of Te Kura Kaupapa Māori o Waitaha undertook a survey of 50 random addresses in Parklands, Aranui and Mairehau asking:

- Preference for bilingual or total immersion education
- Current level of te reo.

The survey results are as follows:

Parklands

- 2/43 school aged children surveyed would go to immersion school if established in Parklands
- 20/43 school aged children surveyed would go to a bilingual school (not enough te reo for TKKM)
- 23/43 would go to English Medium school.

Aranui

- 8./80 school aged children surveyed would go to immersion school if established in Aranui (2 of these fluent enough in te reo for TKKM)
- 27/80 would go to bilingual school if established in Aranui (2/27 of these fluent enough for TKKM)
- 45/80 would go to English Medium school.

Mairehau

- 9/53 school aged children surveyed would go to immersion school if established in Mairehau (3 of these fluent enough in te reo for TKKM)
- 19/53 would go to bilingual school if established in Mairehau (2/19 of these fluent enough for TKKM)
- 25/53 would go to English medium school.

Ministry comment about the information provided by Te Kura Kaupapa Māori o Te Whānau Tahi about the ways its whānau consider that access to Māori Medium provision could be improved.

Suggestion	Comment
Could strengthen access to Māori medium provision through having more applications to establish TKKM	 Each application would be assessed on its merits. When considering an application the Ministry would undertake analysis of the network including any spare capacity at the kura currently operating in the city and the demand for the new provision (and where these students currently or would currently enrol) and its impact on the network of schools. This, along with a range of other factors, would then be presented to the Minister for consideration.
Could strengthen access to Māori Medium provision through the establishment of a new TKKM or satellites of current kura.	 The Ministry's experience is that boards that have satellites find it challenging to govern and effectively manage the second campus. In order to be successful the kura would need a strong board and successful leadership. While the Ministry can proactively facilitate development of a proposal to establish immersion / bilingual provision as a satellite, it is the Board of the school concerned that must take on the responsibility for the unit and develop and run it.
Could strengthen access to Māori Medium provision through having units attached to mainstream schools	The Ministry will work with Boards of schools across the network to support the implementation of immersion / bilingual units at mainstream schools.
Could strengthen access to Māori Medium provision by having dedicated transport options for students in areas so they can go to TKKM from West (Rolleston, Hornby and Halswell)	It is unlikely that there would be a change to the school transport policy for Christchurch. For this reason this option is not likely to be able to be implemented.
Could strengthen access to Māori Medium provision by the Ministry investing more in kōhanga reo so there is sustainability for TKKM in Christchurch	 There are currently six kōhanga reo in the wider Christchurch area and two education and care services that work within a Māori context and philosophy. The Waitaha Advisory Board is developing a Māori Medium strategy for Christchurch and this will include the current and proposed location of kōhanga reo and immersion / bilingual schooling. This will highlight the areas where kōhanga and kura / wharekura would be best located in the future.
