

Dear Kathryn Palmer

Our Board of Trustees, after consultation with the affected community, does not want Duvauchelle School closed and consolidated with Akaroa Area School.

What we DO want is to continue as a single entity Year 0 – Year 6 contributing primary school under our own governance and management with the potential to re-capitate to Year 8. We want to continue appointing our Principal and retain the close and supportive input of our parents/caregivers. We are keen to have our Years 7 & 8 students complete their primary education here instead of two years at an interim school (Akaroa Area School) before many of them continue their education in Christchurch.

Furthermore we have entered into consultation with the Banks Peninsula Plunket Pre-School to re-locate the Pre-School onto the Duvauchelle School site. The Ministry of Education has approved this in principle.

What we particularly value is the positive influence and impact on our childrens' education that provides the right culture in the present rural setting and environment where they are educated, centrally located in the Akaroa cluster.

We value the "buy-in" of our parent/caregiver community. Without this community group seeing the strong local governance, management and commitment to our school, we will be very vulnerable to total closure.

Informal face-to-face discussion with Akaroa Area School Board Chair and Principal recently established that they support our School remaining open as a separate entity. It was pointed

out by them that their recent experience in endeavouring to maintain the Akaroa Primary School on a site 500m from the Akaroa Area School proved impractical, difficult and illogical, so the two schools were merged. This would likely also happen in time to Duvauchelle and Okains Bay Schools with the Minister's proposal.

Since the Minister has expressed interest in "economies of scale" the risk of funding loss to some degree seems likely should a closure/consolidation be forced. There has also been indications from the Akaroa Area School Board Chair that unless there was significant funding made available to Akaroa Area School both Duvauchelle and Okains Bay hubs would be closed quite soon under this proposal.

The ability to appoint our own Principal with real and direct input into the appointment process. We also value the strength of our local community in that our Board of Trustees is elected and there is competitive interest in becoming a trustee.

Quality of Education: As highlighted in our May 2012 ERO report - "ERO observed students who enjoyed learning and were motivated to achieve. Students have positive and supportive relationships with each other and their teachers. Older students provide positive role models and support younger students in their learning."

Our students are achieving at 10% above the National Standards.

Our school community is very proud that they have provided IT resources for our students on a one to one basis. In addition provision for extra teaching hours have been funded over and above what is provided for by the Ministry.

<u>Sustainable School Rolls:</u> There is a change in the pattern for the school roll emerging from 2013 onwards. We have confirmed new arrivers of at least 13 in 2013 which gives a roll of 39. This is a substantial increase of 50% from the 2012 roll. As 9 of these are new entrants we expect to maintain this increase in roll for some years.

<u>Future School Roll Potential</u>: As a result of the Minister's proposal we have been innovative and entered into discussions and consultation with the Banks Peninsula Plunket Pre-School on the feasibility of them relocating onto our site. This option is approved in principle by the Ministry of Education. This would provide a seamless transition from pre-school to primary and enable the Pre-school to double its roll to a minimum of 30 children. Because the Akaroa Harbour Basin Settlement Study – Issues and Options - 2009 highlights Duvauchelle and Wainui as priority areas for future development, the Community Board intends to encourage strategic planning for these areas in the 2013 LTCCP development. This and other potential infrastructure changes ahead suggest the Duvauchelle future population over the 10 – 30 year period is likely to increase and therefore help sustain the school roll.

<u>Sustainable Use of Resources:</u> The existing cluster system has been in operation for many years and staff are already successfully applying the cluster approach in the following ways:

- Regular Principals' planning meetings providing collaborative planning.
- Teaching staff getting together to moderate against the National Standards.
- Shared use of resources.
- Combining arts, cultural and sports events.

The challenge posed by the Minister is encouraging us to consider additional ways we can maximize the use of existing cluster resources and we will explore these ideas in the future.

<u>Sustainable Economic Management:</u> The Board of Trustees has a history of successful fundraising that is dependent on the support and loyalty of the locals and the capacity of the community to identify with the school because it is theirs and in their backyard. For example, this year the community has raised money to support our Sunsmart School and Swimsafe Status as listed:

- Provide a new filter and on-going maintenance for the swimming pool as well as regular swim coaching.
- Fund extra staffing for separate literacy and numeracy for the juniors on top of professional develop for our staff.
- Provide six new I-pads.
- Purchase sports attire for our students.
- Provide a shade sail.
- Purchase an upmarket gazebo for use at sports and inter-schools events.

Last year they funded 6 new Apple laptops, a digital camera and a movie camera.

Equity and Accessibility: By maintaining our School in its current form we can continue to provide the high standard of schooling that is ensuring our learners are achieving above the National Standards and have equity with urban schools and their significant access to resources. In addition, the current situation provides the greatest location accessibility to education for our learners, most of them have to travel considerable distances.

Incorrect Information:

We are also extremely concerned that some the data used to formulate this proposal was incorrect. Whilst some of the mis-information has since been corrected, the \$97,000 estimated to repair our library (a Versatile Garage) for weather tightness, which is four years old, is totally incorrect. We utterly refute the veracity of this. This estimation was done as a desktop exercise somewhere in the Ministry of Education and needs to be rectified. Furthermore we have just received (30th November and December 3rd) information requested

under the Official Information Act in the first week of Term 4. Considerably longer than the 20 days working days allowed.

In Summary: What we offer as an individual Board of Trustees that cannot and will not be replicated through closure and consolidation as currently proposed is:

 Preserving the current high standard of education and achievement of our learners in a sustainable way which is our primary goal. The Board draws the Minister's attention to the 2012 ERO report confirming our achievements.

WE STRONGLY URGE THE MINISTER TO DECIDE IN FAVOUR OF DUVAUCHELLE SCHOOL CONTINUING AS A STAND-ALONE SCHOOL.

Executive Summary

The Ministry of Education proposal

That Duvauchelle School be closed and the site retained as a 'hub' of Akaroa Area School (as would Okains Bay School) to provide better coverage and access to education services for learners. (See MoE 'Rationale for change' 12/10/12).

Purpose of the consultation exercise

The Board of Trustees needed to make reasonable efforts to consult with the parents and families of students enrolled full time at the school and to also consult with the school catchment community that may be affected or interested in the outcomes of the Ministry of Education proposal to merge Duvauchelle School with Akaroa School.

Background factors to the consultation approach

The catchment community for the Duvauchelle School is rural, significantly spread out with sometimes challenging road and weather issues and at the time of the consultation, under pressure with lambing, other farming activity and meeting seasonal tourism business demands. Consequently the Board of Trustees chose to confine consultation to two face-to-face meetings with parents and caregivers (Appendix one) and the local community (Appendix 2) plus support internet feedback to the facilitator and school.

The school opted not to formally consult the learners seeing that responsibility lay with the adults to consider the merits and problems with the proposed merger and to limit the expected distress that students would experience from being left with uncertainty.

Inter-relationships between the school and its surrounding community are seen to be so strong, with so much inter-dependence, that consultation questions aimed to recognise this link.

Consultation was managed by an independent facilitator funded by the Ministry of Education. Results of the consultation are summarised in the table pages 4 - 7.

Consultation purpose

The facilitator and Board of Trustees understand that this consultation exercise is a 'big picture' view of the proposal and detailed responses and solutions are not required at this stage. The understanding is that the Minister will give the school a further opportunity to provide more details should the request to continue as an independent site not be accepted by the Minister.

The intention of having an independent facilitator was to ensure that the Board was supported and that individuals in the school community had the opportunity to provide whatever feedback they desired to give.

Consultation feedback results

Common key themes emerging from both parent and community feedback are abbreviated as:

- Both the parents and community members meetings gave unequivocal feedback that they saw no advantage in any change that reduced or removed school governance or management on the site.
- Pride in the school's academic achievements.
- Confidence in the community's continuing ability to support the school financially, psychologically.
- Expected future role increases helped drive their stance that the school had a self sustaining future.
- There is support within the school community to continue working in the Banks Peninsula cluster system and an openness to exploring how this collaborative cluster approach might be further developed to increase the sustainable use of resources.

Facilitator's summary

Notable in this consultation exercise has been the consistency of feedback from both the most adamant supporters for continuing the operation of the school as it is now to the quiet, moderately voiced meeting participants who also wished the school not to merge with Akaroa. In order to provide unpressured, confidentiality of feedback ,the facilitator made it possible for people to send feedback privately via email and to hand in questionnaires unsighted by other meeting participants.

Separate to the consultation steps was an informal meeting between Duvauchelle Board of Trustees Chair and Akaroa Board of Trustees Chair. I understand Akaroa Area School Board of Trustees are not supportive of the proposed merger and they do support continuation of Duvauchelle School remaining with its own governance and management arrangement.

PARENTS AND CAREGIVERS CONSULTATION FEEDBACK ON 2/11/2012 REGARDING MoE PROPOSED CHANGES TO THE SCHOOL

Attending:

19 parents and caregivers, 1 apology meaning all but two school families were

represented.

The following represents a full account of written feedback.

Do you prefer the school changes to become part of a 'cluster' and 'provision for education' under Akaroa School as proposed by the MoE? If so, why?

No - because:

- 1. We are already part of a cluster (BP learning cluster).
- 2. We prefer the provision of education as it stands (including maintaining our Board of Trustees.
- 3. School is currently achieving 10% above national standards.
- 4. Nothing to be gained by Akaroa governing the school.
- 5. No guarantee that the school will remain open as a provision for education.
- 6. We don't believe Akaroa School is capable of managing a cluster as they have not been able to manage two separate sites in the past. This has been shown with the amalgamation of their junior and senior schools.
- 7. Akaroa might not be passionate about this school and may not prioritise our needs.
- 8. We see advantages to becoming a cluster with regards to communication rather than governance. We do not see the value of one Board of Trustees.
- 9. We value our teachers. They have proven themselves and our children are achieving under their tutelage. Are their positions guaranteed if our school merges?
- 10. What guarantees for our school's future? Will there still be on eon this site in 5 years time for example?
- 11. Why would we change something that is already working well? Community involvement, education, staff, fund raising, parental support, children achieving top 10% in NZ. Safe environment.
- 12. No, there is no financial or practical sense for Akaroa School to keep the Duvauchelle site operational. Closure of the site would be inevitable.
- 13. The school would be run by a Board of Trustees that probably do not have any direct involvement with the Duvauchelle community.
- 14. No Why change something that is working well, working stronger with stronger, increasing roles?
- 15. No because we have no clear understanding how this provision for education will run.

- 16. We believe the best leaning environment for all our children is the way it is delivered now. Any changes will result in compromised education.
- 17. If site sharing is part of a future delivery of education this must surely compromise time is classroom and learning activities.
- 18. Our school is financially sound, has no remaining earthquake damage, we have excellent relationships between parents and staff, we already operate in the Banks Peninsula Cluster Group and we have a projected roll increase for 2013.
- 19. No.
- 20. (Submitted after the meeting) I believe it should stay as it is. Our own site with our own amazing teachers/staff & B.O.T. and supportive families.

Do you prefer the school remains as it is currently, a standalone entity? If so, why? (What do you find innovative and successful about the school?)

- 1. We would prefer the school to remain as it is currently for the following reasons:
 - excellent management and governance
 - parents are passionate about Duvauchelle School having its own identity because our children are achieving in the top 10% in New Zealand.
 - parents fundraise between \$12,000.00 \$15,0000.00 annually. This shows parents commitment which contributes to the overall success of the school
 - The Children are mixing in their development age-range. 5 year olds are not mixing with 18 year olds in the playground
 - positive attitudes towards learning
 - nurturing learning environment.
- 2. Absolutely!
- 3. A small size school benefits the pupils giving more one to one time with the teachers. (Teacher pupil ratio).
- 4. Pastoral care the principal is familiar with all the pupils well and their needs and is on site.
- Because the school is being run by an Exceptionally good principal who uses Innovative educational tools and is well backed up by a Board of Trustees and strong parent support.
- 6. We prefer having the principal on site as this role is crucial. As a Board we appoint the Primary Education Provider in the principal.
- 7. B of T elected to fundraise (with strong support from the community) to fund a half teacher to enable them to give the best education to our children.
 Because of this the pupils study numeracy with literacy in two classrooms each morning separated into juniors and seniors.
- 8. My children came from a school in Christchurch. They had issues from bullies at the school and suffered from earthquakes, damage, (panic attacks etc).Duvauchelle embraced my children like a family. This helped them to gain back their social confidence, also taught them to believe in themselves again and trust in their school mates.
 - These important values would not have been regained in a larger school system
 - We call Duvauchelle school staff our second family to my children. They feel safe with staff that not only provide excellent education but go up and above what they need to support earthquake damage children and help them heal.
 - social healing

- confidence
- believing in themselves.
- 9. My child was behind and slipping through the cracks. So I left the city to attend a smaller school to see if we could get things under control. She has been making so much progress so I would prefer to remain as it is.
- 10. The different dynamics of the way this school is currently run provide a rich, collective education where children interact and are educated alongside a varied age group which has helped my child immensely with social interaction skills.
- 11. The way this school teaches I believe is innovative. They encourage every child to play a part and encourage them to participate to try their best. In a bigger class room not every child may have the chance to participate.
- 12. To stay as it is.
- 13. Children are taught numeracy and literacy to their ability rather than age which is possible in a smaller school with "mixed" year groups e.g. y0-y2 etc. Allowing kids to be extended and offering opportunities not always able in bigger schools or classrooms.
- 14. (Submitted after the meeting) Upon reading through the Rationale for change document provided by the Ministry I was concerned to see that no-where in the document it actually stated or gave any clear or "concrete" reasons as to why and what benefits there might be.

The Ministry representatives on the media, the information on the websites, the information provided to the schools seems to constantly change on its opinions, reasonings, terms. It gives the impression that this is a whole new concept/idea and that it is ill thought out, based on wishful thinking and is being made up as it goes along.

The statistics/figures/information that have been quoted and therefore presumably decisions have been on is <u>incorrect.</u>

The school currently enjoys a fantastic culture, environment and great staff resulting in learning achievements 10% above national averages.

It is very obvious to see the dedication and hands on involvement of the teachers, principal, B.O.T. and parents to the school and its children.

The old addage of don't break what's currently working extremely well comes to mind!!

15. Yes I do! As we have a very unique school here & I believe it wouldn't be the same if merged with Akaroa Area School. We have a choice where to send our kids & mine is Duvauchelle.

What does the school bring to the community?

- 1. Security and unity for the children.
- 2. Employment opportunities for surrounding businesses, school staff and contractors.
- Use of school facilities for community purposes (school pool, grounds, tennis court and playground).
- 4. Opportunity for interaction and socialisation of school families (who otherwise live in isolated areas).
- 5. The school draws families into the community.
- 6. The opportunity for children at the preschool next door to use the grounds and interact with the school children.
- Travelling distance and time for 'outer bays' families school makes this possible with its location and convenience with the pre-school next door (some with having preschool and school age children).
- 8. Travel times are currently up to approx. 3 hours per day and if we have to travel to Akaroa it would be approx. 4 hours which is unacceptable for a 5 year old etc...
- 9. Security to all children and parents in the area with good educational development. With a adjunct of a preschool next door, it all helps with the social impact.
- 10. Unity by bringing different parts of the community together for the benefit of the community as a whole.
 - without one you don't have the other e.g. At the Duvauchelle Show the school has a burger and sausage sizzle tent which raises money for the school but also provides as additional service for the show whilst they serve alcohol in the evenings. The community comes to buy burgers etc in order to support us.
- 11. Unity
- 12. Focal point
- 13. The only pre-school (in conjunction with) on Banks Peninsula is right next door. There is much cooperation between the pre-school and Duvauchelle School enabling the smooth transition to school for the young children. (e.g. Pre-school comes to pet day, cross-country etc).
- 14. The pre-school is expanding, has an increasing waiting list and role, to cater for more children which will flow on the school. The proximity to the pre-school is another reason parents end their children to the Duvauchelle School.
- 15. As housing becomes more expensive in Akaroa working families are choosing (and being forced) to live further from Akaroa making Duvauchelle a more central location future.
- 16. Small rural schools such as Duvauchelle have strong and passionate parents who care for and feel proud of this school. Children see this pride taken by the parents and are proud of the school themselves. this is all linked to higher education and very well rounded learners.
- 17. This brings to the community a choice of schools.
- 18. (Submitted after the meeting) The school is a central focus/rallying point for the community. A place where everyone comes together, socialises, mixes, mingles and networks at events such as the school sports days, interschool competitions, fund raisers and working b's.
- 19. It helps to retain young people and families in the area.
- 20. (submitted after the meeting) The school is the heart & soul of this amazing community. It has a sense of belonging here & the whole community is behind it, without it Duvauchelle would be empty.

What potential risks exist for the community if the school were to change from its current mode of operation?

- 1. Cannot predict the future but Canterbury is in a growth phase. Who has predicted the potential growth of this area? This school could cater for that growth?
- 2. Potentially could lose its identity with the hub of the school.
- 3. Would parents still have the choice about which school they send their child/ren?
- 4. Will children have to transport to Akaroa to do IT, swimming or library and potentially how many times per week? Children would be losing valuable learning time.
- 5. Junior school would end being thrown in with senior children.
- 6. Loss of representation on Board.
- 7. Projected roles for 5 to 10 years
- 8. Our primary concern is that as a satellite school how does this improve the education provision for our children?
- 9. Pre-school to expand to take in more children, the majority of which will flow on through.
- 10. How does she see the provision for education improving because of the merger?
- 11. Is she aware of the distances at times that children are travelling.
- 12. Social aspect to the rural community will be lost.
- 13. Total school closure becoming inevitable.
- 14. If school closure happens travel becomes an issue from outer bays. (for some families 55 minutes to Duvauchelle would become 1 hour 20 min. At present 45 minutes + 10 minutes to Akaroa or by bus to Akaroa + 30 minutes. For junior children in means another 1 hour of travel.
- 15. Loss of choice of schooling.
- 16. 4 example: 1 child now has to travel 45 min. by car from one of the bays that would now become 1 hour. If they chose the bus that 5 year old will have to leave now at 7 am to catch the bus by 8 am and not be home by 5 pm.

These times will again increase with weather conditions (ice, snow) that the peninsula hills are susceptible to. Summit Road being 500 m above sea level.

- 17. The community will lose the current format of education which is working exceptionally well in its current form
- 18. Parents with children at the pre-school next door will have a higher level of difficulty with travel at an alternative school site for their school age children.
- 19. I believe that social networks with children's development will be lost (applying to those who can't move away) as more and more family leave the community to be closer to the only available school.
- 20. With the loss of the school, the community would change from a family orientated area to a holiday home area.
- 21. Loss of choice for families choosing where their child would be educated.
- 22. Young children having to socialise with older high school children without segregated "play" areas and young kids being bullied or being exposed to teenage socialising e.g. bad language/adult themes.
- 23. (submitted after the meeting) The loss of:
 - The school currently enjoys a fantastic culture, environment and great staff resulting in learning achievements 10% above national averages.
 - It is very obvious to see the dedication and hands on involvement of the teachers, principal, B.O.T. and parents to the school and its children.
 - The old addage of don't break what's currently working extremely well comes to mind!!

- 24. That this proposal is implemented regardless of the wants of a "small" community by a Ministry's determination to save face. The result of an ill thought, poorly planned and resourced model being forced onto the area could create a real mess that impacts on the children and their learning, teachers morale and the feeling of the community.
- 25. The new governing school will be overwhelmed, ill equipped to handle such a transition of this new model especially without clear direction, resourcing and guidance from the ministry.
- 26. Disenfranchised parents and families resulting in falling roll and ultimate closure of the school site forever.
- 27. (submitted after the meeting) For a start we would send our kids to town. Our children would have further to travel each and every day. I believe their education level of teaching would be ruined, & our leaders of tomorrow would be leavers of today. As I am certainly am upset by this proposed possible merger/closure

What potential risks exist for the community if the school were to change from its current mode of operation?

- 1. Loss of the real 'rural identity"
- 2. The school loosing the support structure it has around it at the moment, Secretary and staff support.
- 3. Risk of families moving out of the area we may be only 10 min from Akaroa but its two valleys away # the closer of preschool.
- 4. The loss of great education as our teachers will lose their jobs.
- 5. Loss of income for other community businesses e.g. gas station and cafe.
- 6. Loss of community focus cohesion lost.
- 7. Strength in the school diminished
 - either because the school is actually closed
 - or the energy is spread around too thinly, not focused where the community is domiciled.
- 8. Inter school competition? What will happen with sports days etc -who do the children compete against?
- 9. Complete school closure will equal community loss.
- 10. Loss of community of interest.
- 11. Lack of control
- 12. Poor Board representation
- 13. Inevitable closure.
- 14. Higher costs and loss of identity.
- 15. Eventual closure of school.
- 16. No evidence that changes will be successful.
- 17. Real danger of assts being closed because of lack of finance for repairs, (such as swimming pool).



Duvauchelle School has been part of the **Enviroschools Programme** since November 2009 achieving a bronze award in 2011. This award acknowledges their commitment to creating a more sustainable school community.

The school brings the Duvauchelle community together through participating in sustainable action that benefits the wider school community.

Students have conducted three waste audits as part of the Enviroschools 'Measuring Change' challenge. Each year there has been an improvement as a result of learning and action taken by the students.

Duvauchelle School is always willing to give students the opportunity to learn more about the unique environment in which they live. They have participated in Enviroschools workshops learning alongside other Enviroschool students, teachers and parents. This year they participated in a biodiversity workshop at Hinewai Reserve and last year explored the rocky shore of Duvauchelle beach.

To Whom it May Concern,

I would like you to reconsider the proposal to close Duvauchelle School. At the time of the Earthquakes our school became a haven for other families more seriously affected by the quakes. The school roll doubled and the appreciation from those families was immense. Our school was a catalyst of support during these tough times.

Duvauchelle School has a healthy and growing roll which is a reflection of the fantastic learning environment the current staff have created.

Banks Peninsula's geographical differences should be the most justifiable factor for reconsidering closure. There are a number of isolated families enrolled at Duvauchelle School. For example I rely on a bus for getting my child to school. It takes me 15mins to get to the bus pickup point. If my daughter was to go to Akaroa for schooling she would be travelling for 2 hours every day just getting to and from school. Manageable maybe when they are a little older but still a huge chunk out of every day. In my area of Chorlton, Menzies Bay and Little Akaloa are 4 more families with children yet to start school. Duvauchelle will be their closest option but if it were to close, these families may be forced to consider home schooling because the alternative for a 5, 6, or 7 year olds could be considered adverse.

Some rural schools <u>need</u> to exist because of the isolation of it's catchment area. Duvauchelle is one of these Schools. I invite any one of you to my home for a coffee so you can fully understand our barriers to participation – not just schooling. This argument is not just about community, it is also about common sense. One formula does not apply to all.

To whom it may concern

I am 28 years old and Duvauchelle School was my first, and best, school. I was a pupil there as a new entrant aged 5 through until the end of Standard 4 as it was then, aged almost 11. The feeling of community and family at that school was unlike anything 1 have heard from the primary school experiences of other people my age. We were encouraged to live life and be excited about learning new things, we had opportunities that any child would be lucky to have. When I look back on my time there I recall times of such growth and discovery in a safe and supportive environment. A lot of the kids that attend Duvauchelle are from surrounding bays or farm homes and benefit hugely from the social support of the school being a manageable size and something that a young child can become used to and be comfortable in, unlike the daunting and even frightening experience of being a 5 year old from a quiet country home suddenly in a large school of so many children of all ages. It may, on paper, appear that Akaroa and Duvauchelle are much of a muchness and that surely there wouldn't be much difference to kids to go to school over there. To a young child, to whom the world can seem very large, the potential trauma of going to a different town to a big school with so many kids who are completely unknown and louder and older can be something that negatively impacts for life. Surely we want our future children to be nurtured and allowed room to grow and develop their strengths and become confident, enthusiastic Kiwis with a passion for life and the initiative to move things forward in their education and beyond that, their work. We do not want them to become stifled or shy, to not have the opportunity to become comfortable letting their voice be heard amongst the others, to become lost or struggle because they're too unsure to ask questions. To a little kid from Barrys Bay or Duvanchelle, or French Farm, being dumped among the Akaroa kids could be so detrimental. I know it would have been for me. I hope that if I have the opportunity to move back to Banks Peninsula, that I would have the option to send my children to Duvauchelle School. I know that would be the best start for them. If this awesome school closes, it will be truly terrible and such a sad loss to the local community and the wider region. Please don't let that happen.

I was one of the founding members of Duvauchelle School Board of Trustees and was its chair for three years. During that time (early1991) like many other small schools in New Zealand, the school faced the threat of closure under Education Minister Lockwood Smith and Finance Minister Ruth Richardson. Ironic that the school was in Ruth's Selwyn electorate because it was believed that the proposed closures were based on financial imperatives rather than educational ones.

We managed to successfully overcome the threat based in no small part on our case that the school provided a better education to its pupils than the neighbouring Akaroa Primary School, the school that Duvauchelle pupils would be expected to attend following closure of their school. Outcomes for Duvauchelle pupils then were demonstrably superior to those for pupils from Akaroa.

21 years later nothing has changed. We are informed by today's parents that educational outcomes for Duvauchelle pupils are still superior to those of Akaroa pupils. On 14th September you made the statement on your Facebook page that the central concern in your present school closure strategy is "how do we ensure the best possible education provision for all learners?"

Can you therefore explain how moving the pupils from a successful school to one whose quality of education parents have less faith in, will result in an improvement in education provision for all those learners? Will they perhaps be taking their teachers and the rest of their school budget with them?
