

Catch.com.au Circulon Cookware Pack Giveaway - Terms and Conditions

1. Definitions

For this Promotion, the following terms have the following meanings:

AEDT/ AEST	AEDT means Australian Eastern Daylight Time. AEST means Australian Eastern Standard Time.
Immediate Family	Any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin

2. Eligibility

Australian residents aged 18 years or over are eligible to enter this Promotion. Persons under the age of 18 may enter only with the consent of their parent or legal guardian. If such consent is not given, the entry will be deemed invalid and any prize forfeit for a redraw.

By entering this Promotion, the entrant accepts these terms and conditions. A person may only enter this Promotion once and must enter this Promotion during the Promotion Period.
