The Council has considered the public interest in relation to whether to make this order. The prevailing public interest in these circumstances is the delivery by the State Government, in partnership with the Council, of a major public works project. The release of this information at this stage may compromise the delivery of a proposed significant roadwork project, which is intended to benefit the Gawler Community and the public in general. The Council considers that, on balance, disclosure would be contrary to the public interest at this time.

2. Accordingly, on this basis, the principle that meetings of the Council should be conducted in a place open to the public has been outweighed by the need to keep the information or matter confidential.

- Notes the Gawler East Link Road Update Report, the presentation by DPTI staff at the Special Council meeting on 28 November and the various correspondence and recent media commentary related to the project and thanks all contributors for assisting with resolution of outstanding issues.
- 2. Notes the estimates of cost escalation and the difficulty of funding the Council preferred Eckerman alignment given current funding restraints, and the potential for delay.
- 3. Notes the DPTI senior executive staff advice about the changed role that DPTI is considering, particularly related to land acquisition, and that the State \$55M project funding may be at risk.
- 4. Notes that the DPTI alignment will diminish the benefit of a future extension of the Gawler East Link Road to Tiver Road, through reduced future volumes of traffic which will use this route against the Potts Road and Main North Road option.
- 5. Notes that the physical components of both the Eckerman and DPTI alignments have significant issues to resolve including the design and cost of lights at Potts Road/Main North Road, the design and cost of an access lane and noise protection on Potts Road, the South Para bridge, the design and cost of crossing the creek/s between South Para River and Gawler One Tree Hill Road and south of Gawler One Tree Hill Road, the standard of road construction and the extent of works to be deferred as part of "value engineering".
- 6. Notes issues with alignment, cost and funding of GELR through Springwood land and issues with State Government additional funding of works within Springwood land potentially reducing funding available for the remainder of the project.
- 7. Notes Council considers that the Project Deed would need to be rewritten if Council adopts the DPTI alignment and that issues including related to Potts Road, deferred works, trunk services, Council ownership of assets and separate rates would need to be clarified.

- 4. In consideration of the current Gawler East Link Road project cost estimates, and further cost risks, acknowledges that this road cannot be delivered by the State Government within the \$55M budget allocated on the Eckerman Avenue alignment.
- 5. Kept confidential
- 6. Notes that DPTI will not tender the further design and construction of the road until such time as the land acquisition process is sufficiently advanced that confidence of obtaining the alignment corridor is achieved.
- 7. Has noted the DPTI senior executive staff advice that the \$55M project budget funding may be at risk after the State Election if its design and construction is not tendered and awarded prior to this time.

- 8. Acknowledges the DPTI alignment will still require a value engineered Gawler East Link Road to be delivered within the \$55M budget, with Potts Road Service Road and Deferred Infrastructure to be further considered (not quaranteed) in the context of further refinement of the design and costs for this project.
- 9. Advise DPTI that notwithstanding its existing project budget considerations, in accepting the DPTI alignment with a value engineered roadway, this significantly diminishes the feasibility of a future Tiver Road extension which was a key fundamental outcome for the Council in negotiations on the Gawler East Link Road with the State Government.
- 10. Notify the State Government that it accepts the Gawler East Link Road being constructed on the DPTI alignment on the basis that all trunk services are considered as part of its construction to ensure the road becomes an enabler of development in the Gawler East residential development zones.
- 11. Advise the State Government that Council will accept the Gawler East Link Road alignment being the DPTI alignment, requests all legal deeds associated with the delivery of the road be updated to reflect this and authorises the Chief Executive Officer and Mayor to sign and seal all documents required to effect this change.
- 12. Notes the State Government will utilise their powers under the Highways Act to acquire the necessary land required on the DPTI alignment without requiring the Council's involvement directly in this process.
- 13. Notes all other fundamental principles underpinning the Council's original decisions for the Gawler East Link Road deeds would remain in place, namely;
  - The Council accept ownership of the road and bridge crossing over a. the South Para River
  - The State Government will be reimbursed \$8.2M over time by the b. Council using funds collected from land developers at the time land division occurs in the Gawler East Development Zones.
  - The Council commit \$2.4M upfront to the Gawler East Link Road C. project as its contribution to the upgrade of Potts Road. Noting this contribution is reimbursed to the Council by way of the relevant separate rate as land development occurs.
  - d. That the Gawler East Link Road extend through Springwood to the location of the future Village Centre as part of the project's delivery within the \$55M budget. It is noted that the extra cost of this road through Springwood (currently estimated at \$1.9M by DPTI) should not be funded from the State Government's \$55M project budget.
- 14. Requests DPTI communicate this decision to the directly impacted property owners and the broader community in consultation with Council.
- 15. Informs the State Government's Department of Planning Transport & Infrastructure of its decision.
- 16. Work with DPTI to implement a Community Information Strategy that will seek to immediately inform key stakeholders and the broader community of this decision.
