4. **POOL INTERIOR**

- (a) First grade 1-2mm polished pebble, for maximum strength and safety non slip surface.
- (b) **Colour** Choose from our range, off white through to gold, brown and black, or a combination of these colours to create a unique pool water appearance to suit your individual needs.

5. **WATER DEPTH**

Customised to suit your needs: 1.1 - 1.8m

6. **EQUIPMENT**

- (a) Filtration: Astral FG 604 Sand filter (glass filtrate), designed to provide maximum purification of water.
- (b) **Pump:** Astral CTX 280 Pump, long lasting, quiet, turnover total pool capacity approximately every 3 hours.
- (c) **Sanitation:** Astral V25 Salt Chlorinator, giving you the most up to date technology in water quality. This system has a self-cleaning cell, 2-week battery back up, super chlorination feature in a very well-presented sealed unit.
- (d) **Time Clock: The Astral E25 Salt Chlorinator** is a fully programmable automatic time clock system to regulate the operating hours to suit varying seasonal needs.
- (e) **Lights:** 2 **x Flush niche LED Pool** lights fitted with transformer and installation.

7. STEPS AND BENCHES

(a) Entry: As per plan.



8. **PLUMBING**

- (a) All plumbing to and from filtration equipment will be in 40 and 50mm pipe. This reduces restrictions to water flow and therefore improves water hydraulics immensely.
- (b) Pool will be fitted with 3 returns.
- (c) 1 x Skimmer box with large opening and oversized leaf basket for efficient debris control.
- (d) Main drain set into the lowest point of the pool floor; main drain incorporates a pressure release valve to ensure your pool has complete stability.
- (e) Water overflow connected to filter backwash facility for rapid mechanically driven water level reduction to prevent overflowing of your pool during heavy rain. Plumbing to the sewer or storm water is not included in the price.

A DOCUMENTATION

- a. Master Builder Swimming Pool Contracts are approved by the Queensland Building Services Authority, which lists the pool specifications, items of equipment, construction time, warranties and standard construction terms and conditions in triplicate.
- b. Equipment carries the Manufacturer's Warranties with our personal backing.
- c. All construction is based on Engineers Certification.
- d. On completion an Engineer's certificate will be issued.
- e. All decision notices are based on Australian Building Codes Certification.
- f. Standard council applications included.



B INSURANCES, LICENCES AND AFFILIATIONS

All compulsory Government insurance which cover all public liability (BSA), workers compensation, site insurance and product liability are in place.

C AFTER SALES SERVICE

You will be given full on site, pool operation instructions during the handover of your pool, with ongoing maintenance advice if required.

At the time of handover, you will receive cleaning equipment which includes vacuum head, hose, telescopic handle, brush and leaf scoop. A test kit will also be provided.

All chemicals to start up the pool are included in this price.

D MISCELLANEOUS

- (a) **Temporary fencing:** Aquatech Pools supply temporary pool fencing for the duration of the construction period, 8 weeks.
- (b) **Resuscitation chart:** A resuscitation chart will be provided if Aquatech Pools are to supply permanent pool fencing.

E BOUNDARY FENCING

(a) **Boundary fences:** Quite often unforeseen rectification work will need to be done to make safe your boundary fences. Climbing aids such as garden structures, BBQ's, trees and sheds are some of many that can affect your pools certification and therefore final completion. Please familiarize yourself with the abovementioned and enquire about the current fencing standards available from your sales consultant or supervisor.
