2. Hazards identification

Statement of hazardous/dangerous nature: Not classified as hazardous according to the criteria of NOHSC nor classified as dangerous goods according to the ADG Code.

Risk phrases: NIL

Safety phrases: Use as directed.

3. Composition/information on ingredients

Ingredients, determined not to be hazardous according to NOHSC criteria, and not dangerous according to the ADG Code, make up the product concentration to 100%.

4. First-aid measures

Eye contact: Check for contacts and remove, rinse with plenty of running water. Get medical attention if symptoms occur.

Skin contact: In case of irritation, immediately flush skin with plenty of water and stop use. Wash clothing before reuse. Get medical attention if irritation continues.

Inhalation: Should not occur if directions for use are followed. Remove to fresh air. Obtain medical attention if symptoms occur.

Ingestion: Do not induce vomiting. Rinse mouth; then drink one or two large glasses of water. Contact a doctor or a Poisons Information Centre (Phone: 13 11 26).

Notes to physician: No specific treatment. Treat symptomatically.

5. Fire-fighting measures

Extinguishing media: Use an extinguishing agent suitable for the surrounding fire.

Fire/explosion hazards: No specific hazard.

Special protective equipment for fire-fighters: Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode.

Hazardous decomposition products: This mixture is not combustible under normal conditions. However, it will break down under fire conditions and the hydrocarbon component will burn. In a large fire, heating may produce toxic fumes. Wear self contained breathing apparatus and complete protective personal equipment. Decomposition products may include the following materials:

6. Accidental release measures

Personal precautions: Immediately contact emergency personnel. Keep unnecessary personnel away. Use suitable protective equipment. Slippery when spilt. Avoid accidents, clean up immediately. Personnel should wear appropriate protective clothing during clean up.

Environmental precautions: Avoid dispersal of spilled material and runoff and contact with soil and waterways. Inform the relevant authorities if the product has caused environmental pollution (waterways or soil).

Methods for cleaning up: Stop leak if without risk. Move containers from spill area. Prevent entry into water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in a container for disposal according to local regulations (see section 13). Dispose of via a licensed waste disposal contractor. Note: see section 1 for emergency contact information and section 13 for waste disposal.

7. Handling and storage

Handling: Put on appropriate personal protective equipment (see section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking.

Storage: Keep container tightly closed. Keep container in a cool, well-ventilated area.

8. Exposure controls/personal protection

Occupational exposure limits: No exposure standard allocated.

Engineering measures No special ventilation requirements. Good general ventilation should be sufficient to control worker exposure to airborne contaminants. If this product contains ingredients with exposure limits, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure below any recommended or statutory limits.

Hygiene measures: Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period.

Appropriate techniques should be used to remove potentially contaminated clothing. Wash contaminated clothing before reusing. Ensure that eyewash stations and safety showers are close to the workstation location.
