



## WISEMAN COURSE FEE INFORMATION 2014

<b>1. Approximate Course Fees - Skills for all Funded:</b>	<b>For Students who do not hold a health care card and meet the Skills for All eligibility criteria</b>
Course Fees: \$500 - \$1000 per person	Please note you must provide evidence of any achievements declared as well as residency and photo identification will be required  Fees are payable in instalments of 30% at commencement, 30% after 6 months and 40% at completion
<b>2. Approximate Course Fees - Full Fees (Skills for All Non-Funded)</b>	<b>For Students who do not hold a health care card and do not meet the Skills for All eligibility criteria</b>
Course fees: \$1,200- \$3,000 per person + \$50  Calculation is based off the value of funding received through Skills for All + \$50.00 Enrolment Fee.  Example of Calculation: Total Nominal Hours of the course x Skills for all Subsidy Rate = Tuition Fee + \$50.00	Funding is not available to students who do not meet the eligibility criteria; this can be confirmed through the following link <a href="http://www.skills.sa.gov.au/training-learning/check-your-eligibility">http://www.skills.sa.gov.au/training-learning/check-your-eligibility</a> .  Course fees are payable in instalments of 30% at commencement, 30% after 6 months and 40% at completion
<b>3. Approximate Fees - Health Care Card Holder</b>	<b>For Students who hold a valid health care card and do not have same level or higher qualifications</b>
Course Fees: \$50- \$2,700 per person  Example of Calculation: Course Fees / nominal hours = \$hourly rate - 0.50 cents = Concession Student Course Fee Per Hour  Concession Student Course fee per hour x Nominal Hours = Course Fees	Please note that you must provide evidence of your Health Care Card and it <b>must be valid on the day of enrolment and for every unit of competency completed</b> .  Fees are payable in instalments of 30% at commencement, 30% after 6 months and 40% at completion
<b>INFORMATION ON WITHDRAWING FROM YOUR COURSE</b>	
Depending on when students withdraw from the course, certain fees will may or may not apply based off our payment method of 30% at commencement, 30% after 6 months and 40% at successful completions. For example if a learner withdraws before commencement they will not be required to pay a fee. If the learner has commenced and withdraws before the 6 months into delivery of training they will not be required to pay additional fees above the 30% paid at commencement.
