Interest of 2.5% will be charged per month (or part therein) on all overdue accounts. Other payment options are outlined on our tax invoices, credit card payments will attract a surcharge. Please quote invoice number as reference number on all payments & fax or email remittance advice to ensure all payments are promptly reconciled.

FREIGHT

All goods sent nationally attract a separate freight & handling + GST charge which is determined on destination & volume, unless other arrangements are agreed on by Buyer & Bird Healthcare. Should termination of order occur after shipment, Buyer will be billed for transportation both ways and be subject to a 20% restocking plus refurbishment, if required. Prior to shipment, with Bird Healthcare Pty Ltd consent, Buyer agrees to a 10% cancellation fee. Bird Healthcare will not accept returned stock that has been sold for longer than 3 months. A Goods Return Authorisation Number **MUST** be obtained by the customer prior to any return of stock, if goods are returned without this consent, a credit will not be issued.
