Facebook page @ililoveit and 'Like' the page.</i> • <i>Download the ili! mobile app to their Smartphone and log in to the ili! mobile app using a valid Facebook account. The ili! mobile app is available from the Google Play and Apple App Stores.</i> • <i>During the competition period, visit one or more of the physical Declic stores (store locations at www.declic.com.au)</i> • <i>While at the physical store, the consumer must curate one or more items to their ili! curation journey by launching the ili! App and using the scanning option within ili! to scan Declic barcodes to curate the product to the consumer's ili! curation journey. This process may require the entrant to also take a photo of the product if the product is not yet registered in the ili! system (barphoto curation). A completed 'barphoto curation' will count as a valid entry.</i> • <i>Only curations that are saved to a consumer's ili! Curation Journey will be eligible as entries to the competition. Conditions of Entry

3. The Competition will be run during the Competition Period.
4. The Competition is being run by CollectMe Holdings Pty Ltd (ACN 165 774 970) (CollectMe) in conjunction with Arbes-DuPuy & Associates (ACN 006 642 413) trading as Declic, jointly referred to as The Promoter.
