As the Chief Investigator of the 2016 Australian Government report *How Regional Universities Drive Regional Innovation*, Professor Graham Wise has put his research into practice, drafting the Amazon Regional University IKIAM's \$200m technical campus masterplan in partnership with the Fraunhofer Institute and founding a university in nestled among 93,000Ha of cloudforest reserve in the Amazon.

In this Keynote, Professor Wise provides evidence from both sides of the Pacific about how to achieve a clear line of sight from developing a distinctive organizational mission to building campuses that reflect that distinctiveness, and how these factors work hand-in-hand when pursuing industry engagement and international prominence in higher education.

### 11.45 **Covering shortfalls for frozen CSPs: the pre-requisites for successful philanthropy engagement**

After the recent Government freeze on Commonwealth Supported Places (CSPs), some universities have been driven to lean on other in-house financial strategies, among which is the increasing prominence of philanthropy departments.

Daniel McDiarmid led the first Australian University campaign to raise more than \$100 million. In 2004, Daniel established a fundraising practice advising universities internationally and was an early adviser to the University of Auckland campaign which raised \$203 million, and advised the National University of Singapore on the scaling-up of its fundraising and alumni programs.

Peri-capital city universities – institutions under two hours from capital cities – have distinct economic characteristics that distinguishes them quite markedly from universities that are more geographically isolated from major capital cities. They benefit from lower business costs to attract innovation and entrepreneurial partnerships and favorable lifestyle factors while still servicing large metropolitan markets.
